**1227.11 TERMINATION OF URBAN RENEWAL AGENCY OF JACKSON COUNTY.**

- (a) The Urban Renewal Agency of Jackson County is terminated.
- (b) All facilities, files and personnel of the Urban Renewal Agency of Jackson County are transferred to Jackson County, Oregon.
- (c) The termination of the Urban Renewal Agency of Jackson County shall not affect any outstanding legal actions, contracts or obligations of the Urban Renewal Agency of Jackson County. Jackson County shall be substituted for the Urban Renewal Agency of Jackson County on any outstanding legal actions, contracts or obligations of the Urban Renewal Agency of Jackson County, and, for the purpose of those legal actions, contracts or obligations, Jackson County shall be considered a continuation of the Urban Renewal Agency of Jackson County and no a new entity.
