Fee is per sticker/per vehicle. Permit holders are required to show proof of residency with either a current utility bill or valid driver's license. Stickers are valid until April 30, 2027.

Please refrain from blowing grass clippings onto public sidewalks and into the streets. Not only can grass clippings present a hazard for pedestrians and bicycles, but grass clippings get washed down into storm drains and clog the pipes and catch basins, which leads to street flooding. One option is to blow the grass back onto the mowed lawn. Another option is to sweep and collect the yard waste, which can be taken to the City refuse site for those with dump permits.
