MEETING OF THE JUNEAU COUNTY BOARD OF SUPERVISORS April 19, 2011

Chairman Peterson called the meeting to order at 9:30 a.m.

Roll Call: 21 present- Arnold, Brounacker, Brown, Carlson, Feldman, Granger, Hamm, Kelley, Kolba, Koscal, Larson, Marchetti, Niles, Pagel, Peterson, Robinson, Seamans, Tadda, Wafle, Wenum, Willard.

Carlson led the opening prayer followed by the Pledge of Allegiance.

Motion Pagel, second Brown to approve the minutes of the last Juneau County Board of Supervisors meeting. Motion carried.

Reappoint Janice Cleven to the Regional Board of the Aging & Disability Resource Center of Southwest WI-North. Motion Marchetti, second Tadda to approve. Motion carried.

B. Loyd, Lands, Forestry and Parks Administrator; discussion on public lands versus County Forest Land and Community Forest Land. Land, Forestry, Parks Committee is discussing what to do with the land. There are 480 acres in Town of Armenia, and other Townships that could go into County Forest.

The benefits of the program are that the DNR and Forest Ranger will be able to contribute about 600 hours of labor.

Land to be entered into County Forest is Town of Finley, Armenia, Cutler, Necedah, Orange, Clearfield, Germantown, Lisbon, Marion, Lemonweir, Kildare, Seven Mile Creek, and Lyndon.

Loyd would like the County Board to review and ask questions and let him know how they feel about the project.

Discussion Wafle, Brounacker, and Larson.

JCAIRS-Herb Dannenberg wanted to update the County Board on the fair grounds property. Dannenberg informed the Board the Gasser & Co. would be building a new road into the property at no cost to the County. There will be a walking path from the Hospital to the Park.

The tearing down of the roof of the grandstand is part of the updating of the project. J. Hamm is in charge of getting donations. Enlarging arena for new events and safety in front of the grandstand.

ORDINANCE #11 - 01

DATE: April 19, 2011

INTRODUCED BY: Public Peace and Good Order Committee

SYNOPSIS: Amending Subsections 11.04(3) and 11.04(9) of the Juneau County Code of Ordinances (the Smoking Prohibition Ordinance)

WHEREAS, on October 19, 2010, the Juneau County Board of Supervisors passed Ordinance No. 10-03, creating Section 11.04 of the Juneau County Code of Ordinances, the so-called "Smoking Prohibition Ordinance," implementing Wis. Stats. § 101.123, which became effective on July 5, 2010, and prohibits smoking in indoor locations and public places, and the Board amended said ordinance to correct typographical errors by adoption of Ordinance No. 10-04 on November 9, 2010; and

WHEREAS, the aforesaid Ordinance No. 10-03 contained a provision in § 11.04(3) of the newly created ordinance, regarding the definition of the term "enclosed place," which is different than the definition of said term in Wis. Stats. § 101.123(1)(ak), and the Public Peace and Good Order Committee is of the opinion that the definition in the County's ordinance should be the same as that found in the state statute; and

WHEREAS, the aforesaid Ordinance No. 10-03, as amended by Ordinance No. 10-04, contained a provisions in § 11.04(9) regarding penalties to be imposed under the Smoking Prohibition Ordinance which were different from the comparable penalty provisions in Wis. Stats. § 101.123(8), and the Public Peace and Good Order Committee is of the opinion that the penalties imposed in the County's ordinance should be the same as those found in the state statute; and

WHEREAS, the following proposed amendments would conform the definition of "enclosed place" and the penalties imposed in the ordinance to those in the statute and are in the best interests of the citizens of Juneau County;

NOW, THEREFORE BE IT ORDAINED that the Juneau County Board of Supervisors shall and hereby does amend § 11.04(3) of the Juneau County Code of Ordinances, to read as follows:

"(3) DEFINITIONS. The definitions set forth in Wis. Stats. § 101.123(1) are hereby adopted and incorporated by reference as if fully set forth herein, provided that "enclosed place," defined in § 101.123(1)(ak), shall be deemed to include any "enclosed indoor area" defined as "all space between a floor and ceiling that is bounded by walls, doors, or windows, whether open or closed, covering more than 50 percent of the combined surface area of the vertical planes constituting the perimeter of the area. A wall includes any retractable divider, garage door, or other physical barrier, whether temporary or permanent. A 0.011 gauge screen with an 18 by 16 mesh count is not a wall."

AND BE IT FURTHER ORDAINED that the Juneau County Board of Supervisors shall and hereby does repeal and recreate § 11.04(9) of the Juneau County Code of Ordinances, to read as follows:

"(9) PENALTIES.

————"(a) Forfeiture. Any person, agent, firm or corporation violating §11.04(4) shall, upon conviction thereof, forfeit as follows:

	Forfeiture	Deposit
 First offense	\$100-250	\$100
 Second offense	\$100 350	\$100
 Third offense	\$100.450	\$100

"(b) Forfeiture. Any person, agent, firm or corporation violating §11.04(6) shall, upon conviction thereof, forfeit as follows:

	Forfeiture	Deposit
First offense	Warning	\$0
Second offense	\$100 250	\$100
Third offense	\$100-350	\$100

"(c) Maximum Forfeiture. For violations of §11.04(6), no person in charge may be required to forfeit more than \$250 in total for all violations occurring on a single day."

"(9) PENALTIES. (a) Any person who violates sub. (4) shall be subject to a forfeiture of not less than \$100 nor more than \$250 for each violation.

"(b) Except as provided in paragraphs (c) or (d) below, any person in charge who violates subsection (6) (b) to (d) shall be subject to a forfeiture of \$100 for each violation.

"(c) For violations subject to the forfeiture under par. (d), if the person in charge has not previously received a warning notice for a violation of sub. (6) (b) to (d), the law enforcement officer shall issue the person in charge a warning notice and may not issue a citation.

"(d) No person in charge may be required under par. (d) to forfeit more than \$100 in total forall violations of sub. (6) (b) to (d) occurring on a single day."

INTRODUCED BY: Union Negotiating Committee

SYNOPSIS: Approval of the 2011 – 2013 union contract between Juneau County and the Juneau County Deputy Sheriff's Association of the Wisconsin Professional Police Association, and Authorization for the County Board Chairperson and County Clerk to Sign the Agreements as the Official Act of Juneau County

WHEREAS, the Juneau County Union Negotiating Committee has agreed to a new tentative collective bargaining agreement between Juneau County and the Juneau County Deputy Sheriff's Association of the Wisconsin Professional Police Association, said agreement has been duly ratified by official vote of the membership of the union, and the Committee recommends that said agreement now be ratified by the Juneau County Board of Supervisors; and

WHEREAS, Wis. Stats. §§ 103.51 and 133.09 authorize collective bargaining and employment contracts between the County and its workforce; and

WHEREAS, the new proposed contract is more favorable to Juneau County than the tentative agreement originally agreed to by the Committee and proposed to the Board yet continues to be in the best interests of the County's employees under all the circumstances as well; and

WHEREAS, the proposed collective bargaining agreement is fair and reasonable and in the best interests of the people of Juneau County;

NOW, THEREFORE, BE IT RESOLVED, that the Juneau County Board of Supervisors shall and hereby does approve the proposed collective bargaining agreement between Juneau County and the Juneau County Deputy Sheriff's Association of the Wisconsin Professional Police Association (a true copy of which has been provided to each member of the Board and shall accompany this resolution as filed with the county clerk) and hereby authorizes Juneau County Board Chairperson Alan K. Peterson and Juneau County Clerk Kathleen C. Kobylski to duly execute duplicate originals of the Agreement forthwith, as the official act of Juneau County.

This memo is for the purpose of advising you of the changes in the tentative agreement with the union representing the sheriff's deputies (WPPA), which was reached between the union and the Negotiating Committee subsequent to the last County Board meeting in March. At that meeting, the Board ratified a proposed agreement consistent with the three contracts reached with the AFSCME employees. That agreement was rejected by the WPPA, bringing about a negotiation session with a mediator from the Wisconsin Employment Relations Commission on March 31, 2011, in which the current tentative agreement was reached. The current tentative agreement has already been ratified by the members of the union. It is recommended unanimously by the Negotiating Committee for ratification by the Board at its next meeting on April 19, 2011.

The contract you will be voting on is similar to the original tentative agreement, except that it is more favorable to the County than the previous one (although less favorable than the AFSCME contacts, because the WPPA is not affected by the governor's budget bill as the AFSCME unions are). The significant changes from the previous WPPA tentative agreement are as follows:

- 1. It is a three year contract, rather than two.
- The parties agreed to look into and consider a possible future agreement providing for 12-hour days, rather than the current 8-hour days. (That possibility would likely save

the County a lot of money in overtime pay, and it may be preferable from the point of view of the employees too.)

- 3. The 12 furlough days per employee that have been agreed to previously may be implemented during 2011, 2012, or 2013, provided that an employee shall not take more than 6 in any given year.
- 4. Commencing July 1, 2011, employees shall pay two per cent (2%) of the employees' contribution to the Wisconsin Retirement System, and commencing July 1, 2012 and thereafter employees shall pay four per cent (4%) of the WRS contribution. (Currently, employees pay none of the 5.8% employee contribution, all of which has been paid by the County.)
- 5. In addition to the pay raises of three per cent (3%) agreed to previously for 2011 and 2012 (one per cent (1%) on July 1, 2011, one percent (1%) on January 1, 2012, and one per cent (1%) July 1, 2012), the new three-year agreement also provides for a pay raise of three percent (3%) in 2013, implemented by a 2% raise on January 1, 2013 and a 1% raise on July 1, 2013. (The County's three-year contracts ending December 31, 2010 provided for pay raises of 4% annually.)

The financial benefits to the County from furlough days and the new employee contributions to the WRS substantially exceed the cost of the pay raises that have been agreed to.
