Discussion:

Wenum –with the motion on the table, we are waiting for events over which we have no control to occur probably in the near future and in the process we also assure that if the legislation currently pending is passed in any form between now and then everything we have done in terms of collective bargaining, everything we have done in terms of trying to deal in good faith with our employees goes down the drain. That would be the impact of passage of this motion, and I pray we do not.

Arnold: Having set on the negotiation committee for some time and having had a chance to keep good notes in the process, and having picked up the documents presented today, there are too many inconsistencies in the documents presented. We are not in a position to sign these documents today until the inconsistencies are corrected. In fairness to the County and to the Union people, these documents are going to be very important to us and I think they have to be correct before we actually agree to them. It is unfortunate that this has happened, but I think that making the corrections giving the supervisors sufficient time to review them and then voting on them is more appropriate.



**INTRODUCED BY: Union Negotiating Committee**

**SYNOPSIS: Approval of the three 2011 – 2013 union contracts between Juneau County and Locals 569, 1312, and 1312-A of AFSCME Council 40 of the AFL-CIO, and Authorization for the County Board Chairperson and County Clerk to Sign the Agreements as the Official Act of Juneau County**

**WHEREAS**, the Juneau County Union Negotiating Committee has successfully negotiated new proposed collective bargaining agreements between Juneau County and Locals 569, 1312, and 1312-A of AFSCME Council 40 of the AFL-CIO, representing the County's public works employees, courthouse employees, and professional employees, respectively, and said agreements have been duly ratified by official votes of the membership of all three union; and

**WHEREAS**, Wis. Stats. §§ 103.51 and 133.09 authorize collective bargaining and employment contracts between the County and its workforce; and

**WHEREAS**, the parties have negotiated contracts which are in the mutual best interests of both the County and its employees, and the three contracts are recommended to the County Board for ratification by the Union Negotiating Committee; and

**WHEREAS**, each of the three proposed collective bargaining agreements is fair and reasonable and in the best interests of the people of Juneau County;

**NOW, THEREFORE, BE IT RESOLVED**, that the Juneau County Board of Supervisors shall and hereby does approve all three proposed collective bargaining agreements between Juneau County and Locals 569, 1312, and 1312-A of AFSCME Council 40 of the AFL-CIO and hereby authorizes Juneau County Board Chairperson Alan K. Peterson and Juneau County Clerk Kathleen C. Kobylski to duly execute duplicate originals of the Agreements forthwith, as the official act of Juneau County; and

**BE IT FURTHER RESOLVED**, that the Juneau County Board of Supervisors shall and hereby does act in keeping with its past practice and de facto policy to declare and affirm that the terms and conditions of said collective bargaining agreements on issues of employee compensation and benefits shall apply with equal force to all nonunion employees and elected officials of Juneau County.

**SYNOPSIS: Approval of the 2011 – 2012 union contract between Juneau County and the Juneau County Deputy Sheriff's Association of the Wisconsin Professional Police Association, and Authorization for the County Board Chairperson and County Clerk to Sign the Agreements as the Official Act of Juneau County**

**WHEREAS**, the Juneau County Union Negotiating Committee has successfully negotiated a new proposed collective bargaining agreement between Juneau County and the Juneau County Deputy Sheriff's Association of the Wisconsin Professional Police Association, and said agreement has been duly ratified by official vote of the membership of the union; and

**WHEREAS**, Wis. Stats. §§ 103.51 and 133.09 authorize collective bargaining and employment contracts between the County and its workforce; and

**WHEREAS**, the parties have negotiated a contract which is in the mutual best interests of both the County and its employees, and the contract is recommended to the County Board for ratification by the Union Negotiating Committee; and

**WHEREAS**, the proposed collective bargaining agreement is fair and reasonable and in the best interests of the people of Juneau County;

**NOW, THEREFORE, BE IT RESOLVED**, that the Juneau County Board of Supervisors shall and hereby does approve the proposed collective bargaining agreement between Juneau County and the Juneau County Deputy Sheriff's Association of the Wisconsin Professional Police Association and hereby authorizes Juneau County Board Chairperson Alan K. Peterson and Juneau County Clerk Kathleen C. Kobylski to duly execute duplicate originals of the Agreement forthwith, as the official act of Juneau County; and

**BE IT FURTHER RESOLVED**, that the Juneau County Board of Supervisors shall and hereby does act in keeping with its past practice and de facto policy to declare and affirm that the terms and conditions of its collective bargaining agreements on issues of employee compensation and benefits shall apply with equal force to all nonunion employees and elected officials of Juneau County.
