SYNOPSIS: Authorization of the Juneau County Sheriff to Sign an Amended Agreement with the Juneau County Dive Team, Inc., as the Official Act of Juneau County

WHEREAS, the Juneau County Sheriff and the Juneau County Sheriff's Department wish to enter into an Amended Agreement that updates the Agreement approved April 21, 2009, by Resolution No. 09-21, for rescue services with the Juneau County Dive Team, Inc., a rescue squad which is a Wisconsin nonprofit corporation; and

WHEREAS, Wis. Stat. § 59.27(11) authorizes and requires the Sheriff to "Conduct operations within the county and, when the board so provides, in waters of which the county has jurisdiction under s. 2.04 for the rescue of human beings and for the recovery of human bodies"; and

WHEREAS, the Juneau County Sheriff's Department and the Juneau County Dive Team, Inc. have negotiated a contract providing services to Juneau County by the Dive Team enabling the Sheriff to better comply with the aforesaid statute; and

WHEREAS, the attached proposed Amended Agreement is fair and reasonable and is in the best interests of the people of Juneau County;

NOW, THEREFORE, BE IT RESOLVED, that the Juneau County Board of Supervisors shall and hereby does grant Juneau County Sheriff Brent H. Oleson authority to duly execute the original of the Amended Agreement copied and attached hereto, as the official act of Juneau County, provided, however, that the Sheriff shall report to the County Board by February 1 of each year regarding Dive Team activity during the previous year, together with notice to the Board of the automatic May 1 renewal clause in the contract.

AMENDED AGREEMENT

THIS AGREEMENT, by and between the Juneau County Sheriff's Department, by Juneau County Sheriff Brent H. Oleson (hereafter "Sheriff"), whose principal office is located at the Juneau County Justice Center, 200 Oak Street, Room 1110, Mauston, Wisconsin 53948, and the Juneau County Dive Team, Inc., a rescue squad which is a Wisconsin nonprofit corporation, by its president, Kathleen A. Kohutko (hereafter "Dive Team"), whose principal office is located at N9397 7th Avenue South, Necedah, Wisconsin 54646, is based upon due, sufficient, and valuable consideration for both parties and contains the following terms and conditions, to-wit:

- The Dive Team shall provide dive or underwater rescue services in and around Juneau County as requested by any authorized agent or employee of the Sheriff.
- 2. The term of this Agreement shall be one year, commencing May 1, 2011 and continuing through April 30, 2012. It shall automatically renew for a period of one year each year thereafter, unless terminated by either party. This Agreement may be terminated by either party (a) upon sixty (60) days advance notice or (b) immediately for good cause shown.
- 3. The Dive Team is comprised of members, who are fully qualified to perform the required services, and who volunteer their time and effort. The services provided by the Dive Team are without charge to the Sheriff or Juneau County.
- 4. The Dive Team is an independent contractor, and neither it nor any of its members shall be deemed to be an employee of the Sheriff or Juneau County. The Dive

Team shall maintain its own insurance coverage, in full force and effect at all times, with respect to any and all liability it may have to third parties or to members, for negligence or otherwise, including workers compensation insurance and any other insurance that may be required by law. The Dive Team shall provide proof or certification of its current liability insurance coverage to the Sheriff, and, in the event the Sheriff deems liability insurance coverage for the Dive Team to be inadequate, that determination shall be just cause for immediate termination of this Agreement

- 5. The Dive Team and its members shall abide by all applicable federal, state, and local laws or ordinances. They shall be fully responsible at law and in equity for their own actions. The Dive Team shall hold the Sheriff and Juneau County harmless from any and all alleged negligence or liability which is the result of its or its own members' actions.
- The Sheriff shall hold the Dive Team and its members harmless from any and all alleged negligence or liability which is the result of action by any agent or employee of the Sheriff.
- 7. The Sheriff in the sole exercise of his discretion may make an annual donation of up to five thousand dollars (\$5,000.00) to the Dive Team for the good of the nonprofit organization that it is, and any such donation shall not be deemed to be compensation for services rendered under this Agreement.
- 9. When providing services under this agreement, the Dive Team shall cooperate fully and comply with the directions and requests of the Sheriff as to what assistance is needed, whether and how to collect evidence, and the like. The Sheriff has

no control over the techniques or maneuvers employed by the Dive Team in performing its services. The Dive Team shall advise the Sheriff, as needed, regarding safety issues, feasibility of actions considered or undertaken, and the like. The parties shall cooperate with each other mutually and to the fullest extent possible at all times.

10. The signatories of both parties are fully authorized to execute this Agreement as the official act of their respective organizations.
