

ORDINANCE NO. 12 - 01

DATE: May 15, 2012

INTRODUCED BY: Sheriff and Jail Committee

SYNOPSIS: Creating Section 2.03(13.1) of the Juneau County Code of Ordinances, Establishing an Ad Hoc Sheriff's Department Grievance Committee

WHEREAS, the County Board has the authority under Wis. Stats. § 59.26(8)(b)1. to establish a grievance committee to hear and decide grievances filed by deputy sheriffs or more senior officers of the sheriff's department and to appoint the members of the committee, whether they may be members of the County Board or other electors of the County, or both; and

WHEREAS, after due consideration the Sheriff and Jail Committee of the Juneau County Board of Supervisors recommends to the full County Board the adoption of the following Ordinance establishing the ad hoc Sheriff's Department Grievance Committee as a separate and distinct committee from the Sheriff and Jail Committee itself; and

WHEREAS, the proposed Ordinance will serve the interests of justice and will best guarantee impartiality and the confidence of the public and the employees of the Department, and, therefore, is in the best interests of Juneau County and its citizens;

NOW, THEREFORE BE IT ORDAINED that the Juneau County Board of Supervisors shall and hereby does approve and adopt the following Ordinance creating Juneau County Code of Ordinances § 2.03(13.1), to read as follows:

(13.1) Sheriff's Department Grievance Committee. Composition and Appointment. This Committee shall consist of two County Board supervisors and three electors, recommended to the County Board by the County Board Chairman for appointment to the Committee. The two County Board supervisor members shall neither be on the Personnel Committee nor on the Sheriff and Jail Committee, nor shall any citizen member be affiliated with any law enforcement agency. Members of the Committee shall be appointed on the basis of recognized and demonstrated interest in civic affairs. County Board supervisor members shall serve during their term of office and citizen members at large shall serve three year staggered terms of office with the first citizen member to serve a three year term; the second citizen member to serve a two year appointment and thereafter his/her successors to serve a three year appointment; and the third citizen member to serve a one year appointment and his/her successors to thereafter serve three year appointment. The purpose and powers of the Committee shall be as set forth in Wis. Stats. § 59.26(8).
