Carlson led the opening prayer followed by the Pledge of Allegiance.

Motion Lally, seconded Larson to approve June 18, 2013 County Board minutes.

Discussion regarding Shadowland-Frac Sand Mining.

Deputy Clerk C. Fischer read a letter from George Alcorn, President and CEO of Shadowland Holdings and Shadowland Operations reaffirming Shadowland's statements that there will be no financial risk and a significant positive impact on the citizens of Juneau County.

A number of individuals from the audience including Diane Dahl, Lyn Emery, Jane Powers spoke against the County Board voting to approve the bond issue and submitted a petition to the Board with 150 signatures against the project.

Further discussion by Geo. Bates, CFO of Shadowland; Granger, Marchetti, Arnold, Robinson and Chairman of the Town of Orange Mike Keichinger and Attorney Ann Murphy of Quarles and Brady.

RESOLUTION No. 13 – 48

DATE: July 16, 2013

INTRODUCED BY: Executive Committee

SYNOPSIS: Approval of a One-Time Lump Sum Payment of \$600.00 Per Person to Juneau County Employees, Except for Limited Term Employees and Those Employees Who Are Members of the Juneau County Deputy Sheriff's Association and Wisconsin Professional Police Association.

FISCAL NOTE: One-time cost of approximately \$120,000.00

WHEREAS, the Juneau County employees who are members of the County's three A.F.S.C.M.E. Unions have not had a pay increase in the year 2013, and the employees who are members of the County's fourth union, the Juneau County Deputy Sheriff's Association and the Wisconsin Professional Police Association, have received a pay raise of 2% on January 1, 2013 and a raise of another 1% on July 1, 2013, under the terms of the current contract between the Union and the County; and

WHEREAS, the current contracts between the County and the A.F.S.C.M.E. Unions provide that the County and the Unions shall negotiate in good faith regarding wages in 2013, and those unions and the Juneau County Union Negotiating Committee have done so and have agreed that in lieu of a pay raise for 2013 there shall be a one-time lump sum payment of \$600.00 (less proper wage withholding on that sum) to each and every employee of the County, except for limited term employees (LTEs) and those employees who are members of the deputies' union, and the A.F.S.C.M.E. Unions and the County will negotiate in good faith before the end of 2013 regarding wages to be paid in 2014; and


WHEREAS, the aforesaid one-time lump sum payment meets with the approval of the Negotiating Committee, the Personnel Committee, and the Finance Committee and is recommended by those committees for adoption by the full County Board at this time;

NOW, THEREFORE, BE IT RESOLVED, that the Juneau County Board of Supervisors shall and hereby does authorize a one-time lump sum payment of \$600.00 (less proper wage withholding on that sum) to each and every employee of the County, except for limited term employees (LTEs) and those employees who are members of the Juneau County Deputy Sheriff's Association and the Wisconsin Professional Police Association, and does direct that said payments shall be made by separate check at the time of the next regular paycheck or as soon thereafter as reasonably possible.



INTRODUCED BY: Personnel Committee

SYNOPSIS: Establishing the Position of Zoning/Sanitation Administrator as the non-union Department Head of the Zoning/Sanitation Department

WHEREAS, the position occupied by long-time Zoning/Sanitation Administrator David M. Donnelly technically has been considered to be a non-managerial union position, while in reality Donnelly has served as the *de facto* manager and head of the Juneau County Zoning/Sanitation Department, and there is a need to formally recognize his status in practical terms consistent with the personnel policies of Juneau County; and


WHEREAS, the Personnel Committee has determined that it is in the best interests of the County and the Zoning/Sanitation Department that the position of Zoning/Sanitation Administrator be designated as a non-union managerial position and that Administrator David M. Donnelly be recognized as the Department Head of the Zoning/Sanitation Department; and


WHEREAS, the A.F.S.C.M.E. union has notified the Personnel Department of its willingness to allow Donnelly to withdraw from the union and to permit the County to formally designate him as the non-union managerial Department Head of his department;

NOW, THEREFORE BE IT RESOLVED that the Juneau County Board of Supervisors shall and hereby does designate the position of Zoning/Sanitation Administrator as a non-union managerial position and does further designate Administrator David M. Donnelly to be the Department Head of the Zoning/Sanitation Department, with a change of his Grade 17, Step 12 status as a wage earner to a Grade 17, Step 12 salaried managerial employee, effective on the day of adoption of this resolution and continuing thereafter.
