Minutes of the Juneau County Board Public Hearing on 2015 Budget November 12, 2014

Chairman Peterson opened meeting.

Roll call: 21 present-Arnold, Brown, Cottingham, Feldman, Frei, Granger, Kelley, Kolba, Lally, Larson, Niles, Peterson, Robinson, Schneider, Seamans, Strouse, Tadda, Wafle, Wenum, Wilhorn, Willard.

Chairman Peterson turned the Public Hearing over to the Finance Committee, Chairman Niles, Brown, and Cottingham.

Niles called upon Lori Chipman, Audit and Accounting Director, to give an overall explanation of the 2015 Budget. Chipman explained that new construction allowed an increase of 1 1/2 %. Debt was restructed. Mill rate is 6.49 for 2015 which is an increase of .11 cents over 2014. The valuation also has increased, which helps.

Wafle asked what the ½ % sales tax brings in and Chipman said around 1.4 million. Feldman also questioned a room tax, which would not be a county tax. Wheel tax also questioned and that would be an addition on your renewal of plates.

Health insurance has an increase of 9% for 2015.

There were no more questions so Niles closed the Public Hearing.

TO THE HONORABLE BOARD OF SUPERVISORS OF JUNEAU COUNTY, WISCONSIN:

WHEREAS Juneau County has federally recognized Indian Trust lands within its boundaries, concerning which this Board may enter into an agreement for County-Tribal Law Enforcement Programs, pursuant to s.59.07(141) of the Wisconsin Statutes and seek funding therefore under s.165.90, Wis. Stats.; and.

WHEREAS to be eligible to receive funding under the latter section, as amended effective on August 3, 1989, this County and the Ho-Chunk Indian Nation must develop and submit to the Wisconsin Department of Justice, for its approval, a joint program plan by December 2nd of the year prior to the year for which funding is sought on a first-come, first-service basis:

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE AFORESAID BOARD MET IN REGULAR SESSION

- 1. That the Sheriff's Committee of this Board, in consultation with the Sheriff, shall develop together with the governing body of the Ho-Chunk Indian Nation, a joint program plan for County-Tribal Law Enforcement in the foregoing amount, and the same shall be submitted for 2015 funding approval; and,
- 2. That prior to submission of such joint program plan to the aforesaid Department for funding approval, the same shall be endorsed on behalf of this Board by its Chairman upon the recommendation of the Sheriff's Committee.

Kenas, Esq. in a newly-created half-time Grade 14, Step 11 position, effective immediately, to compensate her for her full-time performance in the role of assistant district attorney and by providing her to the fullest extent possible the benefits of a regular full-time County employee and (2) direct the Juneau County District Attorney and Juneau County Corporation Counsel to prepare and file with the State the application for position authority referred to immediately above.
