Discussion on ADRC - John Wenum and Heidi Randall

Governor Scott Walker in the State proposed budget addresses privatizing aging and disability resource centers for cost savings. The agency provides medical help, and assisting clients with obtaining disability payments. The agency has served more than 40,000 meals to the elderly and disabled in the four county areas. Wenum feels the proposed privatization is critical to the point of being dangerous.

# OPPOSING THE PROPOSED CHANGES TO AGING AND DISABILITY RESOURCE CENTERS IN THE 2015-2017 GOVERNOR'S PROPOSED BUDGET AND REQUESTING THE WISCONSIN LEGISLATURE TO OPPOSE THOSE CHANGES

WHEREAS, the 2015-2017 proposed governor's budget would give authority to the Department of Health Services (DHS) to eliminate county-run Aging & Disability Resource Centers (ADRCs) by contracting out all of their functions;

WHEREAS, this upheaval was initiated without input from ADRCs, people receiving Long Term Care (LTC) services and/or their families, aging and disability advocates, local officials, the State Long Term Care Advisory Council, or legislators; and,

WHEREAS, with the elimination of ADRC Governing Boards and county-run ADRCs, a small Aging Unit with limited capacity would remain without a service point for persons with disabilities, and

WHEREAS, the ADRCs provide one-stop information, while in the proposed fragmented model, people will get shifted among entities and the most difficult situations will be left to county government without resources, and

WHEREAS, the role of county government includes meeting the needs of its citizens, and the ADRCs have become a nationally recognized model for supporting seniors and persons with disabilities in making informed decisions regarding their money and thereby delaying the need for public support, and

WHEREAS, ADRCs are locally accountable, accessible and utilize local resources that enhance the local economy, and as the central and sole provider, the ADRCs fill gaps in local service delivery for all citizens, and

WHEREAS, the current system of ADRCs and LTC programs have already produced the planned-for reforms, which have created huge savings for taxpayers while maintaining quality. The Medicaid portion of the budget decreased from 53% in 2002 to 43% in 2011 and the nursing home population decreased by 11,000 people thereby reducing nursing home costs, and

WHEREAS, the citizens of Wisconsin's ADRCs are satisfied with the services offered, and that ADRCs are governed locally by the people they serve and the ADRCs attribute much of their success to community partners and local volunteers, and

NOW, THEREFORE, BE IT RESOLVED, by the JuneauCounty Board of Supervisors, who met in regular session, that the State of Wisconsin should retain its existing successful and cost-effective model of ADRCs,

BE IT FURTHER RESOLVED, that a copy of this resolution will be sent to the legislators serving the people of Juneau County, the Wisconsin Counties Association, and the ADRC of Eagle Country and be submitted as testimony to the Joint Committee on Finance, with the request that they assist in this endeavor.

INTRODUCED BY: Juneau County Board of Health

SYNOPSIS: Resolution to Secure State Funding to Support Communicable Disease Control for Population Health

FISCAL NOTE: None.

WHEREAS, Wisconsin has no dedicated, stable federal and state funding sources for communicable disease control and prevention efforts; and

WHEREAS, a strong public health infrastructure is paramount to the health of all citizens; and

WHEREAS, emerging and existing communicable diseases threaten health security, economies, and quality of life for all; and

WHEREAS, communicable diseases such as ebola, H1N1, measles, HIV and AIDS, tuberculosis, influenza, syphilis, gonorrhea, rabies, hepatitis, polio, and pertussis can threaten the lives and well-being of Wisconsin residents; and

WHEREAS, emerging and re-emerging threats such as ebola, H1N1, SARS, and measles threaten personal and community safety and require substantial resources to contain; and

WHEREAS, Wisconsin local health department communicable disease programs protect residents by investigating and controlling communicable diseases, collecting data, educating the community about prevention and the importance of immunizations, and caring for those affected by these diseases; and

WHEREAS, local health departments have been successful in controlling communicable diseases through case reporting and involvement of public health staff in referral of exposed persons for screening and prevention services; and

WHEREAS, evidence in the scientific literature indicates that partner notification services are not adequately assured in the absence of specific public health staff involvement; and

WHEREAS, local health departments and the State of Wisconsin have demonstrated commitment, competence, and success in assuring the confidentiality of persons with reported communicable disease for decades, including cases of AIDS; and

WHEREAS, local health departments have placed a high priority on communicable disease control; and

WHEREAS, communicable disease control is one of the ten essential functions of public health;

NOW, THEREFORE, BE IT RESOLVED, that the Juneau County Board of Supervisors shall and hereby does urge the State Legislature to develop bipartisan support and enact funding for comprehensive, sustainable, effective, and evidence-based communicable disease control and prevention for the public's health; and

BE IT FURTHER RESOLVED, that a copy of this Resolution shall be sent to Representative Ed Brooks, Senator Howard L. Marklein, and Governor Scott Walker.

INTRODUCED BY: Personnel & Insurance Committee

SYNOPSIS: Creating Section 11.7 of the Juneau County Personnel Policy, Regarding Ride-along Policy

WHEREAS, the County is in need of a clear policy regarding persons riding along with other employees in County owned and operated motor vehicles; and

WHEREAS, the language of the following proposed policy statement has been considered, approved and recommended by the Highway & Public Works Committee; and

WHEREAS, the Personnel Committee recommends to the Juneau County Board of Supervisors that it amend the Juneau County Personnel Policy to create Section 11.7 entitled Juneau County Ride-along Policy, to read as follows:

#### "11.7 Juneau County Ride-along Policy

It is the policy of Juneau County that individuals may not and shall not ridealong as passengers in any motor vehicle owned or operated by Juneau County, provided that an individual may do so in any of the following circumstances:

- 1. The individual is a member of a committee of the County Board having authority or responsibility for the county department operating the vehicle, and he or she is riding along for business-related reasons;
- 2. The individual is an employee or trainee in the county department operating the vehicle, and he or she is riding along for business-related reasons; or
- 3. The Highway Commissioner, Sheriff, or other Department Head of the county department operating the vehicle has explicitly authorized the ridealong, and the individual is a passenger for business-related reasons. The individual shall be required to sign a release of liability form approved by Corporation Counsel prior to beginning the ride.

Nothing in this policy shall restrict law enforcement transportation of a detainee, arrestee, or inmate or the taking on of a passenger in any county vehicle in a bona fide emergency situation."

and

WHEREAS, the proposed policy is in the best interests of Juneau County and its employees;

NOW, THEREFORE BE IT RESOLVED that the Juneau County Board of Supervisors shall and hereby does amend the Juneau County Personnel Policy to create Section 11.7 entitled Juneau County Ride-along Policy, to read as set forth above.

INTRODUCED BY: Personnel & Insurance Committee

SYNOPSIS: Amending Section 5.1b of the Juneau County Personnel Policy, regarding Public Works Group Overtime Hours and Breaks

WHEREAS, there is a need to clarify the rules regarding overtime and breaks for workers in the Public Works Group of County employees; and

WHEREAS, the language of the following proposed amended policies has been considered, approved and recommended by the Highway & Public Works Committee; and

WHEREAS, the Personnel Committee recommends to the Juneau County Board of Supervisors that it amend the Juneau County Personnel Policy to effectuate the changes requested by the Highway & Public Works Committee by amending subsections B and H1 of Section 5.1b, entitled Public Works Group Hours of Work and Compensation, to read as set forth in the resolution below; and

WHEREAS, the proposed policies are in the best interests of Juneau County and its employees;

NOW, THEREFORE BE IT RESOLVED that the Juneau County Board of Supervisors shall and hereby does amend subsection B of Section 5.1b of the Juneau County Personnel Policy, to read as follows:

"B. Overtime: Employees shall be compensated at the rate of one and one-half (1 ½) times the normal rate of pay for all hours worked over 8 hours per day and/or over 40 regular hours worked in a week. Sick, vacation, and compensatory time shall not be included in calculating the 40 regular hour work week. The payroll week shall start on Monday morning at 12:01 a.m. and end Sunday evening at midnight."

AND BE IT FURTHER RESOLVED that the Juneau County Board of Supervisors shall and hereby does amend subsection H1 of Section 5.1b of the Juneau County Personnel Policy, to read as follows:

#### "1. WORK AND OVERTIME:

"Breaks: Employees shall be allowed one (1) break of fifteen (15) minutes in the morning from 9:00 a.m. until 9:15 a.m. and one (1) break of twenty (20) minutes for lunch from 12:00 noon to 12:20 p.m.

"Overtime: Employees shall be compensated at the rate of one and one-half (1 ½) times the normal rate of pay for all hours worked over 10 hours per day and/or over 40 regular hours worked in a week. Sick, vacation, and compensatory time shall not be included in calculating the 40 regular hour work week. The payroll week shall start on Monday morning at 12:01 a.m. and end Sunday evening at midnight."

SYNOPSIS: Creating Section 11.9 of the Juneau County Personnel Policy, Regarding Fitness-For-Work Assessments, and Clarifying Section 4.1 of the Policy regarding Regular Part-time Employees

WHEREAS, the County is in need of a clear policy regarding obtaining fitness-forwork assessments of injured or disabled persons in the work place or seeking to return to the work place; and

WHEREAS, there also is a need to clarify the provision regarding regular part-time employees that is set forth in Section 4.1 of the Juneau County Personnel Policy; and

WHEREAS, the Personnel Committee recommends to the Juneau County Board of Supervisors that it amend the Juneau County Personnel Policy to effectuate the changes deemed necessary by the Committee by amending Section 4.1 and Chapter 11 of the Personnel Policy as set forth in the resolution below; and

WHEREAS, the proposed additions and corrections are in the best interests of Juneau County and its employees;

NOW, THEREFORE BE IT RESOLVED that the Juneau County Board of Supervisors shall and hereby does amend the Regular Part-Time provision in Section 4.1 of the Juneau County Personnel Policy, to read as follows:

#### "REGULAR PART-TIME

An employee who fills a part-time position of less than forty (40) hours per week shall be designated as regular part-time and shall be eligible to receive pro-rated County benefits. Prorated benefits shall be based on the average weekly hours worked. Changes in the weekly hours worked shall be approved by the Department Head, and an add/change form shall be completed at the time of the change."

AND BE IT FURTHER RESOLVED that the Juneau County Board of Supervisors shall and hereby does create Section 11.9 of the Juneau County Personnel Policy, to read as follows:

#### "11.9 Fitness-For-Duty Policy

"The Human Resources Director, or a Department Head with the knowledge and approval of the Human Resources Director, may require any employee who is injured or is temporarily disabled to obtain a fitness-for-work assessment from the employee's attending physician. Restricted duty, if any, may only be directed by the employee's attending physician. When necessary, the Human Resources Director may require that the employee undergo an independent medical examination (IME)."

Restoring Funding for County Forest Administration Grant Program

FISCAL NOTE:

WHEREAS, Juneau County has land entered into the Wisconsin County Forest Law (Wis. Stats. §§28.10 & 28.11) and is a member of the Wisconsin County Forests Association (WCFA); and

WHEREAS, if these budget cuts were enacted it will seriously reduce the level of service provided for the public's benefit regarding the Juneau County Forest.




