Comprehensive Community Services and Coordinated Services Team Presentation

Brooke Schluter, CCS/CST Manager, and team present. Comprehensive Community Services (CCS) is a community-based program that provides or arranges for psychosocial rehabilitation services for eligible adult and child consumers. It is designed to assist individuals of all ages who have a psychiatric illness, a serious emotional disorder, or a substance abuse problem and who need ongoing, comprehensive services to help them manage and ultimately recover from that disabling condition. Coordinated Services Team (CST) program is a family-centered, strength-based, wraparound approach to help address the complex needs of children and youth involved in multiple systems of care. CST utilizes 13 core values to develop a plan which builds from the unique and holistic needs of children, youth and their families.

Director report outs (if any)


