The Town of Kennebunkport is pleased to offer the “**Tax Club**”.

The Tax Club is a tax payment plan that taxpayers can utilize to assist in relieving the pressure of dual lump sum payments for Real Estate taxes. It works like a Christmas Club where the taxpayer and Town enter into an agreement that allows one to budget their obligation over an 11-month period. During this agreement period, interest will not accrue as long as the taxpayer is current with their obligation in accordance with the agreement.

Payments will be due on the 15<sup>th</sup> of every month for a total of 11 months, commencing in August 2024 and running thru June 2025.

**Monthly Tax Club Payment Plan Agreement**

**PURPOSE OF PLAN:** The Tax Payment Plan benefits the taxpayer by relieving the pressure of dual lump sum payments and enabling one to budget those obligations out over an 11-month period as well as avoiding interest charges. This in turn benefits the Town by creating a more predictable cash flow.

I, (we), the undersigned, do hereby agree to pay the 2025 tax bill in eleven (11) payments for the months of August 2024 to June 2025, inclusive. **Payments shall be made on the 15<sup>th</sup> of the month.**

**You will receive your official payment book with your calculated monthly payments in August 2024. If there is a delay, your payments will be estimated.**

If your payment is not received by the end of each month, this agreement shall become null and void and interest on the balance will begin to accrue at the normal Town interest rate, beginning from the date of the last payment.

It is **not** the responsibility of the Town to notify a Payment Plan member of delinquent payments.
