Kenton City Council met in their 3rd Regular Session on February 12, 2024, at 7:00 PM, in Council Chambers. Present: President, Joel Althauser, Sue Fox Buroker, David Beazley, Steve Walter, Chad Miller, Pegg Wren, Anda Tudor, Robin Jones, Law Director John Schwemer, Mayor Lynn Webb, Safety Service Director Cindy Murray.

Prayer given by Mr. Althauser:

Pledge of Allegiance recited.

Althauser: Welcome back everyone after one of our three-week breaks. Sue and I were talking the other night that as much as we do like Council every other week it is nice to have that period of time where we only have to, where we get a three-week break. So, anyways let's get right at it. We have a busy agenda tonight.

MINUTES:

Althauser: Are there any additions or corrections to the minutes as they were included in your packets? Those would be the minutes from January 22nd. Hearing no issues, let them stand approved as submitted.

CITIZENS REQUESTING TIME TO SPEAK:

Althauser: Now, we have some individuals that have requested time to speak tonight. It's that time of year, and it is always nice, I appreciate it when folks running for County government do want to talk with City Council. So, in no particular order, we're beginning tonight with Kathy Kelley, and if you'd like to come up to the podium.

Kathy Kelley: Hello everyone. Apologies for running in at the last minute here. My name is Kathy Kelley, I am running as a Republican for Hardin County Commissioner. To tell you a little bit about myself, I grew up in Findlay. I've lived in the county for approximately 21 years. As a business owner, I owned S & K Mini Mart down in Ridgeway, Ohio for ten years, sold my half of the business back, and started another commercial power washing flooring business from the ground up. I currently still have that business. I don't work it much unless it's for a commercial entity. I currently am employed at the Hardin County Veterans Service Office here in Kenton. I, myself, am a four-year navy veteran. I also sit on the HHWP CAC Board, and I represent the low-income families and individuals here in Hardin County. I'm on their Planning and Development Board as well. Just another little tid-bit, I have been through Leadership Institute out of Union County, which I don't really think that matters whether it's Union, Hardin, Hancock, it's about the experience within itself, and the tools that are gained in becoming a better leader that came out of that. The reason I'm on the ballot for County Commissioner is I, as one of the people, am ready for change. I'm ready for some growth, a little bit of open-mindedness, probably a whole lot of open-mindedness, and I believe that a listening ear is very important. People in the county want to be heard. They want to know that their opinions matter, and everybody brings something to the table. I'm a firm believer in that. I also believe that good relationships, strong relationships promote growth and opportunity. If we're not working together; whether it's County and City, whether it's County and Townships, whatever the case may be, we're stronger together, and I think there's a big need for that gap to be filled. Kathy Kelley: My apologies. Althauser: Oh that's okay. Kathy Kelley: Questions?

Althauser: I just wanted to give them the opportunity. Alright, thanks a lot. Next we have

Michael Kasler with us this evening.

Mike Kasler: Thanks Joel. My name is Michael Kasler. I am a candidate for in the Republican Primary for Hardin County Commissioner and I thank you for the time to address you. I really appreciate it. I've been a public servant for almost forty years, I began my career in 1985, when I was hired by the State of Ohio to be a Highway Patrol Trooper. I served as a trooper at the Delaware post. I was promoted to Sergeant. Served at the Lima post, and then I was transferred to the Marion post where I finished my career. I was a twenty-five-year veteran of the Highway Patrol. During that time I represented the State of Ohio. I represented the Governor on many occasions. I did a lot of speaking engagements. I was an instructor at our academy, and I guarded the Governor's residence every Wednesday afternoon for two years. George and Janet Voinovich are very nice people. It was an honor to be a public servant in that capacity. I retired in 2010, and before I retired, I took advantage of a tuition reimbursement program that patrol had, and I went to business school at University of Findlay. I didn't focus on the business aspect. My concentration was public policy, and during that time I studied budgeting, fiscal management, strategic leadership, and all the different things that a public servant is required to have to be an effective leader, and I graduated with my MBA in 2004. I retired in 2010, and after that I continued my education. I went to law school at Ohio Northern University, I got my law degree in 2017. After I retired, I formed an oil and gas title company where I helped people in the Marseilles and Utica formations in Southeast Ohio develop their oil and gas rights. During that time, it taught me a lot about energy, resource management, and it taught me a great deal about not only oil and gas, but also solar and wind energy. I have a lot of experience in solar and wind energy, leasing, and the title issues involved, and just the basic concept, and I put that experience to use everyday because I'm also the zoning officer for Buck, Hale, and Pleasant Townships here in Hardin County. We've had two, I've issued two permits for solar fields just within the past few months. One was in Buck Township, and the other was in Pleasant, just west of town, out by the County Home, and just today I got the application for another one just east of town, about a mile or so. So, solar is a big thing, and it's my expertise in that area, I think, is very beneficial for the county. I've very demanding in the application requirements for the solar people, and I think it's produced, the solar fields that are approved, I think they're going to be good ones, and I think the companies are going to be held accountable. I am also an elected trustee of a state retirement system. There were five retirement systems in Ohio and I'm on the smallest one, which is a Highway Patrolman Retirement System, but I'm responsible for being a trustee and I help manage 1.1 billion dollars in pension and healthcare benefits. I'm the chairman of the healthcare funding committee, and my healthcare fund has one-hundred and ten million dollars in it, and I take great pride in being able to provide good pension and healthcare benefits for my constituents, and I'm on my second term. I was elected. I had two people running against me and I received 76% of the vote which I think is a testament that people, retirees, trust me to get the good pension and healthcare benefits. I am really enjoying this campaign, as I said, I like to be a Hardin County Commissioner because I think I can bring a lot of experience, and a lot of good qualifications to the table, and I love working for people, and I love helping people that are disadvantaged. When I was a trooper I was the guy that wrote the most warning of anybody. That shows I'm not out to harm people, I want to help them. Any questions from anybody?

COMMUNICATIONS:

Althauser: Holli is here tonight, and you also have Holli's report from the HCCBA in your packet. So, yeah they've got it right in front of them, Holli.

Holli Underwood: Alright so, I submitted this earlier this month, but luickily you all missed a week so you've got it in front of you the same night that I came. I focused this report on some of the activities centered around Kenton. You'll see countywide activities on there, but something that we talk about, Lynn and I work closely together on project with Jobs Ohio; and RGP. So RGP is the Toledo based branch of Jobs Ohio that serves Hardin County, and RGP came out last week for a site visit. We visited the Jones Road Site out across from the dog pound, just to make them more aware of that site, and the potential there. Want to come back to that in a minute, the Jones Road Site, but we also visited several other sites in Kenton. Just so when they see those state-wide opportunities, Kenton is on their mind. Working with Regional Planning on potential All-Ohio Future Fund Project and Brownfield Projects in the county. So, the EPA has a lot of Brownfield money available right now, and we're going to try to capitalize on that if we can. Mark Doll does a great job doing those Brownfield projects already, but we're going to collaborate and see if we can't get one of our major industrial sites cleaned up. The All-Ohio Future Fund, if you're not familiar with that I encourage you to look it up, but it's money for infrastructure improvements to make more attractive industrial site available in the state of Ohio. So, off the top of my head, I'm thinking that Jones Road could be improved to make that site more attractive. and if there's significant state dollars available for that we'd like to look into it further. So, that's what the All-Ohio Future Fund and the Brownfield was about. I've gotten a lot of calls lately. It's very busy at my office, people emailing and calling interested in a lot of commercial opportunities, commercial and office space opportunities. So, you can see those are notated on here as well, and I keep these vague, right because of confidentiality reasons but to try to share and give you an idea of some of the activity that's been coming in, there are a few listed in the report. Scheduling BR&E visits. We've got partnerships again with RGP and Jobs Ohio and Ohio Means Jobs to get out to about 17 major employers in the county this year. Keep up with them and find out how their operations are going and how we might be of service to them if they needed to expand, or hire. Workforce Development, this is just continuing the Hardin Career Taskforce work that we're doing to try to continue to develop students working with the schools, and making sure that we're all on the same page with in-demand careers, and what the hiring needs of local employers are. The Hardin County Job Fair is hosted by Ohio Means Jobs, but that is coming up March 5th out at the fairgrounds. Ongoing projects, I mentioned I think the last time I was here we were working on passing the Local Revolving Loan Fund Program. Since that time that program was approved and funded by the Commissioners at an amount of \$500,000.00 and we had out first application. The Commissioners just passed a resolution to approve that application, based on the recommendation of our governing board, and we haven't closed yet on that deal but the resolution was passed by the Commissioners a week ago. So, that Local Revolving Loan Fund is to stimulate the creation of job and capital investment in the county. This project, our first application does happen to be within the city limits. Vibrant Communities, I mentioned that before, we're chugging away on that. I encourage you to visit the Jobs Ohio website. There's a ton of information about that program but it could mean significant grant monies in our downtown. So, focused in the core of the downtown for that one for revitalization of our historic buildings. I've been sitting in on the KOPA meetings and we've got another one coming up in the next couple of weeks. Eclipse planning is going on. We talked about that at our DBA meeting this morning, and I encourage you to visit our website. We've got a banner on our home page that lists the resources that we have available. If you're aware of additional resources, share those with us, as far as places people can go and things that they can do on April 8th, and we're also preparing for the Market on Main season coming up this year and I will be working with the Mayor, and probably Cindy on what that might mean during construction. We have had someone accept our job offer for replacing Morgan Ellis as the Director of Chamber and Tourism February 22nd at ONU. That's all I have. Any questions?

Althauser: And there is an explanation of Ordinance 24-002, and also Emma has a, you'll notice the numbering system, brilliant by the way, I hadn't had a chance to tell you that. So, Resolution start with the number, then the year. Ordinances start with the year, then the number, and the reason why; we kept mixing them up last year a couple of different times because we got on a cycle where, I mean deep into the year, which normally does not happen. So, I don't know who wants to kind of chat through, Cindy?

Murray: It's really going to be all of them, all at once.

Althauser: Okay, that's fine. They're all interrelated.

Murray: All of these deal with the water line that goes from 68 out to the Quarry. So, for those of you who do not know, we had a lot of issues with our well at the Quarry. Two years ago in the middle of the season we did not pass our testing and the EPA got on us, and we had to do some additional inspections last March which cost us \$6,223.00, and at that time the EPA said if you don't pass this well inspection you have two choices; one you either extend your waterline out to the Quarry, or you tote water out for all the campers. So, at that point we applied to the EPA for this extension of this water line, and we were given a grant of \$268,000.00. The total cost for that water line, including, it was \$376,200.00, and that does not include the, so we still had some money to come up with in order to pay for this line, and we struggled, and we struggled, and we struggled, and finally the EPA says, you guys really, really need to do this. So, we put our heads together, we came up with a plan as to, up to this point, all the money for the water line out at the Quarry came out of the Water Enterprise Fund. So, we said what if we created a separate line under the Quarry to where the money that's generated from the quarry actually pays for this water line extension. So, it does not come out of the tax payer's money, either out of the General Fund or out of the Enterprise Fund. So, in order to do that we have to raise our rates out at the Quarry, and if we do that it's like \$250.00 for a seasonal site, we need to raise the rate. That in itself will pay for this water line extension to the quarry, and we will not be using any taxpayer money to do that.

Beazley: So essentially the users are funding the improvement/

Murray: That's correct.

Romanko: That is \$386,200.00 for the construction. We need money for the engineering as well. So yes, we've calculated out at a little over \$250.00 per site for twenty years to pay off the zero percent loan for twenty years for that water line that goes out there.

Murray: We are also looking for additional money. We did find on the ODNR website, the NatureWorks Grant can be up to \$150,000.00. So, we will apply for that, and if we get that, that would pay for this water line extension.

Romanko: Questions?

Beazley: Yes Pam, it says here the EPA is offering the \$108,200.00 at zero percent interest, and you're saying we need a total of \$149,543.00.

Romanko: The \$108.200.00 is for construction and the engineering and OWDA fees were not included in that.

Beazley: So, we are getting additional funds?

Murray: At the zero percent? Beazley: At the zero percent?

Romanko: I know we'll get the OWDA funds. I'm not sure about the engineering.

Beazley: So, the cost of the engineering, the \$35,700.00 may still be on the city to do so? But that's where we are seeking the other sources?

Romanko: It's also included in the \$267.00 amount to pay that per site.

Beazley: Regardless of whether it's zero interest or whether we actually have to spend our own money to do that.

Romanko: Mhm.

Beazley: Okay, thank you.

Althauser: And the money David is talking about, you'll see that, I mean it's actually cited by, Quarry Project Engineering \$35,700.00, that's the dollar amount.

Romanko: On the ordinance we have a line item in the water fund for \$45,000.00 for Clover Lane, that we are not going to be using. So, we were going to take that out of the appropriations, but we also are going to transfer \$41,400.00 from general into the park fund, and then the engineering, the construction, and incidentals. So, the ordinance funds the resolution, in essence.

Beazley: This puts us then, we have had our struggles with being in compliance with EPA on a number of issues, and this one specifically has reared it's ugly head most recently.

Murray: Yes, it took us three times last year at the camp ground opening to get it to pass.

Romanko: And EPA is very strongly suggesting accepting this grant.

Beazley: And we have in the past not done so well at paying attention to them on a timely basis. So, I understand the urgency. What is the timeline on the construction and utilization, should Council proceed with the funding?

Murray: The June 1st is when we have to award the construction loan. So, they are in the process of the design. As soon as we give them the go ahead they will get this design completed.

Beazley: And that will go in the specs and the bid package and that sort of thing? We're hoping to have that turned around by June 1?

Murray: Yes.

Beazley: After we award a contract what is the estimated date of completion, or what are we putting in the specs as our request?

Murray: I'm not sure. I'll have to get back to you on that one.

Beazley: Thank you.

Romanko: Engineer hasn't come up with that yet.

Althauser: And just a little further background, I mean, this isn't just a last year...

Beazley: No, no, no...

Althauser: We've talked about running a water line from 68 for a decade, at least.

Beazley: Should we be able to pass this this evening, will our intent and resolution, as well as funding appease the EPA going forward for the operation of those sites for 2024?

Murray: Yes.

Althauser: Unless the well doesn't pass.

Murray: Right.

Althauser: It'll still have to pass. Beazley: Bite your tongue. Althauser: I know, I'm just being...

Deb Purcell (Campground Manager): We'll still have to use the well this year,

Althauser: Right, if it passes. It's got to pass. That's my point. It's got to pass. But, I mean, Cindy and Pam, Lynn, everybody out there is moving as fast as they can to address that.

Beazley: Understood, and this, I assumed the reason for the immediate need on all of this is the timing that we've received from our good friends at EPA.

Murray: Yes.

Althauser: And just to clarify the related ones would be this one that, obviously Emma just read, and then the third one, and the fourth one.

Beazley: Right.

Buroker: What would be the timeline on that grant you were talking about.

Murray: That one, the application is due June 1st, and I'm not sure when they make their announcement.

Beazley: But EPA has given us some kind of tacit approval idea saying we see this urgent enough to expedite the awarding of this grant.

Murray: Yes.

Althauser: So, what we would be asking Council to do, unless council desire to hear a little more explanation on Resolution 001-24, and Resolution 002-24 first, it's up to you all. They are all interrelated. Well, the Resolutions deal with the engineering, and then applying for the monies that have already been discussed here. So, do we want to do the project and comply with the EPA and if so, we need to approve the Ordinance, and the associated Resolutions to make this whole thing move forward as expeditiously as possible.

Althauser: Yes. So, if there are no questions I'm going to ask if there would be a motion to suspend the three-reading rule.



Enclosed is one set of preliminary legislation for the project referenced above, which is scheduled for construction in the summer of 2026.

This project proposes the following work along SR 67:

 Filling sidewalk gaps and extending the network along Columbus Street from Broadway St. to the Kenton Station Senior Villas.

The city will be responsible for the entire cost of the improvement, including environmental, preliminary engineering, right-of-way and construction costs, less the \$1M of safety funds that are currently allocated toward the project.

The enclosed legislation verifies the City's consent to proceed with the project and commitment to pay for the project costs as noted above. Based on the current estimate, the City's share for the construction phase of the project will be approximately \$425,000. The actual amount the city will be responsible for will be determined by the State's official estimate, which should be calculated in March 2026. At that time, ODOT will ask the City to complete final legislation and return a check for the estimated amount due.

WHEREAS, the City of Kenton is eligible to apply for Transportation Alternatives Program funding for the North Detroit Street (U.S. 68) Improvements;

WHEREAS, if requested funds are granted, the City of Kenton shall be responsible for at least five percent (5%) of the construction costs of TAP funded items, and for 100% of all other costs associated with the architecture/engineering plans, environmental studies and documentation, right-of-way plans, and right-of-way acquisition, if necessary.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Kenton, Ohio:

SECTION I. The Mayor and/or Safety Service Director for the City of Kenton be and herewith are authorized and directed to apply to the Ohio Department of Transportation for Transportation Alternatives Program funds.

SECTION II. Said request shall be for improvements for the North Detroit Street (U.S. 68) Improvements, Phase I, estimated to cost \$4,340,048.02 of which the Local Public Agency (LPA) is applying for \$252,351.11 in TAP funding, if awarded the funds, the LPA commits to pay at least five percent (5%) (hereinafter known as the local portion) of the actual construction cost over and above the maximum amount provided by the State of Ohio, Department of Transportation and for all costs associated with design, environmental and right-of-way activities.

SECTION III. Upon completion of the described Project, and unless otherwise agreed, the LPA shall: (1) provide adequate maintenance for the described Project in accordance with all applicable state and federal laws, including, but not limited to, 23 USC 116; (2) provide ample financial provisions, as necessary, for the maintenance of the described Project; (3) if necessary, maintain the right-of-way, keeping it free of obstruction; and (4) if necessary, hold said right-of-way inviolate for public highway purposes.

SECTION IV. If the application is approved for the funding the Mayor and/or Safety Service Director of said LPA is hereby empowered on behalf of the LPA to enter into a contract with the Director of the Ohio Department of Transportation necessary to complete the above described project.

SECTION V. That this Resolution shall be an emergency measure, the particular emergency being the need to submit the application in a timely manner. Therefore, for the immediate and best protection of the public welfare and convenience, this Resolution shall be in force and effect from and after its passage and approval by the Mayor; otherwise, from and after the earliest period allowed by law.
