The U.S. Amateur Four-Ball is played by teams of two golfers. 128 teams qualify via a nationwide tournament qualification process and then compete in a 36 hole stroke play qualifier that determines the field of 32 teams for match play. Play is conducted using a four-ball format, where the lowest score by either player on each hole is the score for the side. The winning team obtains a ten-year exemption into the tournament but also automatically registers them for the U.S. Amateur Championship, where a victory leads to exemptions for the next years U.S. Open, Open Championship, and The Masters.

An event of this nature focuses on the support and growth of the game of golf.
