Fee Schedule - Public Health Services

Fees for services provided by Knox County Community Health Center are consistent with locally prevailing rates or charges and are designed to cover reasonable costs of operation. Knox County Community Health Center's fee schedule is available upon request.

Sliding Fee Schedule

The Health Commissioner shall establish a sliding fee schedule based on the federally established poverty level and family size and income. The Community Health Center's Service Fees shall be administered in accordance with the approved sliding fee schedule for residents of Knox County, and the service area for the Knox County Community Health Center.

The Health Commissioner has the authority to waive any fee in this schedule when requested.

MULTIPLE WATER SAMPLE COLLECTIONS

When a recreational vehicle park or camp is served by more than one water well, and water samples are collected from more than one well during an inspection, the fee for the water sample from the first well sampled shall be the full fee, the fee for water samples from any additional wells on the property shall be eighty percent (80%) of the full fee.

WAIVER OF ENVIRONMENTAL HEALTH FEES

The Health Commissioner may waive the fee to Knox County Townships and Villages and the City of Mount Vernon for any environmental health program license or permit that does not include a fee collected for the state.

REFUND OF ENVIRONMENTAL HEALTH FEES

No license, permit, or registration fee shall be refunded after a license, permit or registration has been issued. No site evaluation fee shall be refunded after any work has been performed for the site evaluation. All other fees may be refunded if no work has been done or service rendered. All refunds shall be subject to a deduction of \$10.00 to cover administrative costs of the refund.

TRANSFER OF PERMITS, LICENSES, AND REGISTRATIONS PROHIBITED

No license, permit, or registration that has been issued may be transferred to another person or entity.

SECTION 6.0 Effect of Partial Invalidity

Should any provision or part thereof of this fee schedule be found unconstitutional, void or of no effect, the same shall not affect the legality and effect of the other provisions or parts thereof of this fee schedule.

SECTION 7.0 Effective Date

The fees in this schedule shall be effective on the date approved by the Board of Health and shall replace any previous fee schedule establishing fees for services provided by the Knox County General Health District adopted by the Board.

SECTION 8.0 Emergency

This fee schedule is hereby declared to be an emergency measure necessary for the immediate preservation of life, health and safety for the reason that fees need to be established to partially defray the cost of providing vital public health services in the Knox County General Health District; therefore, this fee schedule shall take effect and be in force immediately upon the date of approval by the Board of Health.

All elements of the fee schedule will be reviewed annually.
