2010 ANNUAL REPORT

The mission statement of the Kochville Township Fire Department is to enhance the quality of living in our community by preventing or minimizing injury, and loss of human life or property, resulting from fire or other emergencies, (natural or man-made), that may occur within the jurisdictional boundaries of the township we serve, and other surrounding communities through our mutual aid agreements.

Kochville Township Fire Department proudly protects 3,944 residents, according to the 2009 Saginaw News. Our township consists of 931 households, and 333 businesses, all in 61 miles of county, state, and private roadways.

Our Department of Public Works maintains 484 fire hydrants.

This report will include information on the make up of the fire department, budget, grants, apparatus, incidents, fire prevention, fire training, burn permits, and my final comments.



EMPLOYEES

The Kochville Fire Department of today is known as a “paid on call” fire department. The 2010/11 fiscal year budget authorizes 2 part-time, up to 25 paid on call members, and one administrative assistant within the department.

The part-time positions consist of a salaried Fire Chief and a 20 hour a week fire inspector. Paid on call positions consist of two Assistant Chiefs, two Captains, two Lieutenants, 10 firefighters and t one administrative assistant. One Administrative assistant works an average two hours a week.

Firefighters Jeff Babcock resigned with 5.5 years of service and Chris Pagano resigned with 4 years of service.

Our employees proudly continue to be highly trained and dedicated. As of January 1, 2010, we had 18 employees with total years of experience at 215.16 years. As of December 31st 2010, we currently are at 17 employees and total years of 222.43 years.

Ten firefighters are now eligible to retire, and we have 9 auxiliary personnel.

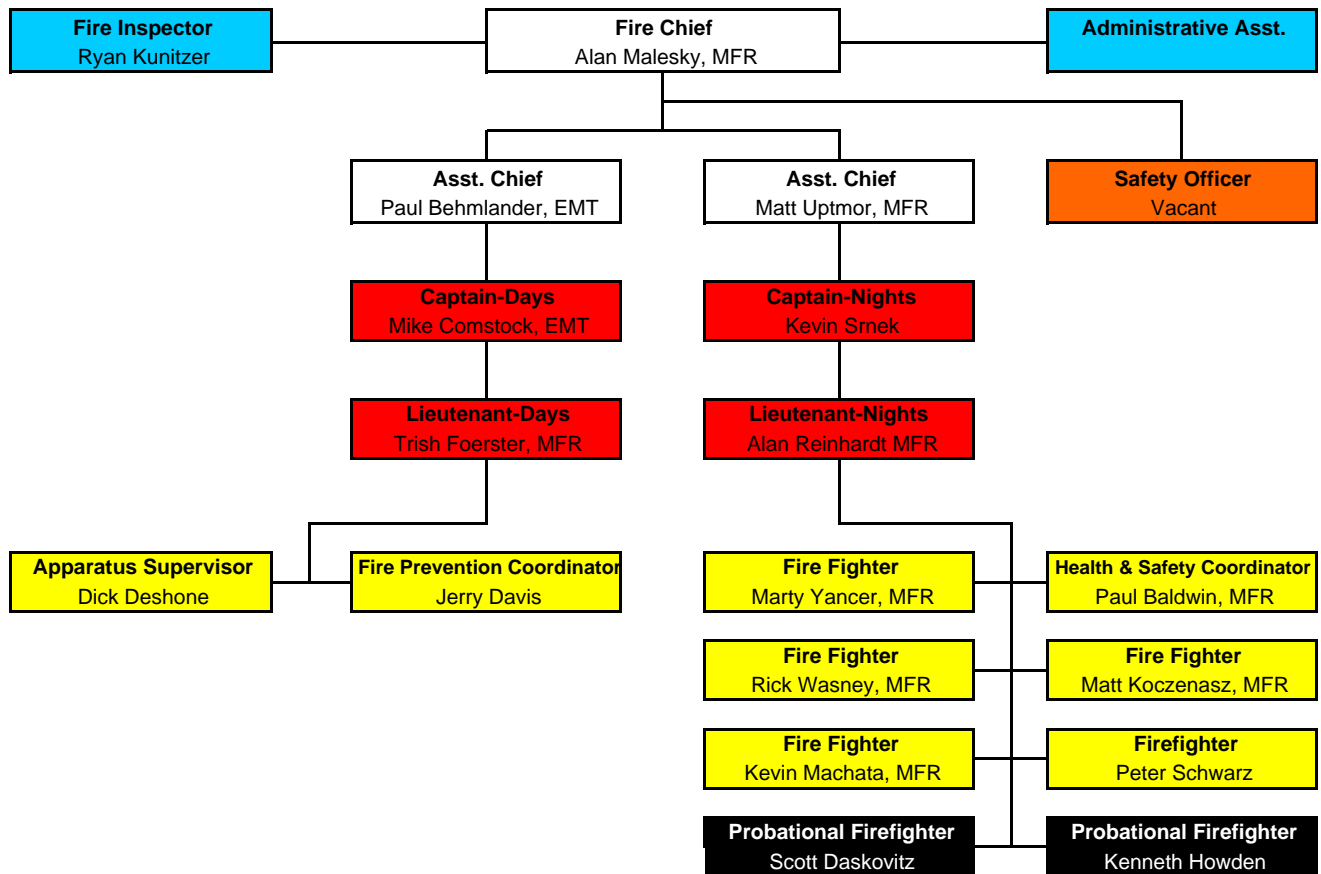

BUDGET

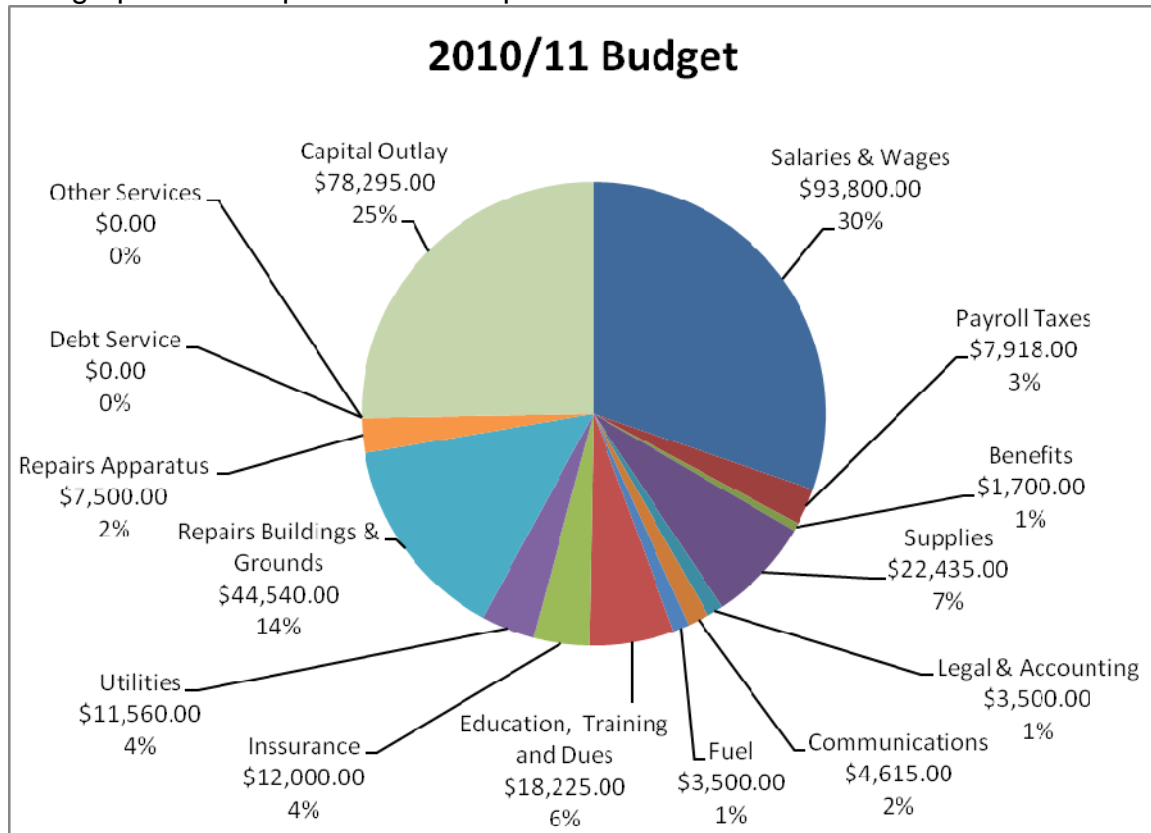
Our budget for the FY 2010/11 was financed by the following: A special assessment, cost recovery, and a fire protection grant for SVSU.

The 2010/11 revenue consisted of the following:

- \$280,000.00 Special Assessment
- \$15,000.00 Fire protection grant for SVSU
- \$15,000.00 Cost Recovery
- \$1246.00 Interest Income

Cost recovery

We billed out a total of \$69,548.54 for cost recovery, which included fire alarms, hazardous material Incidents, medical emergencies, and motor vehicle accidents. A total of 53 billable incidents were mailed out. As of January 30, 2011, we have received a total of \$31,432.71 as a result of our billing. We have received a total of \$22,611.67 in cost recovery for calendar year 2008/09.

Starting in January 2010 Emergency Service Billing Company facilitated our cost recovery for Motor vehicle Accidents

GRANTS

The following is a report and list of all grants that we applied for during the 2010 Fiscal Year. During the 2010 we applied for a total of 5 grants totaling \$ 924,700.00. As of January 11, 2011 we still have not heard the status of any of our grants.

The Grants that we have applied for are through the 2010 Assistance to Firefighters Grant Program (AFG) and are as follows: 5% match is required.

EMW-2010-FO-0621- Grant covers a new cascade system and 2 bottle enclosed fill station, the grant was written for \$40,000.00 and is still outstanding.

EMW-2010-FV-03563- Grant was written for a 75 foot Quint Fire Apparatus in the amount of \$755,000.00. This grant has been denied.

EMW-2010-FF-00099- Grant was written by Chief Al Malesky for Staffing of Firefighters in the amount of \$110,700.00 and is still outstanding.

We applied for a grant from the 2009 Michigan Homeland Security Program, First Responder Sub-Committee, Region-3 for two mobile data computers for two fire apparatus for a total of \$12,0000.00 this grant is pending approval from the State of Michigan and Region-3 authority board.

We applied for a grant from the 2009 Michigan Homeland Security Program, Critical Infrastructure Sub-Committee, Region-3 for a security Camera System for a total of \$7000.00 this grant is pending approval from the State of Michigan and Region-3 authority board.

APPARATUS

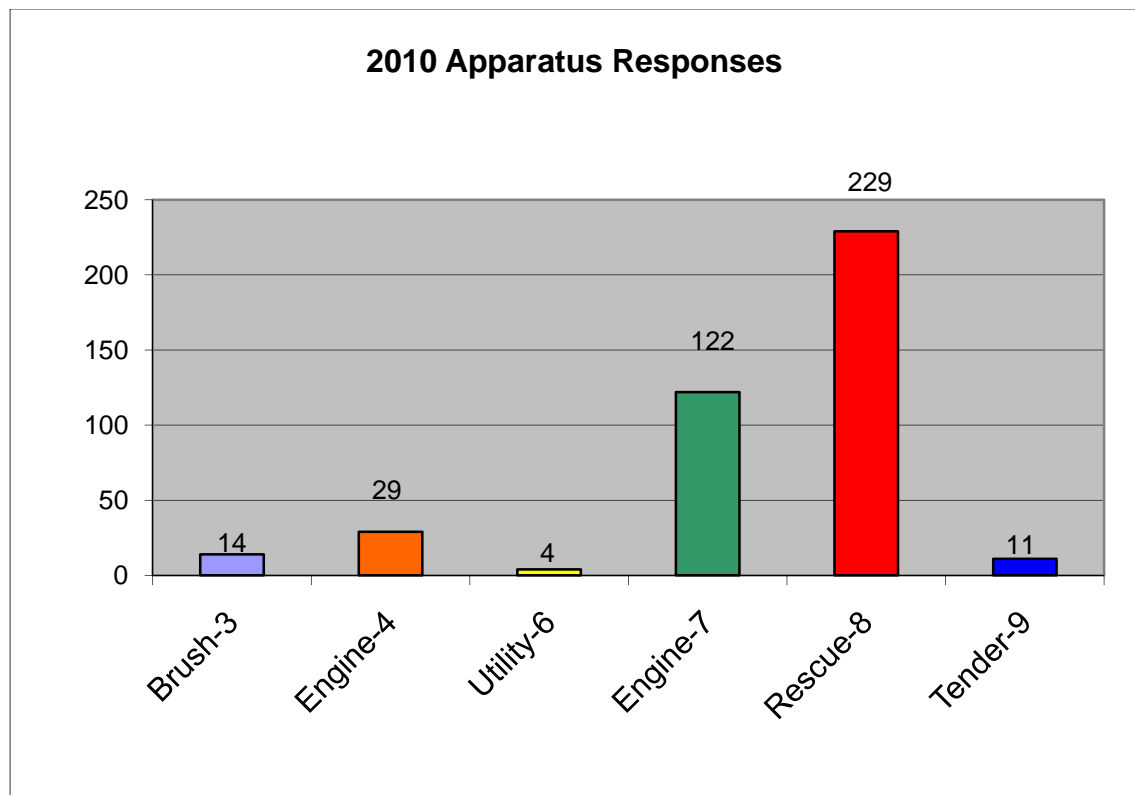


We currently have one fire prevention trailer and six fire/emergency apparatus in our fleet. Five of these are owned by Kochville Township and one is on loan to us from the Michigan Department of Natural Resources (DNR). All apparatus are safety checked monthly following MIOSHA part 74. Our current apparatus are DOT Department of Transportation inspected annually. Our fire pumping apparatus are certified annually by an independent contractor, this is pump maintenance and a test to meet NFPA 1901 requirements.

Utility 6 (DNR) apparatus was taken out of service on November 11th, due to mechanical safety issues. A committee was appointed by Chief Malesky to replace this vehicle.

Our ground ladders and fire hose is also tested annually according to the NFPA 1901 requirements.

Engine-4 (1988) was scheduled to be replaced in 2008 and has been rescheduled until to 2013.

INCIDENTS



INCIDENTS

By Asst. Fire Chief Paul Behmlander



As required by Federal and State law, all reportable incidents for Kochville Fire Dept. are submitted electronically to the DELEG which over sees the State Fire Marshall. Fire Departments in the State of Michigan to report all activity utilizing the National Fire Incident Reporting System (NFIRS) on an annual basis. Kochville Fire Department (KFD) currently utilizes Fire Tools, a State approved software and reports with the State on a monthly basis via electronic communication. Below, is a breakdown of the Kochville Fire Department responses in 2010.

KFD was activated 459 times in 2010 with one exposure report for a total of 460 reportable incidents

KFD experienced just over a 1% increase from the 2009 calendar year, however still 9% less than 2008.

The 460 emergency incidents responded to consisted of:

- 48% of responses were medical assists.
- 22% of responses were alarms, (false alarms, smoke detectors, water flow, etc.)
- 11% of responses were to motor vehicle accidents.
- 4% of the incidents were "fires", (structures, grass, vehicles, etc.).
- 15% were "other" type incidents.

Of 460 incidents, 299 (65%) occurred during the time period of 6:00 a.m. to 5:59 p.m. This corresponds with the daily time period where KFD has its minimum number of available on-call personnel.

Kochville Fire Department personnel logged a total of 1866:40 hours, responding to these 460 incidents.

Geographical responses within Kochville Township:

- 297 (68%) East of Bay Rd.
- 123 (27%) West of Bay Rd.
- 7 Center of Bay Rd.
- 29 Mutual Aid Given
- 1 Tornado Warning Activation
- 2 Wrong Dept. Dispatched

KFD reported zero fire related civilian injuries, one firefighter injury, and two near misses during 2010.

FIRE ALARMS

KFD responded to 99 fire alarms in 2010 compared to 71 fire alarms in 2009, and 89 in 2008.

FIRES

KFD responded to 20 Fires in & outside of township boundaries. This included structure, vehicle, vegetation/outside fires and overheated equipment. Fire losses for Kochville Township in 2010 were estimated at \$7500.00 involving property with an estimated value of \$30,500.

MEDICAL EMERGENCIES

KFD responded to 221 medical emergencies in 2010. Our Medical Coordinator Captain Mike Comstock breaks down these responses in his report.

MOTOR VEHICLE ACCIDENTS (MVA)

KFD responded to a total of 51 MVA incidents in 2010.

43 – with Injuries

2 – Motor Vehicle with Pedestrian

6 – Extrication of Victim(s) from vehicle

1 – Extrication of Victim(s) from machinery

Note: Mutual Aid was given by KFD to neighboring communities on fatal MVA incidents; however no fatal MVA incidents occurred within the township boundaries for the second consecutive year.

MUTUAL AID

Mutual Aid is a vital part of each Fire Department's existence. KFD provided mutual aid 31 times, and received mutual aid 6 times. KFD participates in a countywide mutual aid agreement with all Saginaw County Fire Departments, including a mutual aid agreement with Frankenlust Township in Bay County.

KFD assisted the following communities in 2009:

Carrollton Township, Frankenlust Township, Saginaw Township, and Zilwaukee City.

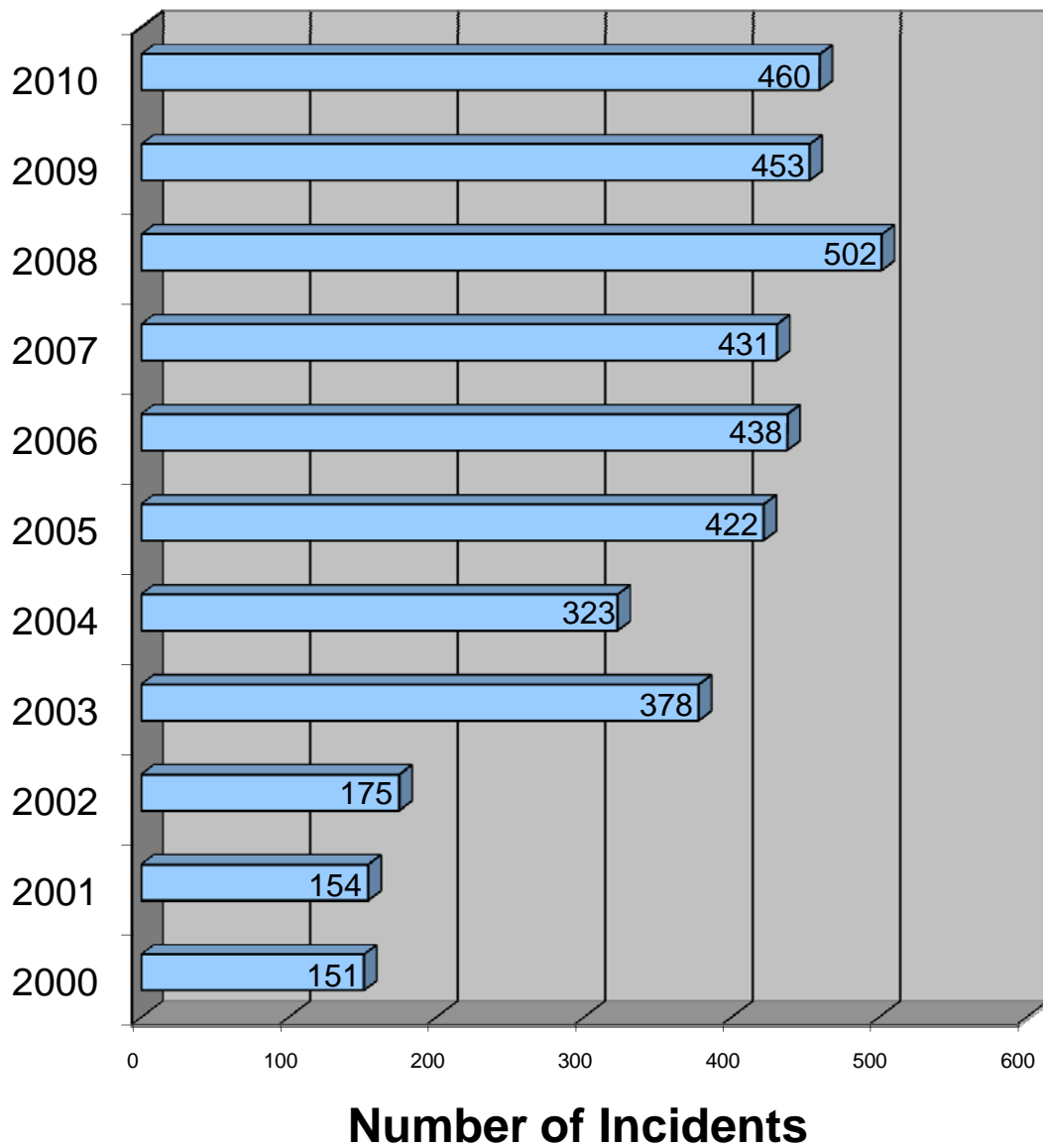

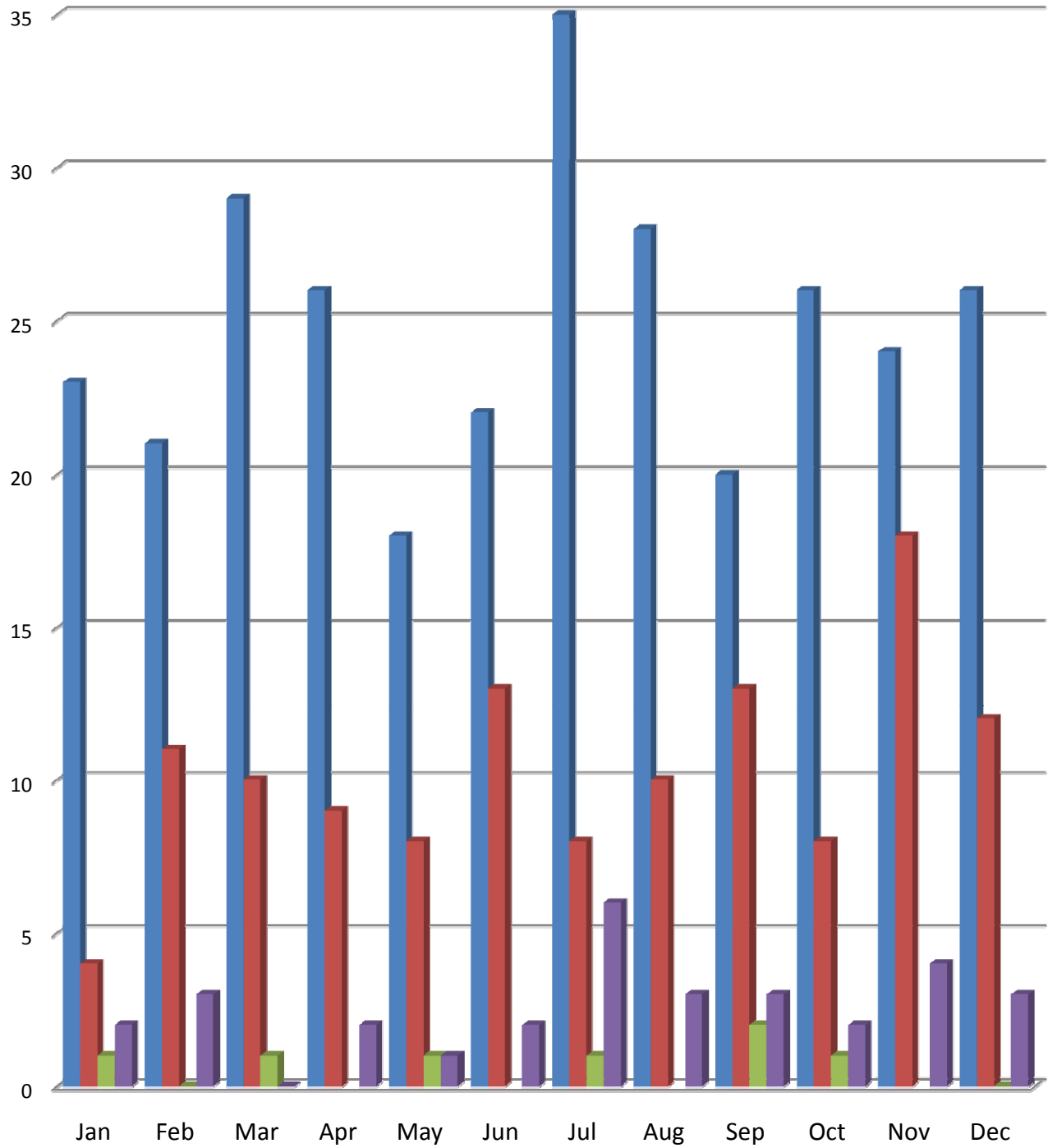
KFD responded to 105 emergencies to the university, which equaled 23% of our call volume.

2010 East/West of Bay Rd. Responses



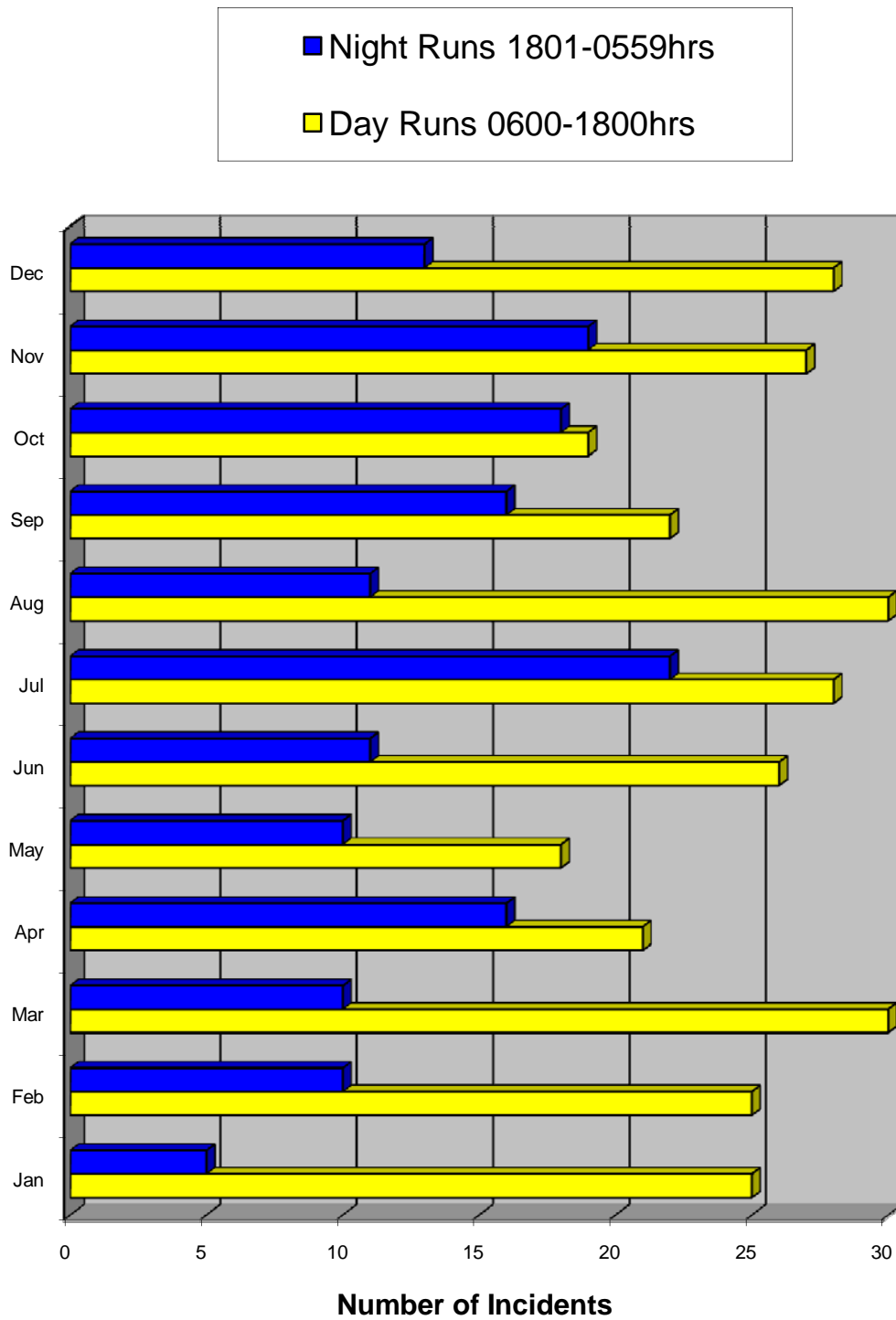
■ East of Bay Rd. (298 responses)

■ West of Bay Rd. (124 responses)

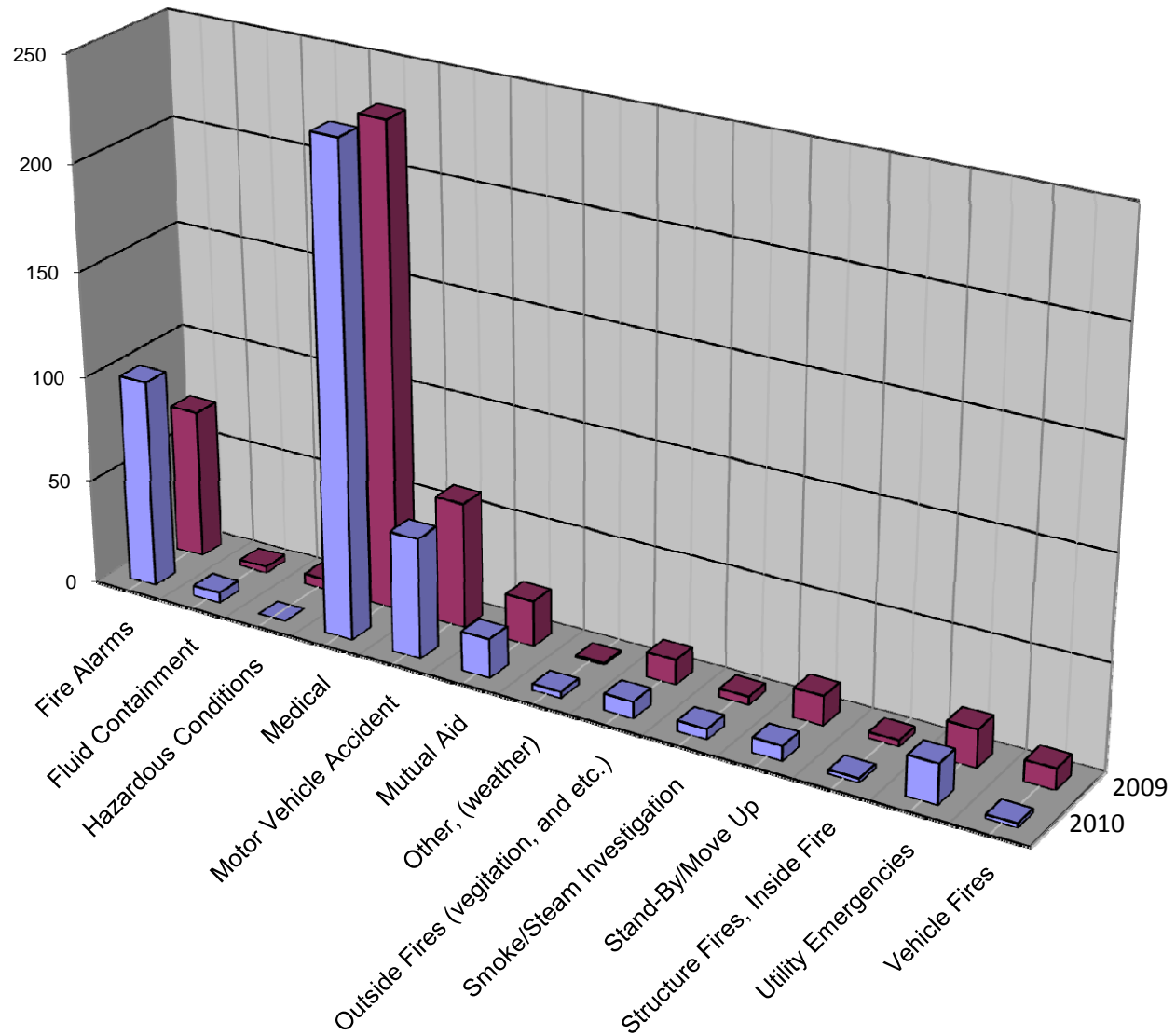

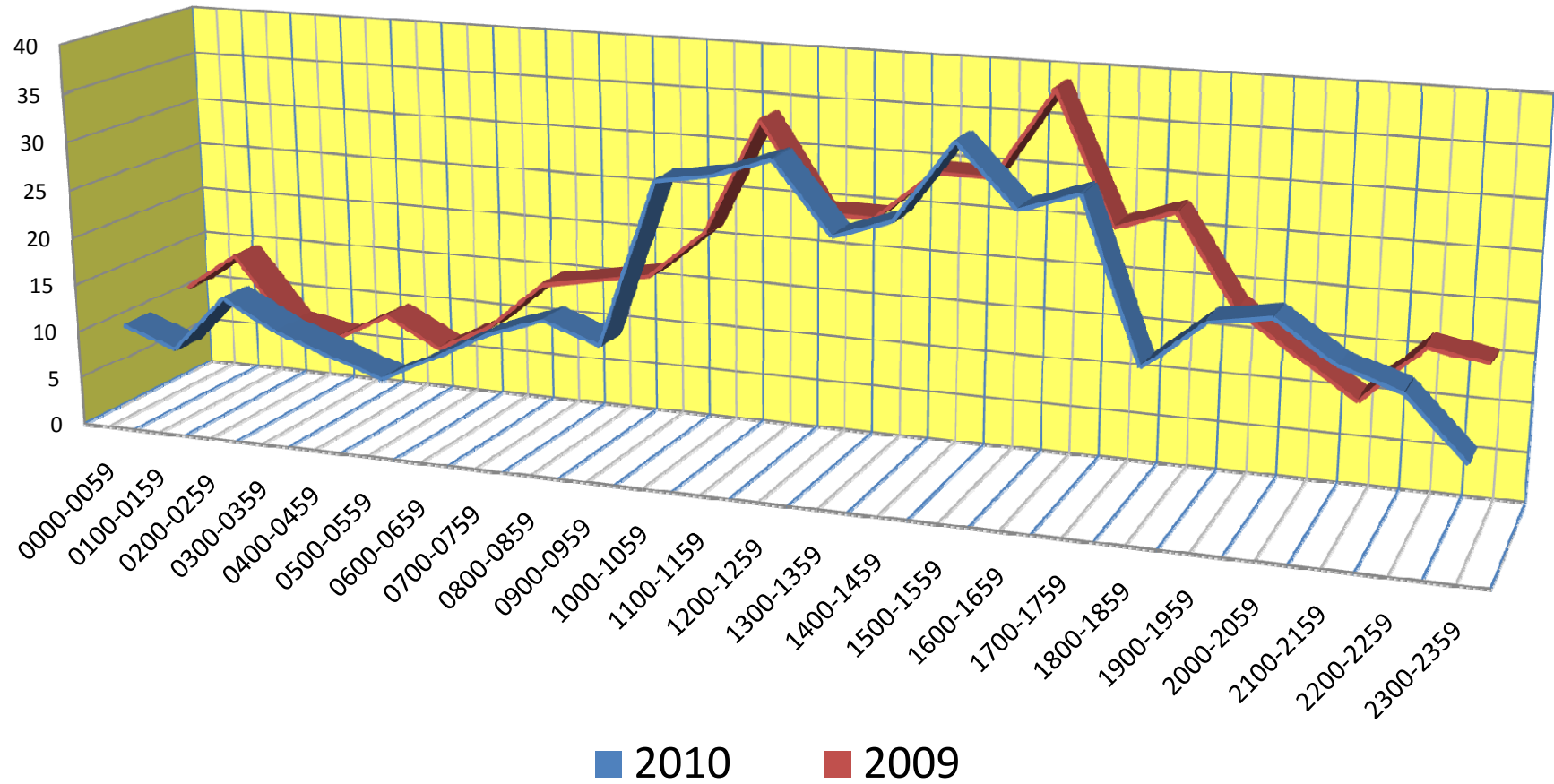
2010 Day and Night Runs

MEDICAL

Captain Mike Comstock-EMT



Kochville Township Fire Department continues to provide medical first response to our community as a State Certified EMS agency. The Fire Department maintains a compliment of two MFR licensed vehicles. We are priority dispatched by MMR. Priority dispatch means that we are not responding to all medical emergencies, only incidents involving life threatening details, or if MMR has a delayed response. This is the basic concept of sending the appropriate resources that are needed. We currently have two Emergency Medical Technicians (EMT) and ten Medical First Responders (MFR).

Kochville Township is represented on the Saginaw Valley Medical Control Authority, basic life support/medical first responder committee.

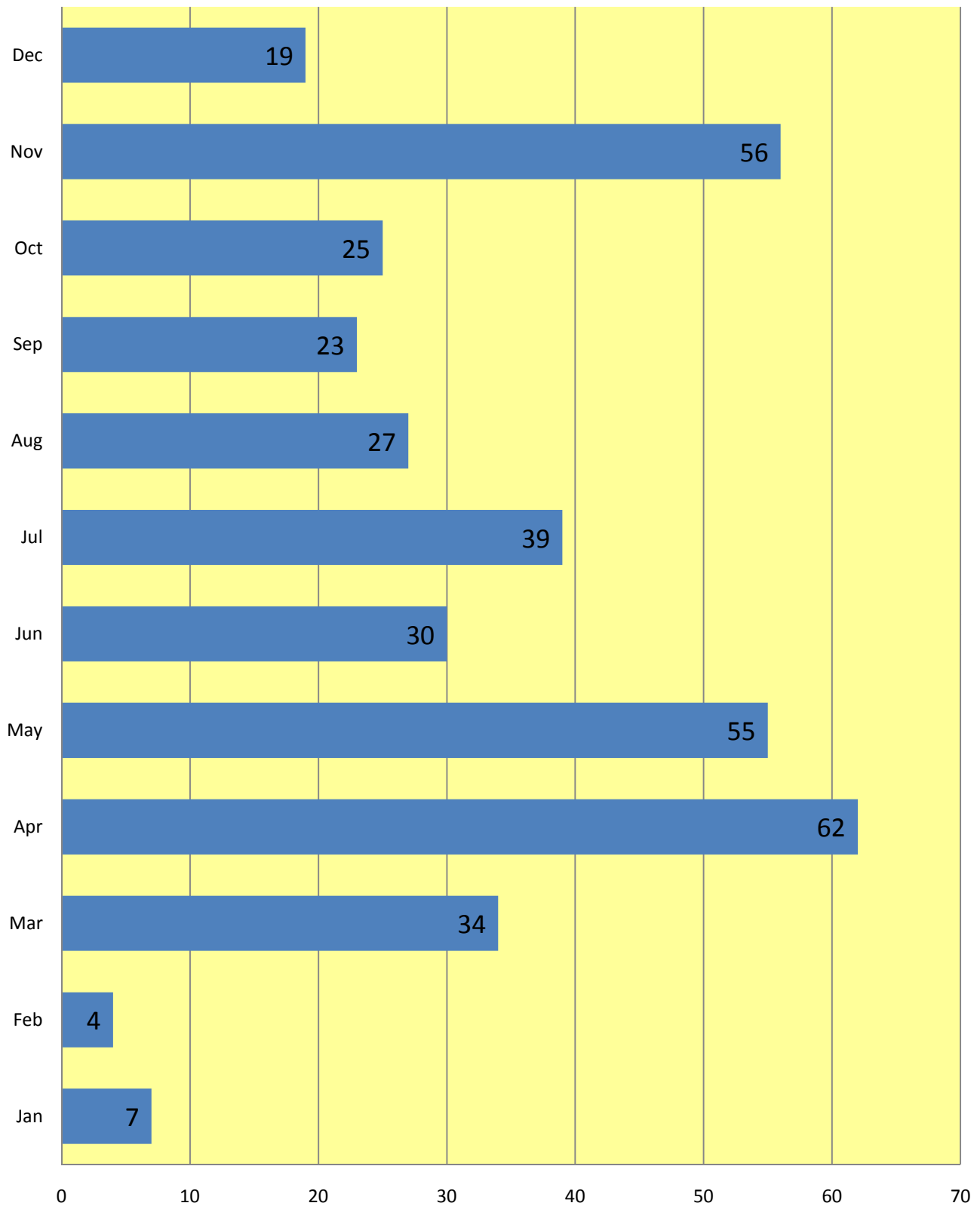
We responded to 221 medical emergencies in 2010.

Mobile Medical Response (MMR) responded to Kochville 531 times in 2010 compared to 614 times in 2009. Kochville fire responded 221 times. Kochville fire department responded to only 42% of the total medical calls in our community. Of the 531 medical emergencies MMR provided (ALS) Advance life support to 467 people.

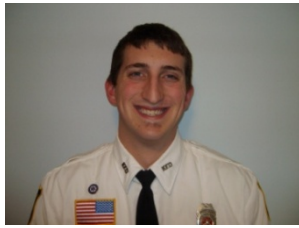

The Fire Inspection Division within the Kochville Township Fire Department works with local businesses to maintain fire and life safety codes adopted by the Township of Kochville through premise inspection. Site plan review, fire safety ideas, or potential construction topics can be discussed and reviewed by Ryan as well. I am a certified as a Fire Inspector I by the NFPA and State of Michigan; I also have certification as a Firefighter I

& II and multiple other trainings in the fire service along with education from Delta College, Michigan Fire Inspectors Society and the Public Agency Training Council.

In 2010 the following have been completed:

- Initial Inspections – 112

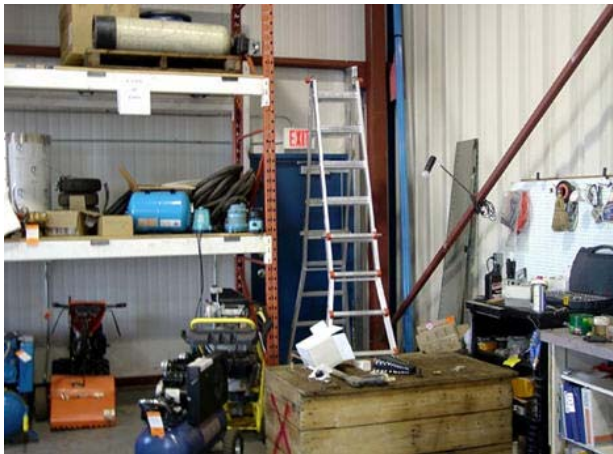
- Re – Inspections (Follow ups, Finals, etc.) – 125

I will be leaving the Kochville Fire Department on January 6th, 2010, but I will be on staff as a contractual employee until this position is filled.



FIRE TRAINING

In 2010 we scheduled a total 36 training sessions for our Firefighters. NFPA 1401 sets the standard for our training requirements.

Topics included: CPR, blood borne pathogens, patient assessment, vehicle extrication, water pump certification, search and rescue, firefighter survival, Firefighting tactics, forcible entry, ventilation, SCBA fit testing, SCBA proficiency testing, HIPAA, Employee right to know and Sexual Harassment.

Our firefighters participated in extra trainings that consisted of Agricultural Rescue, Submerged vehicle, Live fire training in Auburn, and a disaster drill @ MBS international airport.

Our Firefighters logged in a total of 678 training hours.



Health and Safety Coordinator

I am responsible for the health and safety of the fire department and fire fighter personnel. I also ensure the fire department and its personnel understand and operate within compliance of all regulatory guidelines, laws, codes, standards, policies and procedures of the Township of Kochville, OSHA, MIOSHA, and NFPA 1500. I have been an active member of the Kochville Fire Service for 14 plus years. During my tenure I have successfully completed more than 1400 hours of certified fire service training through the Michigan Fire fighter Training Council as well as training as a Medical First Responder licensed by the State of Michigan. I have currently held this position for five years.

Our firefighters are required to have a physical minimum of once every three years for Firefighters ages of 18-29, every two years for 30-39 years and every year for firefighters 40 plus. These physicals include the following. Plan A physical, 1-view chest X-Ray, Tetanus Shot, Vision Test, TB Test, Pulmonary Function Testing, Hepatitis A/B Twinx injection, EKG, Drug Screen 8 panel, Comprehensive blood Panel (Chem23, CBC, UA), Audiometric Exam, and Agility Test.

In 2010 we had one employee injury that occurred during regular maintenance time.

Personal Protective Equipment

I am responsible for all personal protective equipment, each year following MIOSHA part 74 standards and NFPA 1971 Standards. Each piece of equipment is inventoried and a visual inspection is performed. Our personal protective provides a barrier for our firefighters in a hostile environment. The equipment is very expensive, the life expectancy is usually five years, we average ten to twelve years. I am also responsible for outfitting firefighters with dress uniforms and accessories.

In fiscal year 2011/12 & 2012/13 our turnout gear is scheduled to be replaced.

Inventory and Maintenance

I am responsible for all apparatus inventory and maintenance. At every other training session our firefighters go through every apparatus and completely check the inventory. We also maintain every piece of motorized equipment, by starting the engine and checking fluid levels. Therefore making sure everything on our apparatus is ready to go at any given moment. After the inventory and maintenance is completed and recorded. I review the records and take corrective action to replenish supplies. Our apparatus and inventory are worth more than a million dollars. This is an investment for the community that we do not take lightly.

Chief's Message



The Kochville Township Fire Department personnel are extremely proud of our resources and our capabilities. We are very dedicated and committed to the citizens and businesses of Kochville. We have an excellent working relationship with our surrounding Fire Departments and will continue to do so in the future.

I would also like to mention our affiliation with the Saginaw County Sheriff Department and the Michigan State Police. Both use our Fire Station as a sub-station. I

also need to thank our Department of Public Works. Their commitment and assistance is greatly appreciated. Our two departments work very well together.

Our firefighters are valued more than any piece of equipment could be. They continually give up their time to help someone in need. They are willing to respond at any time of the day.

Most of the time people meet us on their worst day. If everything is alright, you do not need the services of the fire department. We pride ourselves on helping our fellow neighbors and human beings.

Budget:

Our budget is funded by a special assessment of 1 mil for residential properties and 2 mils for commercial properties. It is very critical to the community that we put revenue away for future capital purchases. We continually apply for grants in many different areas to fund these capital improvement projects. In the past we have been very successful receiving over \$500,000.00 from many various grants. Emergency Service Billing Corporation has been hired in the beginning of 2010 for the billing of our motor vehicle accidents, but Kochville continues to bill for excessive fire alarm violations.

Highlights:

In April FF Richard Wasney Jr. received the Kochville Township Firefighter of the year and FF Jerry Davis and FF Kevin Machata the BIG NOZZLE awards for participating the most in the previous year.

Remodeling of our training room. Our members performed most of the remodel work except for skilled labor. This has been such a nice addition, with very usable components for our fire & medical classroom training.

We upgraded our Knox box secure system. In the past one officer could have access to a Knox box key and enter any building, now it takes two personnel to input a pin number to release a key to enter the building. Also all key releases are tracked through a software program.

On June 12, 2010 we assisted Joseph Saumier of Zilwaukee with his Eagle Scout Project of a military flag burning ceremony at the VFW hall in Carrollton.

We also started offering our citizens the CIPP vials. This stands for Covenant Injury Prevention Program. These are available to our residents at no cost. The goal of this program is to have residents that take medications fill out their medical history and store them in their freezer, that way if we go on a medical call to their residence and they are unable to speak we can expedite their care by knowing what prescriptions they are on. They can also be put in the glove compartment of a vehicle in case of an accident. It's very helpful when medical information is readily available to health care providers.

The Township board approved the signing of Michigan Emergency Management Assistance Compact (MEMAC), and Mutual Aid Box Alarm System (MABAS).

Saginaw County Fire Chiefs approved a development of an Incident Management team that will assist communities with organization during disaster situations during the first twelve hours. Region-3 is developing an Incident management team that will assist communities for the duration of the disaster.

We hired probationary firefighters Kenneth Howden and Scott Dashkovitz.

Saginaw County Fire Chiefs approved a new accountability system for the tracking of firefighters on incidents.

We put into service new (Demo units) Self contained Breathing apparatus. These demo units saved the community a lot of dollars. New SCBA's would have cost \$7000.00 each; we paid \$2150.00 each for two year old SCBA's.



Future:

Our future capital improvement schedule consists of the replacement of our 1980 and 1986 brush trucks, 1988 Fire Engine and our 1999 Self Contained Breathing Apparatus.

Saginaw County Central Dispatch is installing a new computer aided dispatch (CAD) system before summer. This will enhance our dispatch information.

We are participating in an all day live fire scenario training at the Crest Center in Oakland County in the spring.

Our training scheduled has changed to 15 trainings a year, rotating from Monday night to Saturday morning.

All firefighters will be received annual evaluations in January of 2011.
