ST. LOUIS COUNTY, MISSOURI MONDAY, FEBRUARY 21, 2023

The meeting of the City Council of the City of Ladue, St. Louis County, Missouri, was held on Monday February 21st, 2023, at 4:00 p.m., at City Hall, 9345 Clayton Road. The following members were present:

Also, present were Police Chief Ken Andreski; Fire Chief Steven Lynn; Mr. Paul Garlock, Building Commissioner; Ms. Lamitola, Director of Public Works; Ms. Andrea Sukanek, City Planner; Ms. Erin Seele, City Attorney; and Ms. Lori Mullins, Deputy City Clerk.

Approval of the Agenda: Council Member Fox moved to approve the agenda, upon second by Council Member Brennan, the motion passed unanimously.

Approval of the Minutes: Mayor Spewak asked if there were any amendments, corrections, or clarifications to the minutes of the Regular Meeting of January 17, 2023. Council Member Brennan moved approval of the minutes as submitted; upon second by Council Member Fox, the motion passed unanimously.

Public Forum: No one wished to address the Mayor and Council.

Public Hearings:

PH1: The City Council will hold a Public Hearing regarding a request for a Special Use Permit Amendment for an addition to the clubhouse at the Bogey Club. The property is located at 9266 Clayton Road, in the B-Residential Zoning District.

Council Member Brennan moved to open the public hearing, with second by Council Member Howell the motion passed unanimously.

Mr. Matt Wolfe, Architect for the Bogey Club kitchen renovation shared the plans for the addition with the Council.

Ms. Sukanek stated that the Zoning and Planning Commission unanimously recommends approval, following standard construction conditions.

No one else came forward to speak.

Ms. Seele announced the public hearing notice, the application, Zoning and Planning file, the Code of Ordinances and Ordinance 1175 were available for viewing and part of the official record.

Council Member Hensley moved to close the public hearing, with second by Council Member Brennan the motion passed unanimously.

Council Member Hensley moved approval of the amendment to the Special Use Permit for renovations at the Bogey Club, located at 9266 Clayton Road, upon second by Council Member Burroughs the motion passed unanimously.

PH2: The City Council of the City of Ladue will hold a Public Hearing regarding a proposed text amendment regarding a new Planned Development procedure.

The public hearing was opened upon motion by Council Member Fox and second by Council Member Howell.

Ms. Sukanek shared the proposed text amendment to the Zoning Code allowing commercial and residential use in G-1 and G-2 zoning districts. The submitted changes reflect objectives and goals stated in the comprehensive plan with commercial properties on the street level and luxury condominiums on the upper floors. The text amendment is being presented with the approval of the Zoning and Planning Commission.

After discussion, it was determined that more information was necessary to amend the Zoning Code as proposed. Council Member Fox moved to keep open the public hearing through the March meeting, with second by Council Member Hensley the motion passed unanimously.

No one else came forward to speak.

Ms. Seele announced the public hearing notice, the application, Zoning and Planning file, the Code of Ordinances and Ordinance 1175 were available for viewing and part of the official record.

The public hearing was kept open through the March meeting upon motion by Council Member Hensley and second by Council Member Brennan.

PH3: The City Council of the City of Ladue will hold a Public Hearing regarding a proposed text amendment to add certain language to Section VII regarding Special Use Permits.

Council Member Burroughs moved to open the public hearing, with second by Council Member Fox the motion passed unanimously. Mayor Spewak announced that this application was forwarded to the Council from the Zoning & Planning Commission with a positive recommendation.

Ms. Sukanek reported the proposed additional language gives the City Council the full authority to deny or revoke Special Use Permits due to uses found to be unsuitable, non-compliant and/or creating a nuisance.

Ms. Seele added the current code does not include revocation language for Special Use Permits. Ms. Seele announced the public hearing notice, the application, Zoning and Planning file, the Code of Ordinances and Ordinance 1175 were available for viewing and part of the official record.

No one else came forward to speak.

The public hearing was closed upon motion by Council Member Burroughs and second by Council Member Fox.

New Business:

Proposed Legislation:

Bill No. 2326-An ordinance modifying Chapter 102 – Trees and Landscaping, of the Ladue Code of Ordinances of the City of Ladue

Mayor Spewak read Bill No. 2326 followed by a second reading by Council Member Brennan.

Ms. Lamitola reported that additional BOSTA Committee members will ensure meetings have a quorum, which will aid in performing the additional permit review responsibilities to the Committee.

Mr. David Woltz addressed the City Council on the issue of Bamboo and it's unwelcome spreading from yard to yard. He commended the City Council for taking measures to tackle the problem but suggested more vigorous measures such as adding a requirement for property owners to register bamboo plants with the City to ensure proper containment of the plant.

Mayor Spewak thanked Mr. Woltz for his comments and ensured that the City will monitor this going forward, and address it as necessary.

After discussion, Council Member Hensley moved approval of Bill No. 2326. Upon second by Council Member Fox the roll call vote thereupon was as follows:

Bill No. 2327- An ordinance amending Article VI, Drug Regulations, of Chapter 62, Offenses and Miscellaneous Provisions of the Code of Ordinances of the City of

Ladue, St. Louis County, Missouri in compliance with Amendment 3 to the Missouri Constitution.

Mayor Spewak read Bill No. 2327 followed by a second reading by Council Member Hensley.

Ms. Seele reported on the necessity of Bill No. 2327 to ensure compliance with Missouri Amendment 3.

Council Member Hensley moved approval of Bill No. 2327. Upon second by Council Member Fox the roll call vote thereupon was as follows:

Bill No. 2328- An ordinance amending Section 90-221 of Chapter 90 Streets and Sidewalks, Article IV. and Section 98-7 Chapter 98 Traffic, Article I., of the Code of Ordinance of the City of Ladue, St. Louis County, Missouri regarding traffic calming devices

Mayor Spewak read Bill No. 2328 followed by a second reading by Council Member Brennan.

Chief Lynn reported on the recommended amendments to Chapter 90 Section 90-221 by updating the language and eliminating the ban of speed bumps.

A second recommended change to Chapter 98 defines the procedure. Updating the title of Sec. 98-7 to Traffic Calming Devices in Streets, revising the terminology, and clarifying within the ordinance, that traffic calming devices are permitted by resolution, with placement to accommodate emergency vehicles.

A permit process will insure proper approval, placement, and removal at the end of the maximum 120-day period after approval by the City Traffic Commissioner, Fire Authority, and Police Chief.

Bill No. 2331-An ordinance to amend Ordinance 1175 – the Zoning Ordinances of the City of Ladue, St. Louis County, Missouri regarding the city council's authority over special use permits

Resolution No. 2023-10- A resolution authorizing the mayor to authorize on behalf of the City of Ladue, Missouri a contract amendment to work order #002 with Horner & Shifrin for engineering consultant services under the on-call professional services contract for the Foxboro Road buyout project for Flood Mitigation Assistance (FMA) Program
