Regular Meeting June 9, 2020

A meeting of the Lakesite City Commission sitting as the **Beer Licensing Board** of the City of Lakesite was held on **June 9, 2020 at 12:30 p.m.** at the Lakesite City Hall, 9201 Rocky Point Road, Lakesite. Members present were: Chairman David Howell, via and electronic "Zoom"call, Vice Chair Kenneth Wilkerson, Members: Curtis Jones, William Neighbors and Michelle Wilson. Also present were City Manager Dr. David Edwards and City Recorder Jodi P. LaCroix. Members of the public present were Darrell Jones and Valerie Boddy.

Chairman Howell stated that the Lakesite City Commission is sitting as the **Beer Licensing Board** pursuant to TCA 57-4-203 and the City of Lakesite Municipal Code of Ordinances 8-211 in order to hold a public hearing to consider the **application received from Darrell Jones d/b/a Jones Bay Inc., Dockside Market and Deli for premises located at 9546 Hixson Pike, Lakesite, TN 37379. This public hearing was advertised in the Chattanooga Times Free Press on June 1, 2020 and the required background check was submitted and returned as was all other required paperwork. Mr. Jones was notified by e-mail on May 28, 2020 of this meeting.**

Chairman Howell stated the original license was issued under Amanda England. Per Tennessee Law, Mr. Jones cannot operate under another person's license and it cannot be transferred. He must obtain his own. Chairman Howell asked if there were any questions from anyone. There were none therefore the public hearing was closed.

Motion made by Mr. Wilkerson, seconded by Mr. Jones to **approve the <u>application for a Beer License</u>** from Darrell Jones d/b/a Jones Bay Inc. Dockside Market & Deli for premises located at 9546 Hixson Pike, Lakesite.

ROLL CALL: Mr. Jones-yes; Mr. Neighbors-yes; Mrs. Wilson-yes; Mr. Wilkerson-yes; Chairman Howell-yes. Motion Carries.

Chairman Howell cautioned Darrell Jones on being careful not to sell to underage people. The Hamilton County Sheriff's Department is vigilant about checking establishments to make sure they are in compliance. He asked if Mr. Jones had any questions of the Board and Mr. Jones said no.


With no other business pending, the meeting adjourned at 12:40 p.m.

INSTRUCTIONS

Applications must be completed in full and returned with a \$250 non-refundable application fee. At this time, the City of Lakesite does not accept debit or credit cards. Checks should be made payable to the City of Lakesite.

Prior to being approved, the premises must first be inspected and approved by the City of Lakesite Building Official, Dallas Bay Vol. Fire Department and the Hamilton County Health Department.

Remember to have your signature notarized.

If you do not own the property the business is on, a copy of your lease must accompany the application.

A copy of your deed must accompany the application.

The applicant requesting the license must appear in person at the Beer Board when the application is considered for approval. Managers may represent owners at the meeting IF ownership offices are located out of town.

A permit holder must return a permit to the city that issued it within fifteen (15) days of termination of the business, change of ownership, relocation of the business or change of the business name. A change in ownership occurs for a corporate owner when at least fifty percent (50%) of the stock of the corporation is transferred to a new owner.
