- Insurance - The grantee shall have in force, during the period covered by the permit, appropriate general liability and workers' compensation insurance. Insurance certificates are required before the excavation permit will be issued.
Notifications -
1. The City of North Mankato shall be notified and a permit issued at least 3 days prior to starting any excavation.
2. Gopher State One-Call System shall be notified by the contractor at least 48 hours before excavating.
3. Residents inconvenienced or affected by work relating to this permit shall be notified by the Applicant not less than 48 hours prior to work commencing.

Applicant must provide the City with a copy of this excavation permit upon request. Applicant shall complete restoration of the entire disturbed area to original or better condition and to the satisfaction of the City of North Mankato. All subcontractors hired by the Applicant shall be listed on this permit. The City of North Mankato reserves the right to deny the services of any listed subcontractor(s) due to their previous work performance within the City. Permit expires within 60 days of City approval date.
