The Commission presented a Proclamation for the 80th Anniversary of the attack on Pearl Harbor.



WHEREAS, on December 7th, 1941, the United States Navy base at Pearl Harbor, Hawaii, was subjected to a evastating attack by the Naval forces of Imperial Japan; and

WHEREAS, the Japanese aggressor managed to destroy or damage nearly twenty American naval vessels, including eight battle ships as well as three hundred fighter planes; and

WHEREAS, a total of 2,335 U.S. servicemen were killed in the attack with 1,143 wounded. Sixty eight civilians also lost their lives with 35 wounded; and

WHEREAS, the battleship USS Arizona suffered the heaviest casualties of the attack. Out of 1,512 crewman only 335 survived when the vessel was sunk; and

WHEREAS, four of the Navy personnel killed on the Arizona Ernest Angle, William Gibson, Robert Robinson and Randall Thomas were natives of West Virginia; and

WHEREAS, twenty three sets of brothers were killed on the Arizona; and

WHEREAS, this attack led to the United States entry into World War II by the order of President Franklin Delano Roosevelt;

WHEREAS, the military personnel at Pearl Harbor showed outstanding courage in fighting back against their attackers. Fifteen of them were awarded our Nation's highest decoration for bravery, the Congressional Medal of Honor, and ten of these awards were posthumous; and

WHEREAS, Pearl Harbor was similar to 9/11 sixty years later. In each case America was attacked by a cowardly enemy who sought to tear our nation apart but in each case the United States prevailed and was victorious.

NOW, THEREFORE, BE IT RESOLVED that the Marion County Commission is proud to honor the brave men who served and died at Pearl Harbor. Let their great sacrifice remind each and every American of the terrible price of our freedom. Let us never forget.

Public Comment:

Allen Fluharty of the West Virginia Bass Federation expressed appreciation and presented a plaque to the Commission for their ongoing support of the bass tournaments held in Marion County. He also reported that he is hopeful to bring a National Bass tournament to Fairmont in the coming year; this will bring contestants and their families here for a period of 7 to 10 days, which will promote revenue for area hotels, restaurants, businesses, etc.

Commissioner Elliott thanked Mr. Fluharty for his leadership in bringing bass tournaments to Marion County and is glad that the Mon River and Palatine Park are seen as desirable locations at which to hold the bass tournaments.

Lloyd White, Marion County Health Department Director, provided an update for the Health Department. He reported that the department had just switched over some of their IT systems which will bring more continuity of care with other area healthcare systems, such as WVU Medicine and Mon Health. also reported that the COVID Vaccination center has opened below Fairmont Regional Medical Center on Locust Avenue from 9 a.m. to 3 p.m. averaging 22.37 vaccinations per day but are also averaging 27.26 cases per day; the goal is to get the case numbers down and the vaccination numbers up. He went on to report 64 Marion County deaths from July to the end of November, with the majority being unvaccinated. He is hopeful that the vaccine will prove to be effective against the new Omicron variant, but the research has not been conclusive on that yet. Mr. White reiterated the importance of getting vaccinated as the best line of defense against Covid and the ongoing variants that are produced as the virus remains active.

Meghan Payne from the Marion County Health Department gave some clarification about the recommended vaccination schedule, being 2 doses, followed later by a booster and then 6 months later another dose for those age 65 and older and those 50 and older who have compromising health conditions (making it 4 recommended doses). She reported that Marion County residents 65 and older have an 85% vaccination record, which is great; it is the other age groups that need to step up the percentage of vaccinations to help reduce the number of cases for our county, as well as the number of deaths. She stated that information regarding the vaccine and other Covid-related information can be found on the Marion County Health Department website.

There being no further business to come before the County Commission, it is ordered that this Commission do now recess until, Wednesday, December 15th 2021 at 10:00 a.m. for the next scheduled County Commission Meeting.
