NOVEMBER 3, 2025 BETWEEN 8:45 AM -10:00 AM TO REGISTER BEFORE THE SALE BEGINS. THERE WILL BE A \$25 COST TO REGISTER. All payments must be in the form of cash, cashier's check, certified funds, money order.**

**\*EFFECTIVE AS OF: SEPTEMBER 29, 2025** - all payments on delinquent taxes must be in the form of cash, cashier's check, certified funds, money order, debit or credit card. No personal checks of individuals or companies will be accepted.

**\*PAYMENT OF DELINQUENT TAXES WILL BE TAKEN IN THE DELINQUENT TAX OFFICE ON THE DAY OF THE SALE FROM 8:30 A.M- 10:00 A.M.
