<u>September 28, 2026</u>	Posting & Advertising (\$50.00 Levy Cost will be added)
<u>October 8, 2026</u>	1 <sup>st</sup> Advertisement on Real Estate
<u>October 15, 2026</u>	1 <sup>st</sup> Advertisement on Mobile Home and 2 <sup>nd</sup> Advertisement on Real Estate
<u>October 22, 2026</u>	2 <sup>nd</sup> Advertisement on Mobile Home and 3 <sup>rd</sup> Advertisement on Real Estate

**\*BIDDERS** - MUST COME TO THE DELINQUENT TAX OFFICE, MARLBORO COUNTY COURTHOUSE. **EARLY REGISTRATION ON WILL START OCTOBER 19, 2026 TO NOVEMBER 6, 2026 FROM 8:45 AM - 4:30 PM. WE WILL NOT DO REGISTRATION THE DAY OF THE TAX SALE. THERE IS A \$25 COST TO REGISTER. All payments must be in the form of cash, cashier's check, certified funds, money order. (WE PREFER CASHIER CHECKS OR MONEY ORDERS ON ALL BIDS)**

**\*EFFECTIVE AS OF: SEPTEMBER 28, 2026 - all payments on delinquent taxes must be in the form of cash, cashier's check, certified funds, money order, debit or credit card. No personal checks of individuals will be accepted.**

**\*PAYMENT OF DELINQUENT TAXES WILL NOT BE TAKEN THE DAY OF THE TAX SALE!** The dates may be subject to change, depending on the circumstances.
