2023 Message

To the Mayor, Alderman, City Administrator, Citizens of McMinnville and the Employees of the McMinnville Police Department:

The annual report highlights the activities of the McMinnville Police Department and reports the criminal and traffic statistics for 2023.



This report allows us to share our work, outreach, training, statistics, operations, and our challenges in a concise manner with all stakeholders.

101 East Main Street remains where Police Administration, Records, Criminal Investigations Division, and Patrol Shift Change are conducted. 202 Bell Street also continues to serve as the patrol shift area and break room along with providing storage for our department.

Calls for service were down in 2023 at 22,388 compared to 2022 at 24,092. Crimes against the person and property crimes, which include theft, did increase. Burglary was down 19.4%. Vehicle accidents increased in 2023 and drug violations were up 6.9%. The crime clearance rate increased in 2023, finishing the year at 67%.

Deputy Chief Michael Lane is second in command and performs numerous administrative duties, which include General Departmental Instructor. Lt. Stuart Whitman continues to serve our Accreditation Manager, Driver Safety School instructor for intermittent traffic offenders, Department Range Master and Armorer. The Critical Response Team, commanded by Capt. Ben Cantrell and composed of department officers remains operational and trains regularly at local facilities to train in differing scenarios.

The department maintains a close working relationship with the Tennessee Highway Safety Office, Warren County Sheriff's Department, Tennessee Highway Patrol, Tennessee Bureau of Investigation, District Attorney General Office and numerous Federal, State, and Local Law Enforcement Agencies. Officer Mark Mara continues to work with the Tennessee Highway Safety Grant that assists with traffic enforcement in our community. Mara also operates the department motorcycle in patrol and at events and host Child Passenger Safety Seat events. The McMinnville Police Department remains partnered with the McMinnville Housing Authority and McMinnville Parks and Recreation Department to provide additional police services in these two areas. The McMinnville Police Department is a co-founder and active member of the McMinnville-Warren County Crisis Intervention Team, which meets monthly exploring ways to better serve citizens with mental health issues. The department raining to officers and teaches crisis intervention at the Tennessee Law Enforcement Training Academy.

The McMinnville Police Department hosted Citizen Police Academy in September and expanded to include a Teen Citizens Police Academy this year. Police Department personnel continued to spend hundreds of hours working in school classrooms, with civic and nonprofit organizations, delivering Meals on Wheels, and participating in safety and community events, including the 2<sup>nd</sup> Annual Battle of the Badge softball game which works to gather school supplies for local hero teachers.




## McMinnville Police Department Organizational Chart



#### <u>Clerical</u>

### **Public Relations**

The McMinnville Police Department utilizes vast communication methods to connect and engage with citizens. These methods include local media outlets, capable of online, print, and broadcast media. We also connect and engage with citizens through personal interactions, varying social media platforms, and participation on the City of McMinnville website. These interactions are essential in communicating and conveying the daily operations, as well as the mission of the McMinnville Police Department.

During 2023, MPD participated in numerous public relations and safety events. These events included community outreach in our local schools, community events, child passenger safety events, traffic safety campaigns, hosting our Citizens Police Academy, Teen Citizens Police Academy, participating in our 2<sup>nd</sup> Annual Battle of the Badge event, and partnerships with private organizations. Our events were included in print news articles, as well as featured in broadcast from both our local radio station and stations in surrounding communities. McMinnville Police Department's Facebook Page and participation in the City of McMinnville website were also a powerful tool to connect with the public in 2023. The weekly wrap up included on the City's website each Thursday allowed us to provide information on things we had worked on during the week, upcoming events, and the ability to also share information and statistics from the department with our citizens.

# **OPERATIONS DIVISION**




### **Operations Division**

McMinnville Police Department Operations Division is divided into four shifts, with each shift being commanded by a Shift Lieutenant. The Shift Lieutenants can confer with the Administrative Lieutenant for day-to-day operations, but each answer to the Chief of Police.

During 2023, the Operations Division consisted of 31 positions. Four shifts working 12.25 hours each work to provide round-the-clock police service to the Citizens of McMinnville. In addition to the shifts noted, McMinnville Police Department operate specialized assignments that work to both strengthen security and intensify community engagement and relations within specific areas of the city. Two officers are assigned to the McMinnville Housing Authority and another two officers are assigned to the McMinnville Parks and Recreation Department in order to achieve these efforts.

Officers assigned to the Operations Division have several responsibilities. Officers respond to initial calls for service, complete reports including incidents and traffic crashes, and provide traffic law enforcement and support during events. Additional responsibilities include patrolling the business districts and residential neighborhoods, providing vacation watch to residents, and many other various police services. The Operations Division actively participates in the Department's community policing initiatives and works closely with the Tennessee Highway Safety Office.



## Personnel Allocation and Distribution Report

The McMinnville Police Department bases the allocation of manpower on assessments of the workloads, to ensure the efficient and effective operation of the department.

The Operations Division is allocated 30 personnel. These personnel are distributed in the order of 4 shift lieutenants, 1 administrative lieutenant, 4 sergeants, 3 master patrol officers and 18 patrol officers.

Each officer is required to work 85.75 hours in a two week pay period or 2229.5 hours per year. Lost time is calculated from City benefits, (sick time, vacation, required training and personal leave) that amounts to an average of 270 hours lost. The assignment availability factor is 87%.

#### Officers by Contract

The McMinnville Police Department has a contract with the McMinnville Housing Authority to provide an officer daily to patrol the Housing Authority properties. Two officers are currently assigned to fulfill this duty. While these officers are required by contract to provide services to the McMinnville Housing Authority, these officers are allowed to provide emergency response for assistance to the shift officers if needed.

#### Summary

During 2023, the department answered 22,388 calls for service. This reflects a decrease of 7% from 2022 as calls for service totaled 24,092. Increased traffic enforcement remains a priority for our department along with our effort to reduce traffic crashes. 506 speeding citations, 1,581 citations for other traffic violations, and 41 arrests were made for driving under the influence. The Tennessee Highway Safety Office, Warren County Sheriff's Department, and the Tennessee Highway Patrol work alongside the McMinnville Police Department on special patrols designed to detect impaired drivers and with goals to reduce traffic crashes.

# SUPPORT SERVICES DIVISION



## **Support Services Division**

The Support Services Division is commanded by Deputy Chief Michael Lane, who is also the second in command of the Police Department.

The McMinnville Police Department is divided into two divisions of responsibility, the Operations Division, and the Support Services Division. The division allows police work and investigations to be handled effectively and efficiently.

The Criminal Investigations Unit and Public Safety Unit work within the Support Services Division.

The Support Services Division handles the following responsibilities:

- Community Policing Efforts
- Crime Analysis
- Departmental Statistics
- Citizen Police Academy
- Business Watch Program
- Departmental Training
- Budget Management
- Purchasing
- Quartermaster
- Sex Offender Registry
- Evidence Custodian

Detectives are cross trained in the various areas of responsibility within the Criminal Investigative Division. This training enables the division to effectively carry out the responsibilities required of the unit while also providing service to the community efficiently. Detectives and other personnel within the Support Services Division are readily available to aid and provide support to the Operations Division.



The Criminal Investigations Unit (CID) is generally responsible for the investigation of any major crimes that occur within the city. Specifically, the responsibilities include the following:

- Responding to and investigating all reports of major crimes, such as murder, rape, arson, armed robbery, and kidnapping.
- Processing major crime scenes, including documenting, collecting, and preserving evidence.
- Conducting follow-up investigations on cases which cannot be adequately investigated by the patrol division.
- Conducting surveillance on criminal suspects, suspected crime locations and suspected targets of criminal acts.
- Gathering, analyzing, storing, and disseminating intelligence, including the analysis and publication of crime trend data.
- Preparation of regular reports regarding division performance, crime trends, clearance rates and arrests.
- Preparing, disseminating, and conducting interviews on major crimes.
- Participating in task forces, working with other agencies to fight drug crimes, and participating in the Drug Court Program.
- Maintaining case files
- Registering sex offenders, validating information they provide, conducting follow-up investigations, completing administrative paperwork, and maintaining registration files and computer databases.
- Participating in the CPIT (Child Protective Investigative Team)

#### **Child Passenger Seat Checks**

The McMinnville Police Department in conjunction with the McMinnville Fire Department and Warren County Sheriff's Department conducts numerous child passenger safety seat events throughout the community each year. These events work to educate parents about the importance of the proper use of child safety restraint devices. Child safety seat technicians examine child passenger seats to ensure they are properly installed.

#### Public Safety Unit

The Public Safety Unit (PSU) was created in 2003. The mission of the Public Safety Unit is to enhance the effectiveness of the Police Operations Division by serving as a community-oriented program of the department. The unit performs duties that do not require a post-certified officer and therefore relieves officers of those duties.

While on shift, a PSU officer will take on non-law enforcement duties such as directing traffic at crash scenes, escorting funeral processions, assisting motorists, and patrolling parks within the City of McMinnville.

The PSU unit plays a vital role in the successful outcome of events held within the city. Events include The Christmas Parade, July 4<sup>th</sup> festivities, civic sponsored runs, parades, and other community events.

Officers of the Public Safety Unit volunteered a total of 1130.5 hours in 2023.

#### Training 2023

The McMinnville Police Department works to provide each officer with a high level of training. Areas of skilled training include basic police and specialized areas. Tennessee Law Enforcement Training Academy which includes a12 Week, 495 Hour Basic Law Enforcement School is attended by all newly hired non-certified officers.

McMinnville Police Department officers complete 40 hours of basic in-service each year which is mandatory. Officers also attend other specialized schools.

McMinnville Police Department officers received collectively over 1400 hours of basic in-service training and 1159 hours of specialized training.
