

PARTIAL DISCHARGES OF MORTGAGES INDEXED: From 1823 to Jan. 12, 1973, Partial Discharges were marginal only.
Also check for partial discharges under the following:

- Grantor-Lender
- Grantee-Borrower

After Jan. 12, 1973, the Borrower is listed as a Grantor and the partial discharges were recorded.

FULL DISCHARGES INDEXED: Same as #1 above, Note: Discharges and Partial Releases were Not recorded until 1973, they were noted as marginal reference only on original mortgage.

ASSIGNMENTS OF MORTGAGES INDEXED:

From 1823 to 1973, Same as 1 & 2 above.
From 1973 to present:

- Grantor-Assignor
- Grantee-Assignee
- Grantor-Borrower

PARTIAL RELEASE OF ATTACHMENTS INDEXED:

From 1823 to 1973, Same as 1, 2 & 3 above.
From 1973 to present
Grantor-Defendant

FULL DISCHARGE OF ATTACHMENT INDEXED: 1823 To 1973, Same as 1-4, above.

From 1973 to present
Grantor-Defendant

Grantor-Town and Taxpayer

TRUST AND TRUSTEES AS GRANTORS INDEXED:

Grantor-Trust name and Trustees

TRUST AND TRUSTEES AS GRANTEES INDEXED:

When establishing a trust, the trust is the Grantor to the Trustee as Grantee.

PLANS INDEXED:

All Plans from 1823 to present are computerized. The index is listed by name of plan, owner of land, development and for plans recorded after 1988, listings may include abutter, street names and other pertinent information found on the plan.

AGREEMENTS:

All parties

AFFIDAVITS INDEXED:

Grantor-All parties named in document

FORECLOSURES INDEXED:

These are listed as the foreclosure part of the document:

- Grantor-Owner(s) being Foreclosed
- Grantee-Bank/Person foreclosing

These are listed as the Deed part of the Foreclosure:

- Grantor-Bank/Person Foreclosing
- Grantee-Person buying at foreclosure

HYPHENATED NAMES INDEXED:

Grantor & Grantee as Required with name before and after Hyphen appearing in Surname. Example: Smith-Jones Mary or Jones Mary Smith

ST. PIERRE OR STPIERRE INDEXED:

The standard practice in indexing names such as these is to index them as they appear, with or without spaces, periods are not used in indexing. You should also check under the full spelling of Saint, Mount and any other names that have abbreviations that could be spelled out. Example: St.Pierre = Saint Pierre
