PROPOSITION K.I.D.S.**

Shall the Board of Education of the Miller County R-III School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Five Hundred Thousand Dollars (\$500,000) for the purpose of providing funds to refurbish the gymnasium to include floor refinishing, painting, and sound system upgrades; to renovate the Agricultural classroom/shop and greenhouse; to complete playground upgrades; to make parking lot improvements; to complete athletic field improvements, including installation of LED lights; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof?

If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.3942 per one hundred dollars of assessed valuation of real and personal property.
