#### **MINUTES:**

- April 19, 2021 regular meeting minutes

Councilwoman Ross offered a motion to approve the minutes. Seconded by Councilman Galli.

#### **REPORTS:**

- Clerk – Clerk Bonin reminded everyone the NJ Primary is June 8<sup>th</sup>. Vote by mail or in person. Regular voting again.
- Emergency Management (OEM/State Police/Fire) – no report
- Finance/Tax Collection – no report
- Historic Commission – no report
- Recreation Commission – Mayor Heck reported the annual borough wide yard sale will be held during the second week in June, and the garbage bulk pick up will be the following Tuesday.

#### **COUNCIL REPORTS:**

- Buildings and Grounds – Councilwoman Ross stated we need to continue updating the park. Mayor Heck commented that he will spread mulch this weekend and new fence rails coming. Ms. Ross stated we should ask for volunteers to spread mulch. Ms. Ross asked about removing the graffiti in the park. Mayor Heck stated it has been addressed, painted
- Planning Board – Councilman Galli stated he missed the last Planning Board last meeting. Mayor Heck said he attended the meeting and the board discussed the plan endorsement acceptance. They also discussed property maintenance has improved since penalties were instituted.
- Traffic and Roads – Council President Kidd reported he has quote from Sealmaster for crack sealing borough roads. He stated the material is expensive, but to rent box is cheap. A total cost of \$1,300 and we may wish to consider buying box for another \$800.

#### **MAYOR'S REPORT:**

Mayor Heck commented on the Millstone low Covid cases. No death, mild cases. Despite the low numbers, the Mayor stated we will continue to disinfect the park and high contact areas.

The Mayor also commented there was a coyote sighting in town. He commented there is no real threat and residents should take the precaution to not leave food outside.

Thomas Hitchcock and Deborah Rzemieniewski were present to discuss the development options for the remaining 2 acres of the former Rzem property. Mr. Hitchcock asked if the borough as a preference for what to see there. Attorney Offen informed everyone we are discussion Block 1 Lot 7, and stated there was no agreement on this property so it is subject to standard zoning, which currently is Village commercial. Mr. Hitchcock agreed with Mr. Offen.

Mr. Hitchcock stated the family has long history with town and the historical nature of borough is barely mentioned in official documents. He continued that no historical artifacts were found on this property when the County constructed the bypass. He added that when sewer are constructed the tax burden will be on residents. Mr. Hitchcock commented that if the borough wants historical development on this property nothing may happen. He further commented that Millstone needs revenue producing property. Mr. Hitchcock stated the family's intention to sell property to a developer and hopes the borough would not prevent a developer from installing something to bring in revenue and this must be developed in a realistic way. He believes the two acres could be rezoned into two sections, one with entrance on Main Street and one on bypass.

Mayor Heck stated he appreciated Mr. Hitchcock's comments and asked Attorney Offen if the property is in sewer service area. Attorney Offen stated he believes it is but will confirm.

Mayor Heck commented that there are no restrictions on the property other than the current zoning. He further commented that the services provided by the borough are done at the lowest cost in the County. He said Mr. Hitchcock should bring a concept forward to planning board.

Mr. Hitchcock made point to say they don't want to attempt to do something that will cause extended discussions and was hoping borough would give idea of what they would like to see so no time is wasted.

**WHEREAS**, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

**WHEREAS**, the Borough Council of the Borough of Millstone in the County of Somerset finds it advisable and necessary to increase its CY 2021 budget by up to 3.5% over the previous year’s final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

**WHEREAS**, the Borough Council hereby determines that a 3.5% increase in the budget for said year, amounting to \$14,782.46 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

**WHEREAS**, the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED**, by the Borough Council of the Borough of Millstone, in the County of Somerset, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2021 budget year, the final appropriations of the Borough of Millstone shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$14,782.46, and that the CY 2021 municipal budget for the Borough of Millstone be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED**, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Notice is hereby given that the Budget and Tax Resolution were approved by the Borough Council of the Borough of Millstone, County of Somerset, on April 19, 2021.

A hearing on the Budget and Tax Resolution was held in the Borough Hall, on May 17, 2021 at 7:30 PM at which time comments, including objections, to said Budget and Tax Resolution for the year 2021 were presented by taxpayers or other interested persons.

- **DISCUSSION:** ordinance describing difference between farm animal and pet and how to develop framework.

Mayor Heck asked the Borough Council members if they wish to consider an ordinance to consider a framework for the management in the borough of farm animals. Particularly animals such as chicken, pigs, etc. Councilwoman Ross asked if there have been more complaints. Mayor Heck stated none that he is aware as he tracks complaints and resolutions. Councilman Biviano asked what the complaint was about, smell, noise. Mayor Heck said no complaint on any of those items.

Council President Kidd suggested we look into an ordinance to limit or prescribe rules for farm animals. The Borough Council agreed.

- **Noise discussion** – Mayor Heck stated we don’t have a noise ordinance, largely because there would be a need for an enforcement officer trained to use a decibel meter. Mayor Heck thinks this is less a noise issue and more quality of life, especially construction noise. Mayor Heck believes we should consider an ordinance to identify what time of day certain items can be used.

Attorney Offen stated such ordinances are not unusual and there are two ways to limit noise: measure decibels or limit hours of activity.

Mayor Heck suggested limiting the hours of activity. The Borough Council agreed.

Council President Kidd also suggested we consider an ordinance to prevent residents from parking on lawns.

Councilman Galli asked which day the annual bulk trash pick up day will be in the Borough as this is a big event in town. He also asked that residents be notified.
