# 3. Regional Park Fencing

Mr. Matt Russell stated that the property owner adjacent to the Regional Park attended the August 5, 2019 Park and Recreation Commission Meeting to discuss the maintenance of the fencing installed by the City of Montrose on the north and west side of their property and on the City's property.

Mr. Jim Herzog and Mrs. April Herzog, 4671 County Road Twelve (12) South, addressed the City Council requesting that the City repair and maintain the erosion on the west side of their property under the fence.

The City Council directed staff to have the City's Engineer evaluate the erosion.

Mr. McCormick stated that the Public Works Department employees have filled in the erosion area.

Mrs. Herzog shared her concerns about the Public Works Department employees entering their property to do work without prior notification. Mr. McCormick stated that in the future, the City will contact Mr. and Mrs. Herzog before entering their property.

Mrs. Herzog requested that the City install a porta-potty in the area of the Community gardens. City staff stated that there is a porta-potty located in the Regional Park.

# 4. Winter Skating Rink

Mr. Russell stated that the Park and Recreation Commission is recommending that Skating Rinks be installed in Carver Field and the Lions Park.

Public Works Department Director, Mr. Wayne McCormick, recommended that the Skating Rink in Carver Field be moved to Lions Park and another one be installed in Northridge Park. Mr. McCormick shared his concerns about the damage the Skating Rink is causing to Carver Field.

Mayor Otto motioned to have a small Skating Rink installed at Carver Field and a large Skating Rink in the Lions Park with future planning to eventually move the Skating Rink from Carver Field to Northridge Park. Council Member Johnson seconded. Motion carried 3-1. Council Marszalek opposed.

5. Montrose Days - Coin Hunt

Mr. Russell stated that the Park and Recreation Commission would like to sponsor a *Coin Hunt* during Montrose Days. He continued by stating the cost to sponsor the event would not exceed \$200.00.

Mayor Otto motioned to approve a *Coin Hunt* to be sponsored by the Park and Recreation Commission on Saturday, August 17, 2019 during Montrose Days with expenses not to exceed \$200.00. Council Member Johnson seconded. Motion carried 4-0.

# D. Planning and Zoning Commission

1. July 10, 2019 Planning and Zoning Commission Meeting Minutes

Ms. Boelter gave an overview of the items discussed at the July 10, 2019 Planning and Zoning Commission Meeting.

2. August 21, 2019 Planning and Zoning Commission Meeting - Public Hearing

Ms. Boelter stated that the Planning and Zoning Commission will be holding a Public Hearing on Wednesday, August 21, 2019 to consider amendments to the City's Zoning Ordinance language regarding signs.

3. September, 2019 Planning and Zoning Commission Meeting

Ms. Boelter stated that she has contacted the Planning and Zoning Commission Members to request changing the Wednesday, September 18, 2019 Meeting to Wednesday, September 11, 2019. She continued by stating that she will be attending the Minnesota Municipal Clerks and Finance Officers Association (MCFOA)'s Advanced Academy for her City Clerk-Treasurer Certification from September 18, 2019 to September 20, 2019.

Ms. Boelter stated that the Planning and Zoning Commission Members were in agreement to move the Meeting to Wednesday, September 11, 2019.

### E. City Engineer

1. Trunk Highway 25 (TH 25) Improvements Project – Bid Results

The City's Engineer, Mr. Shawn Louwagie, stated that bids were received for the TH 25 Improvements Project on Friday, August, 2019. He continued by stating that the Project was advertised in the newspaper and on QuestCDN, which is an internet based public bid advertisement website. Thirteen (13) companies listed as prime bidders downloaded the bid package from the QuestCDN website.

Mr. Louwagie stated that the City received one (1) bid to complete the work from R&R Excavating, Incorporated of Hutchinson, Minnesota. The received bid was tabulated and verified and sent to the Minnesota Department of Transportation (MN DOT) staff for their review and approval. MN DOT approval of the submitted bid is required before the City may elect to award the contract per the Cooperative Agreement.

Mr. Louwagie stated that the submitted bid to complete the work was in the amount of \$942,401.01. This bid amount is to complete both MN DOT's work scope and the City's work scope. Based on the breakdown of responsible costs, the cost share responsibility is anticipated to be as follows:

Mr. Louwagie stated that the City portion of the costs is allocated to the sanitary sewer replacement, watermain replacement, and the trail construction costs.

Mr. Louwagie presented the anticipated schedule for the Project:

- → July 8, 2019: Authorize Advertisement for Bids
- → July 11, 2019: Advertisement in the Legal Paper
- > August 2, 2019: Bid Submissions Due and Bid Opening
- > August 12, 2019: Present Bids to Council for Consideration
- > End of August, 2019: Begin Construction
- > October 31, 2019: Complete Construction

Mr. Louwagie stated that verbal discussion with MN DOT staff indicates that they are satisfied with the bid received and will be sending over a revised Schedule I and bid concurrence to City staff.

Mr. Louwagie stated that staff requests that the City Council consider the received bid and determine whether to award the Improvements Project to R&R Excavating, Incorporated. in the amount of \$942,401.01.

Council Member Marszalek asked Mr. Louwagie why there was only one (1) bid received. Mr. Louwagie stated that the scope of the Improvements Project takes two (2) different contractors; so, some companies do not want to deal with work that they have to subcontract. He continued by stating that because the Project is under the direction of MN DOT, it requires more paperwork and some contractors do not want to complete the extra paperwork requirements.

Ms. Wendy Manson, Deputy Clerk stated that the City's portion of costs are less than the City budgeted for the Project.

Council Member Moynagh motioned to award the Trunk Highway Twenty-Five (TH 25) Improvements Project to R & R Excavating, Incorporated in the amount of \$942,401.01. Council Member Marszalek seconded the motion. Motion carried 4-0.

# 2. Emerson Avenue Improvement Project - Quote Results

Mr. Louwagie stated that Wenck staff has received quotes for the Emerson Avenue Improvement Project. He continued by stating that quote requests were sent out to a total of thirteen (13) contractors and out of the contractor solicitations two (2) quotes were received:

Mr. Louwagie stated that the proposed improvements to Emerson Avenue are to widen the section from 2nd Street to Mindy Lane from the existing nineteen feet (19') width to twenty-eight feet (28'), which would better align this segment of Emerson Avenue with the segments to the north and south. Reclamation of the existing street section is proposed in the base bid along with the addition of concrete curb and gutter along both sides of the street.

Mr. Louwagie presented the anticipated timeline for the Project:

- → July 8, 2019: Authorize Request for Quotes
- > July 10, 2019: Solicit Quote Requests to Contractors
- August 2, 2019: Quote Results Due
- > August 12, 2019: Present Quotes to Council for Consideration
- > End of August, 2019: Begin Construction
- > October 31, 2019: Complete Construction

Mr. Louwagie stated that based on the received quotes, it is recommended that the Base Bid be awarded without awarding Alternate 1. This allows for the reclamation of Emerson Avenue in lieu of milling and overlaying it.

Mr. Louwagie stated that staff requests that City Council review the received quotes and determine whether to award the Improvement Project to Mid Minnesota Hot Mix in the amount of \$130,675.00.

Council Member Johnson asked Mr. Louwagie if curb and gutter were going to be installed. Mr. Louwagie stated that curb and gutter was being installed on both the east and west sides of Emerson Avenue.

Ms. Manson stated that the City did budget \$100,000 for the Emerson Avenue Improvement Project.

Council Member Marszalek motioned to award the Emerson Avenue Improvement Project to Mid Minnesota Hot Mix in the amount of \$130,675.00. Council Member Moynagh seconded the motion. Motion carried 4-0.

Mr. Louwagie gave an update on the proposed sludge removal options at the WWTP.

Council Member Moynagh motioned to adopt Resolution No. 2019-19 A Resolution Approving the Purchase of Real Property and Dispensing with Statutory Requirements for Review by Planning Commission. Council Member Marszalek seconded the motion. Motion carried 4-0.

B. Wright County Sheriff's Office - Year 2020-2021 Contract

Ms. Boelter presented the Wright County Sheriff's Office Year 2020-2021 Contract for law enforcement services within the City of Montrose.

Captain Todd Hoffman of the Wright County Sheriff's Office was in attendance at the City Council Meeting to answer questions.

Council Member Marszalek motioned to approve the Year 2020-2021 Contract between the City of Montrose and the Wright County Sheriff's Office for Police protection services. Mayor Otto seconded the motion. Motion carried 4-0.

Mayor Otto called the meeting to order at 3:30 p.m.

#### 3. PUBLIC HEARING

- A. Consider Amendments to the Economic Development Authority's Governing Resolution
  - Consider amendments to the City of Montrose's Economic Development Authority (EDA)'s Governing Resolution

Mr. Shannon Sweeney of David Drown Associates presented Resolution Number (No.) 2019-20. He presented the following significant changes:

- > Membership is changing from five (5) City Council Members to two (2) City Council Members and three (3) Business Owners.
- > The EDA will need to seek approval from the City Council to expend any EDA funds.

Mayor Otto asked about whether the EDA Members will receive any type of reimbursement for attending meetings. Council Member Marszalek stated that the EDA Members will be paid \$25 per meeting. Mr. Sweeney stated that the reimbursement fee will be passed in a separate Resolution.

Council Member Johnson asked if Roberts Rules of Order is a law. Mr. Sweeney stated that it is not a law; but, the most commonly used rules for public meetings. The City Attorney, Mr. James Monge stated that it is one of several rules for public bodies to follow when conducting a meeting.

Council Member Moynagh motioned to open the Public Hearing. Council Member Marszalek seconded the motion. Motion carried 5-0.

Mayor Otto asked for public comment.

Ms. Catherine Neiberger, 125 Hill Street, addressed the City Council and stated that the efforts to reestablish the EDA are important.

Mr. Doug Voerding, 315 Dakota Avenue South, addressed the City Council and asked if three (3) representatives from the Montrose Business Community is enough. Mr. Sweeney stated that five (5) total Members is a good start when you are refocusing the EDA like the City of Montrose is doing. He continued by stating that if there is enough interest and passion for the EDA in the future, the City can increase the membership.

Council Member Moynagh motioned to close the Public Hearing. Council Member Marszalek seconded the motion. Motion carried 5-0.

Council Member Moynagh motioned to adopt Resolution Number (No.) 2019-20 A Resolution Amending Resolution Number 92-15 Establishing the Economic Development Authority for the City of Montrose. Council Member Kuehl seconded the motion. Motion carried 5-0.

### BUSINESS

- A. United States (U.S.) Census Bureau Presentation Mr. Michael Gold-Biss
  - 1. Year 2020 Census and the Complete Count Committee

Mr. Michael Gold-Biss presented information on the proposed *Complete Count Committee* for the year 2020 Census.

Mr. Biss stated that in the past, the Census was primarily conducted by mail response. He continued by stating that in the year 2020 there will also be online registration. In the year 2000 Census, the City of Montrose had a seventy-six percent (76%) participation rate. In the year 2010 Census, there was a seventy-three percent (73%) participation rate. Mr. Biss stated that the goal of the U.S. Census Bureau is to have ninety percent (90%) participation.

Mr. Biss stated that the U.S. Census Bureau is asking cities to establish a *Complete Count Committee* consisting of a trusted group of residents from the Montrose Community who would encourage residents to complete the year 2020 survey. The City Council would determine who would be on the *Committee* and the *Committee Members* would receive training from the U.S. Census Bureau in-person and/or via webinar.

Ms. Boelter stated that the City Council should identify members of the Montrose Community who would be suitable members of the Complete Count Committee and forward their names to City staff.

B. Introduction of City Attorney, Mr. James Monge, III

Ms. Boelter introduced the new City Attorney, Mr. James Monge, III.

Mr. Monge stated that he worked for the League of Minnesota Cities for fifteen (15) years and Campbell Knutson, P.A. for four (4) years.

C. Engineering Discussion

Ms. Boelter stated that the City Council asked to have the Engineering Discussion on the *Special City Council Meeting* Agenda.

Council Member Kuehl motioned to appoint Bolton and Menk, Incorporated as the City Engineer; but, to continue engineering services with Wenck for the Trunk Highway Twenty-Five (TH 25) Project and Emerson Avenue Improvement Project. Council Member Marszalek seconded the motion.

Mayor Otto and Council Member Johnson shared their concerns about the service that engineers from Bolton and Menk, Incorporated provided when they were the City's Engineering Firm.

Council Member Marszalek shared his concerns regarding the increase in expenditures from Wenck for the same type of services and their lack of timely response to City staff requests.

The City staff shared some of the expenditures that are higher than those of Bolton and Menk, Incorporated. City staff also shared information on particular incidents where Wenck has failed to respond to staff requests in a timely fashion.

The City Council discussed whether the City should again go through the Request For Proposal (RFP) process. The City Attorney, Mr. Monge stated that the City Council can decide to appoint an engineer without the RFP process or they can again go through the RFP process.

The City Council discussed and Mayor Otto directed staff to have the City's Engineer from Wenck, Mr. Shawn Louwagie and his supervisor attend the Monday, September 9, 2019 Regular City Council Meeting to discuss their job performance with the City of Montrose.

Mayor Otto took a vote on the motion and second.

Motion failed 2-3. Mayor Otto opposed. Council Member Johnson opposed. Council Member Moynagh opposed.

### D. Code Enforcement

1. Update on Code Enforcement Progress

Ms. Boelter gave an update on Code Enforcement efforts. She continued by stating that the majority of residents who were asked to rectify code enforcement issues on their property have complied.

Ms. Boelter stated that she is working with the property owners who need additional time to remediate their code enforcement issues.

2. Discussion on Fencing - 123 Hill Street

Ms. Boelter asked the City Council for direction on the removal of the chicken wire that was added to the top of the wooden fence at 123 Hill Street.

Council Member Kuehl motioned to direct City staff to have the property owner at 123 Hill Street remove the chicken wire from the top of their wood fence. Council Member Marszalek seconded the motion. Motion carried 5-0.

### E. Franchise Fees Discussion

Ms. Boelter presented the DRAFT Ordinances to implement gas and electric franchise fees in the City of Montrose. She continued by stating that there would be franchise fees for electric with both Xcel Energy and Wright-Hennepin Cooperative Electric Association. The gas franchise fees would be through Xcel Energy.

Ms. Boelter stated that the City Council will need to establish the rates for residential and commercial/industrial. She continued by presenting the rates of cities similar in population and also the rates of surrounding cities.

The City Council discussed and decided on the rate of \$4.00 for residential and \$8.00 for commercial/industrial per Parcel Identification (P.I.D.) Number; not for each meter.

City staff stated that with a rate of \$4.00 for residential properties and \$8.00 for commercial/industrial properties, the City will have an estimated additional annual revenue of \$128,620.00. Ms. Manson stated that this additional revenue could be designated for street improvements; because, there are several streets in the City that need to be repaired and/or improvements made in the near future. She continued by stating that at some point in the future, a portion of the franchise fees revenue could be designated for park improvements.

Council Member Marszalek motioned to establish the electric and gas franchise fee rates as \$4.00 per residential P.I.D. Number and \$8.00 per commercial/industrial P.I.D. Number. Mayor Otto seconded the motion. Motion carried 5-0.

### F. Telephone System Proposal

Ms. Boelter stated that the City's current telephones and system are not working properly and are not conducive to City business. She continued by presenting a proposal to upgrade the City's telephone system and to improve the City's internet service.

Ms. Boelter presented the options to lease the new telephones or purchase them. The City Council discussed and agreed to purchase the telephones.

Council Member Marszalek motioned to accept the communication proposal from Central Telephone and Comcast Business. Council Member Kuehl seconded the motion. Motion carried 5-0.

### DISCUSSION ON YEAR 2020 PROPOSED BUDGET

Ms. Manson presented the proposed Year 2020 General Fund Budget and Levy.

Ms. Manson stated that the proposed Preliminary Levy for the City of Montrose for the year 2020 is \$1,312,635.00; an increase of six percent (6%) or \$73,305.00 over the year 2019 Preliminary Levy.

Ms. Manson stated that the estimated tax capacity for the year 2020 is \$2,371,000.00 compared to \$2,195,173.00 for the year 2019. She continued by stating that with estimated tax capacity the tax rate will actually decrease 1.09%; which means there would be little or no impact on the year 2020 property taxes.

Ms. Manson stated that the property tax is calculated as follows:

> Tax Capacity (one percent (1%) of your property value as shown on your property tax statement) times (X) Tax Rate

She continued by stating that the tax rate calculation is:

> Proposed Levy divided by (÷) the Total City Tax Capacity

Ms. Manson provided an estimate of property tax based on value:

The City Council reviewed the proposed General Fund Budget and Levy with staff. They directed City staff to bring the proposed six percent (6%) increase to the Year 2020 General Fund Budget and Levy to the September 9, 2019 Regular City Council Meeting for approval.

Ms. Boelter reminded the City Council that after the Preliminary Budget and Levy are approved, the City cannot increase them; so, you want to approve the increase now. The Preliminary Budget and Levy can be decreased before the Final Budget and Levy are approved in December.

### GAS FRANCHISE ORDINANCE

### ORDINANCE NO. 2019-08

### CITY OF MONTROSE, WRIGHT COUNTY, MINNESOTA

AN ORDINANCE GRANTING TO NORTHERN STATES POWER COMPANY, A MINNESOTA CORPORATION, ITS SUCCESSORS AND ASSIGNS, PERMISSION TO ERECT A GAS DISTRIBUTION SYSTEM FOR THE PURPOSES OF CONSTRUCTING, OPERATING, REPAIRING AND MAINTAINING IN THE CITY OF MONTROSE, MINNESOTA, THE NECESSARY GAS PIPES, MAINS AND APPURTENANCES FOR THE TRANSMISSION OR DISTRIBUTION OF GAS TO THE CITY AND ITS INHABITANTS AND OTHERS AND TRANSMITTING GAS INTO AND THROUGH THE CITY AND TO USE THE PUBLIC GROUNDS AND PUBLIC WAYS OF THE CITY FOR SUCH PURPOSES.

THE CITY COUNCIL OF THE CITY OF MONTROSE, WRIGHT COUNTY, MINNESOTA, ORDAINS:

### SECTION 1. DEFINITIONS.

For purposes of this Ordinance, the following capitalized terms listed in alphabetical order shall have the following meanings:

- 1.1 City. The City of Montrose, County of Wright, State of Minnesota.
- 1.2 **City Utility System.** Facilities used for providing non-energy related public utility service owned or operated by City or agency thereof, including sewer and water service, but excluding facilities for providing heating, lighting or other forms of energy.
- 1.3 **Commission.** The Minnesota Public Utilities Commission, or any successor agency or agencies, including an agency of the federal government, which preempts all, or part of the authority to regulate Gas retail rates now vested in the Minnesota Public Utilities Commission.
- 1.4 **Company.** Northern States Power Company, a Minnesota corporation, its successors and assigns.
- 1.5 Gas. "Gas" as used herein shall be held to include natural gas, manufactured gas, or other form of gaseous energy.
- 1.6 **Gas Facilities.** Pipes, mains, regulators, and other facilities owned or operated by Company for the purpose of providing gas service for public use.

- 1.7 **Notice.** A written notice served by one party on the other party referencing one or more provisions of this Ordinance. Notice to Company shall be mailed to the General Counsel, 404 Nicollet Mall, 8<sup>th</sup> Floor, Minneapolis, MN 55401. Notice to the City shall be mailed to the City Clerk/Treasurer, City Hall, 311 Buffalo Avenue South, P.O. Box 25, Montrose, MN 55363. Either party may change its respective address for the purposes of this Ordinance by written notice to the other party.
- 1.8 **Public Ground.** Land owned by the City for park, open space or similar purposes, which is held for use in common by the public.
- 1.9 **Public Way.** Any street, alley, walkway or other public right-of-way within the City.

# SECTION 2. <u>ADOPTION OF FRANCHISE</u>.

- 2.1 <u>Grant of Franchise</u>. City hereby grants Company, for a period of 20 years from the date passed and approved by the City, the right to transmit and furnish Gas energy for light, heat, power and other purposes for public and private use within and through the limits of the City as its boundaries now exist or as they may be extended in the future. For these purposes, Company may construct, operate, repair and maintain Gas Facilities in, on, over, under and across the Public Grounds and Public Ways of City, subject to the provisions of this Ordinance. Company may do all things reasonably necessary or customary to accomplish these purposes, subject, however, to such reasonable regulations as may be imposed by the City pursuant to ordinance and to the further provisions of this franchise agreement
- 2.2 <u>Effective Date, Written Acceptance</u>. This franchise agreement shall be in force and effect from and after passage of this Ordinance, its acceptance by Company, and its publication as required by law. The City, by Council resolution, may revoke this franchise agreement if Company does not file a written acceptance with the City within 90 days after publication of this Ordinance.
- 2.3 <u>Service and Rates</u>. The service to be provided and the rates to be charged by Company for Gas service in City are subject to the jurisdiction of the Commission.
- 2.4 <u>Publication Expense</u>. The expense of publication of this Ordinance will be paid by City and reimbursed to City by Company.
- 2.5 <u>Dispute Resolution</u>. If either party asserts that the other party is in default in the performance of any obligation hereunder, the complaining party shall provide written notification to the other party of the default and the desired remedy. Representatives of the parties must promptly meet and attempt in good faith to negotiate a resolution of the dispute. If the dispute is not resolved within 30 days of the written notice, the parties may jointly select a mediator to facilitate further discussion. The parties will equally share the fees and expenses of this mediator. If a mediator is not used or if the parties are unable to resolve the dispute within 30 days after first meeting with the selected mediator, either party may commence an action in District Court to interpret and enforce this franchise for such other relief as may be permitted by law or equity for

breach of contract, or for any other action permitted by law.

# SECTION 3. LOCATION. OTHER REGULATIONS.

- 3.1 <u>Location of Facilities</u>. Gas Facilities shall be located, constructed and maintained so as not to interfere with the safety and convenience of ordinary travel along and over Public Ways and so as not to disrupt normal operation of any City Utility System previously installed therein. Gas Facilities shall be located on Public Grounds as determined by the City. Company's construction, reconstruction, operation, repair, maintenance and location of Gas Facilities shall be subject to permits if required by separate ordinance and to other reasonable regulations of the City to the extent not inconsistent with the terms of this franchise agreement. Company may abandon underground gas facilities in place, provided, at City's request, Company will remove abandoned metal pipe interfering with a City improvement project, but only to the extent such metal pipe is uncovered by excavation as part of the City's improvement project.
- 3.2 <u>Field Locations</u>. Company shall provide field locations for its underground Gas Facilities within City consistent with the requirements of Minnesota Statutes, Chapter 216D.
- 3.3 Street Openings. Company shall not open or disturb any Public Ground or Public Way for any purpose without first having obtained a permit from the City, if required by a separate ordinance, for which the City may impose a reasonable fee. Permit conditions imposed on Company shall not be more burdensome than those imposed on other utilities for similar facilities or work. Company may, however, open and disturb any Public Ground or Public Way without permission from the City where an emergency exists requiring the immediate repair of Gas Facilities. In such event Company shall notify the City by telephone to the office designated by the City as soon as practicable. Not later than the second working day thereafter, Company shall obtain any required permits and pay any required fees.
- 3.4 Restoration. After undertaking any work requiring the opening of any Public Ground or Public Way, Company shall restore the same, including paving and its foundation, to as good a condition as formerly existed, and shall maintain any paved surface in good condition for one year thereafter. The work shall be completed as promptly as weather permits, and if Company shall not promptly perform and complete the work, remove all dirt, rubbish, equipment and material, and put the Public Ground or Public Way in the said condition, the City shall have, after demand to Company to cure and the passage of a reasonable period of time following the demand, but not to exceed five days, the right to make the restoration at the expense of Company. Company shall pay to the City the cost of such work done for or performed by the City. This remedy shall be in addition to any other remedy available to the City for noncompliance with this Section 3.4, but the City hereby waives any requirement for Company to post a construction performance bond, certificate of insurance, letter of credit or any other form of security or assurance that may be required, under a separate existing or future ordinance of the City, of a person or entity obtaining the City's permission to install, replace or maintain facilities in a Public Way.

- 3.5 Avoid Damage to Gas Facilities. Nothing in this Ordinance relieves any person from liability arising out of the failure to exercise reasonable care to avoid damaging Gas Facilities while performing any activity.
- 3.6 Notice of Improvements. The City must give Company reasonable notice of plans for improvements to Public Grounds or Public Ways where the City has reason to believe that Gas Facilities may affect or be affected by the improvement. The notice must contain: (i) the nature and character of the improvements, (ii) the Public Grounds and Public Ways upon which the improvements are to be made, (iii) the extent of the improvements, (iv) the estimated time when the City will commence the work, and (v) if more than one Public Ground or Public Way is involved, the order in which the work is to proceed. The notice must be given to Company a sufficient length of time in advance of the actual commencement of the work to permit Company to make any necessary additions, alterations or repairs to its Gas Facilities.

### SECTION 4. <u>RELOCATIONS</u>.

- 4.1 Relocation of Gas Facilities in Public Ways. If the City determines to vacate a Public Way for a City improvement project, or whenever it shall be necessary for the City to grade, regrade, or change the line of any Public Way, or construct or reconstruct any City Utility System in any Public Way, it may order Company to relocate its Gas Facilities located therein if relocation is reasonably necessary to accomplish the City's proposed public improvement. Except as provided in Section 4.3, Company shall relocate its Gas Facilities at its own expense. The City shall give Company reasonable notice of plans to vacate for a City improvement project, or to grade, regrade, or change the line of any Public Way or to construct or reconstruct any City Utility System. If a relocation is ordered within five years of a prior relocation of the same Gas Facilities, which was made at Company expense, the City shall reimburse Company for non-betterment costs on a time and material basis, provided that if a subsequent relocation is required because of the extension of a City Utility System to a previously unserved area, Company may be required to make the subsequent relocation at its expense. Nothing in this Ordinance requires Company to relocate, remove, replace or reconstruct at its own expense its Gas Facilities where such relocation, removal, replacement or reconstruction is solely for the convenience of the City and is not reasonably necessary for the construction or reconstruction of a Public Way or City Utility System or other City improvement.
- 4.2 <u>Relocation of Gas Facilities in Public Ground</u>. City may require Company at Company's expense to relocate or remove its Gas Facilities from Public Ground upon a finding by City that the Gas Facilities have become or will become a substantial impairment to the existing or proposed public use of the Public Ground
- 4.3 <u>Projects with Federal Funding.</u> City shall not order Company to remove or relocate its Gas Facilities when a Public Way is vacated, improved or realigned for a right-of-way project or any other project which is financially subsidized in whole or in part by the Federal Government or any agency thereof, unless the reasonable non-betterment costs of such relocation are first paid to Company. The City is obligated to pay Company only for those portions of its relocation costs

for which City has received federal funding specifically allocated for relocation costs in the amount requested by the Company, which allocated funding the City shall specifically request. Relocation, removal or rearrangement of any Company Gas Facilities made necessary because of a federally-aided highway project shall be governed by the provisions of Minnesota Statutes, Section 161.46, as supplemented or amended. It is understood that the rights herein granted to Company are valuable rights.

4.4 <u>No Waiver</u>. The provisions of this franchise apply only to facilities constructed in reliance on a franchise from the City and shall not be construed to waive or modify any rights obtained by Company for installations within a Company right-of-way acquired by easement or prescriptive right before the applicable Public Ground or Public Way was established, or Company's rights under state or county permit

### **SECTION 5. TREE TRIMMING.**

Company is also granted the permission and authority to trim all shrubs and trees, including roots, in the Public Ways of City to the extent Company finds necessary to avoid interference with the proper construction, operation, repair and maintenance of Gas Facilities, provided that Company shall save City harmless from any liability arising therefrom, and subject to permit or other reasonable regulation by the City.

### SECTION 6. INDEMNIFICATION.

- 6.1 <u>Indemnity of City</u>. Company shall indemnify, keep and hold the City, its officials, consultants and agents, free and harmless from any and all liability on account of injury to persons or damage to property occasioned by the construction, maintenance, repair, inspection, the issuance of permits, or the operation of the Gas Facilities located in the Public Grounds and Public Ways. The City shall not be indemnified for losses or claims occasioned through its own negligence except for losses or claims arising out of or alleging the City's negligence as to the issuance of permits for, or inspection of, Company's plans or work. The City shall not be indemnified if the injury or damage results from the performance in a proper manner of acts reasonably deemed hazardous by Company, and such performance is nevertheless ordered or directed by City after notice of Company's determination.
- 6.2 <u>Defense of City</u>. In the event a suit is brought against the City under circumstances where this agreement to indemnify applies; Company at its sole cost and expense shall defend the City in such suit if written notice thereof is promptly given to Company within a period wherein Company is not prejudiced by lack of such notice. If Company is required to indemnify and defend, it will thereafter have control of such litigation, but Company may not settle such litigation without the consent of the City, which consent shall not be unreasonably withheld. This section is not, as to third parties, a waiver of any defense or immunity otherwise available to the City; and Company, in defending any action on behalf of the City shall be entitled to assert in any action every defense or immunity that the City could assert in its own behalf.

### SECTION 7. VACATION OF PUBLIC WAYS.

The City shall give Company at least two weeks prior written notice of a proposed vacation of a Public Way. Except where required for a City improvement project, the vacation of any Public Way, after the installation of Gas Facilities, shall not operate to deprive Company of its rights to operate and maintain such Gas Facilities, until the reasonable cost of relocating the same and the loss and expense resulting from such relocation are first paid to Company. In no case, however, shall City be liable to Company for failure to specifically preserve a right-of-way under Minnesota Statutes, Section 160.29.

# SECTION 8. CHANGE IN FORM OF GOVERNMENT.

Any change in the form of government of the City shall not affect the validity of this Ordinance. Any governmental unit succeeding the City shall, without the consent of Company, succeed to all of the rights and obligations of the City provided in this Ordinance.

### SECTION 9. FRANCHISE FEE.

- 9.1 <u>Fee Schedule</u>. During the term of the franchise hereby granted, and in lieu of any permit or other fees being imposed on the Company, the City may impose on the Company a franchise fee by collecting the amounts indicated in a Fee Schedule set forth in a separate ordinance from each customer in the designated Company Customer Class.
- 9.2 <u>Separate Ordinance</u>. The franchise fee shall be imposed by a separate ordinance duly adopted by the City Council, which ordinance shall not be adopted until at least 90 days after written notice enclosing such proposed ordinance has been served upon Company by certified mail. The fee shall not become effective until the beginning of a Company billing month at least 90 days after written notice enclosing such adopted ordinance has been served upon Company by certified mail. Section 2.5 shall constitute the sole remedy for solving disputes between Company and the City in regard to the interpretation of, or enforcement of, the separate ordinance. No action by the City to implement a separate ordinance will commence until this Ordinance is effective. A separate ordinance which imposes a lesser franchise fee on the residential class of customers than the maximum amount set forth in Section 9.1 above shall not be effective against Company unless the fee imposed on each other customer classification is reduced proportionately in the same or greater amount per class as the reduction represented by the lesser fee on the residential class.
- 9.3 Collection of the Fee. The franchise fee shall be payable quarterly and shall be based on the amount collected by Company during complete billing months during the period for which payment is to be made by imposing a surcharge equal to the designated franchise fee for the applicable customer classification in all customer billings for gas service in each class. The payment shall be due the last business day of the month following the period for which the payment is made. The franchise fee may be changed by ordinance from time to time; however, each change shall meet the same notice requirements and not occur more often than annually and no change shall require a collection from any customer for gas service in excess of the amounts specifically permitted by this Section 9. The time and manner of collecting the franchise fee is subject to the approval of the

Commission. No franchise fee shall be payable by Company if Company is legally unable to first collect an amount equal to the franchise fee from its customers in each applicable class of customers by imposing a surcharge in Company's applicable rates for gas service. Company may pay the City the fee based upon the surcharge billed subject to subsequent reductions to account for uncollectibles, refunds and correction of erroneous billings. Company agrees to make its records available for inspection by the City at reasonable times provided that the City and its designated representative agree in writing not to disclose any information which would indicate the amount paid by any identifiable customer or customers or any other information regarding identified customers.

# 9.4 <u>Terms Defined.</u>

- 9.4.1 "Customer Class" shall refer to classes listed in the Fee Schedule and as defined or determined in Company's gas rate book on file with the Commission.
- 9.4.2 "Fee Schedule" refers to the Schedule in Section 9.1 setting forth the various customer classes from which a franchise fee would be collected if a separate ordinance were implemented immediately after the effective date of this franchise agreement. The Fee Schedule in the separate ordinance may include new Customer Classes added by the Company to its gas tariffs after the effective date of this franchise agreement.
- 9.4.3 Therm shall be a unit of gas providing 100,000 Btu of heat content adjusted for billing purposes under the rate schedules of Company on file with the Commission.
- 9.5 Equivalent Fee Requirement. The separate ordinance imposing the fee shall not be effective against Company unless it lawfully imposes and the City monthly or more often collects a fee or tax of the same or greater equivalent amount on the receipts from sales of energy within the City by any other energy supplier, provided that, as to such a supplier, the City has the authority to require a franchise fee or to impose a tax. The "same or greater equivalent amount" shall be measured, if practicable, by comparing amounts collected as a franchise fee from each similar customer, or by comparing, as to similar customers the percentage of the annual bill represented by the amount collected for franchise fee purposes. The franchise fee or tax shall be applicable to energy sales for any energy use related to heating, cooling or lighting, or to run machinery and appliances, but shall not apply to energy sales for the purpose of providing fuel for vehicles. If the Company specifically consents in writing to a franchise or separate ordinance collecting or failing to collect a fee from another energy supplier in contravention of this Section 9.5, the foregoing conditions will be waived to the extent of such written consent.

### SECTION 10. PROVISIONS OF ORDINANCE.

10.1 <u>Severability</u>. Every section, provision, or part of this Ordinance is declared separate from every other section, provision, or part and if any section, provision, or part shall be held invalid, it shall not affect any other section, provision, or part. Where a provision of any other City ordinance conflicts with the provisions of this Ordinance, the provisions of this Ordinance shall

prevail.

10.2 <u>Limitation on Applicability</u>. This Ordinance constitutes a franchise agreement between the City and Company as the only parties and no provision of this franchise shall in any way inure to the benefit of any third person (including the public at large) so as to constitute any such person as a third party beneficiary of the agreement or of any one or more of the terms hereof, or otherwise give rise to any cause of action in any person not a party hereto.

# SECTION 11. AMENDMENT PROCEDURE.

Either party to this franchise agreement may at any time propose that this agreement be amended to address a subject of concern and the other party will consider whether it agrees that the amendment is mutually appropriate. If an amendment is agreed upon, this Ordinance may be amended at any ti.me by the City passing a subsequent ordinance declaring the provisions of the amendment, which amendatory ordinance shall become effective upon the filing of Company's written consent thereto with the City Clerk/Treasurer within 90 days after publication by the City of the amendatory ordinance.

# SECTION 12. PREVIOUS FRANCHISES SUPERSEDED.

This franchise supersedes any previous Gas franchise granted to Company or its predecessor.

**SECTION 1**. The City of Montrose Municipal Code is hereby amended to include reference to the following Special Ordinance.

- **Subd. 1.** <u>Purpose</u>. The Montrose City Council has determined that it is in the best interest of the City to impose a franchise fee on those public utility companies that provide natural gas services within the City of Montrose.
  - (a) Pursuant to City Ordinance 2019-08, a Franchise Agreement between the City of Montrose and Northern States Power Company, a Minnesota corporation, its successors and assigns, the City has the right to impose a franchise fee on Northern States Power Company, a Minnesota corporation, its successors and assigns, in an amount and fee design as set forth in the fee schedule attached hereto as <u>Schedule A</u>.

The fee shall be in lieu of any permit or other fees being imposed on Company. This fee is an account-based fee on each premise and not a meter-based fee. In the event that an entity covered by this ordinance has more than one meter at a single premise, but only one account, only one fee shall be assessed to that account. If a premise has two or more meters being billed at different rates, the Company may have an account for each rate classification, which will result in more than one franchise fee assessment for electric service to that premise. If the Company combines the rate classifications into a single account, the franchise fee assessed to the account will be the largest franchise fee applicable to a single rate classification for energy delivered to that premise. In the event any entities covered by this ordinance have more than one premise, each premise (address) shall be subject to the appropriate fee. In the event a question arises as to the proper fee amount for any premise, the Company's manner of billing for energy used at all similar premises in the city will control.

Subd. 3. Payment. The franchise fee shall be payable quarterly and shall be based on the amount collected by Company during complete billing months during the period for which payment is to be made. The payment shall be due the last business day of the month following the period for which the payment is made. The franchise fee may be changed by ordinance from time to time; however, each change shall meet the same notice requirements and not occur more often than annually and no change shall require a collection from any customer for gas service in excess of the amounts specifically permitted by the attached fee schedule. The time and manner of collecting the franchise fee may be subject to the approval of the Commission. No franchise fee shall be payable by Company if Company is unable to first collect an amount equal to the franchise fee from its customers in each applicable class of customers by imposing a surcharge in Company's applicable rates for gas service. Company may pay the City the fee based upon the surcharge billed subject to subsequent reductions to account for uncollectibles, refunds and correction of erroneous billings.

Company agrees to make its records available for inspection by the City at reasonable times provided that the City and its designated representative agree in writing not to disclose any information which would indicate the amount paid by any identifiable customer or customers or any other information regarding identified customers.

- **Subd. 4.** <u>Surcharge</u>. The City recognizes that the Minnesota Public Utilities Commission may allow Company to add a surcharge to customer rates of city residents to reimburse Company for the cost of the fee.
- Subd. 5. Equivalent Fee Requirement. ### ORDINANCE NO. 2019-11

AN ORDINANCE IMPLEMENTING AN ELECTRIC SERVICE FRANCHISE FEE ON WRIGHT-HENNEPIN COOPERATIVE ELECTRIC ASSOCIATION, A MINNESOTA CORPORATION, ITS SUCCESSORS AND ASSIGNS, FOR PROVIDING ELECTRIC SERVICE WITHIN THE CITY OF MONTROSE.

### THE CITY COUNCIL OF THE CITY OF MONTROSE DOES ORDAIN:

**SECTION 1**. The City of Montrose Municipal Code is hereby amended to include reference to the following Special Ordinance.

- 1. <u>Purpose</u>. The Montrose City Council has determined that it is in the best interest of the City to impose a franchise fee on those public utility companies that provide electric services within the City of Montrose.
  - (a) Pursuant to City Ordinance 2012-04, a Franchise Agreement between the City of Montrose and Wright-Hennepin Cooperative Electric Association, a Minnesota corporation, its successors and assigns, the City has the right to impose a franchise fee on Wright-Hennepin Cooperative Electric Association, a Minnesota corporation, its successors and assigns, in an amount and fee design as set forth in the fee schedule attached hereto as <u>Schedule A</u>.
- 2. <u>Terms</u>. A franchise fee is hereby imposed on Wright-Hennepin Cooperative Electric Association, a Minnesota Corporation, its successors and assigns, under its electric franchise in accordance with the schedule attached here to and made a part of this Ordinance, commencing with the Wright-Hennepin Cooperative Electric Association January 1, 2020 billing month.

The fee shall be in lieu of any permit or other fees being imposed on Company. This fee is an account-based fee on each premise and not a meter-based fee. In the event that an entity covered by this ordinance has more than one meter at a single premise, but only one account, only one fee shall be assessed to that account. If a premise has two or more meters being billed at different rates, the Company may have an account for each rate classification, which will result in more than one franchise fee assessment for electric service to that premise. If the Company combines the rate classifications into a single account, the franchise fee assessed to the account will be the largest franchise fee applicable to a single rate classification for energy delivered to that premise. In the event any entities covered by this ordinance have more than one premise, each premise (address) shall be subject to the appropriate fee. In the event a question arises as to the proper fee amount for any premise, the Company's manner of billing for energy used at all similar premises in the city will control.

3. Payment. The franchise fee shall be payable quarterly and shall be based on the amount collected by Company during complete billing months during the period for which payment is to be made. The payment shall be due the last business day of the month following the period for which the payment is made. The franchise fee may be changed by ordinance from time to time; however, each change shall meet the same notice requirements and not occur more often than annually and no change shall require a collection from any customer for electric service in excess of the amounts specifically permitted by the attached fee schedule. The time and manner of collecting the franchise fee may be subject to the approval of the Commission. No franchise fee shall be payable by Company if Company is unable to first collect an amount equal to the franchise fee from its customers in each applicable class of customers by imposing a surcharge in Company's applicable rates for electric service. Company may pay the City the fee based upon the surcharge billed subject

to subsequent reductions to account for uncollectibles, refunds and correction of erroneous billings. Company agrees to make its records available for inspection by the City at reasonable times provided that the City and its designated representative agree in writing not to disclose any information which would indicate the amount paid by any identifiable customer or customers or any other information regarding identified customers.

- 4. <u>Surcharge</u>. The City recognizes that the Minnesota Public Utilities Commission may allow Company to add a surcharge to customer rates of city residents to reimburse Company for the cost of the fee.
- 5. Equivalent Fee Requirement. This ordinance shall not be effective against Company unless it lawfully imposes and the City monthly or more often collects a fee or tax of the same or greater equivalent amount on the receipts from sales of energy within the City by any other energy supplier, provided that, as to such a supplier, the City has the authority to require a franchise fee or to impose a tax. The "same or greater equivalent amount" shall be measured, if practicable, by comparing amounts collected as a franchise fee from each similar customer, or by comparing, as to similar customers the percentage of the annual bill represented by the amount collected for franchise fee purposes. The franchise fee or tax shall be applicable to energy sales for any energy use related to heating, cooling or lighting, or to run machinery and appliances, but shall not apply to energy sales for the purpose of providing fuel for vehicles. If the Company specifically consents in writing to a franchise or separate ordinance collecting or failing to collect a fee from another energy supplier in contravention of this section, the foregoing conditions will be waived to the extent of such written consent.
- **6.** Enforcement. Any dispute, including enforcement of a default regarding this ordinance will be resolved in accordance with Section 2.5 of the Franchise Agreement.
- 7. Effective Date of Franchise Fee. The effective date of this Ordinance shall be after its publication and ninety (90) days after the sending of written notice enclosing a copy of this adopted Ordinance to Wright-Hennepin Cooperative Electric Association by certified mail. Collection of the fee shall commence as provided above.

Muni Pumping – Dem	\$ 0

Franchise fees are submitted to the City on a quarterly basis as follows:

January – March collections due by April 30.

April – June collections due by July 31.

July – September collections due by October 31.

October - December collections due by January 31.
