Announcements on City-Related Issues and Concerns

Commissioner Kulick announced that a run water notice has been put into effect for a selected and notified group of residents and businesses.

Commissioner Sous announced that sidewalk shoveling policy states commercial businesses are required to clear snow within 24 hours and residential houses are encouraged to clear sidewalks to be neighborly. He would like staff to look into enforcing commercial businesses' compliance. Commissioner Sous also announced that he will be giving a presentation on the Dog Park at the MML Conference and encourages other Commissioners to attend the Conference.

Commissioner Joslin questioned the increased cost of snow removal along school routes.

Commissioner Ling reminded citizens to attend the open house for Parks and Recreation Master Plan being held Tuesday, February 24, 2015 from 2:30 – 4:30 and 6:30 – 8:30. There is also an on-line survey you can fill out now through March 10 at mt-pleasant.org/parksmasterplan. Commissioner Ling also encouraged Commissioners to give any Charter amendment ideas to the Charter Committee.
