SUBJECT: Contract for Assessing Services

The City of Mt Pleasant has utilized statutorily required assessing services via contract for many years. Ruth Scott, of Sunrise Assessing Services, has most recently provided those services to the City of Mt Pleasant beginning in June 2021.

Following a review of contracted assessing services in other municipalities, the average rate of per parcel fees within the State of Michigan, and the ability to keep the services with an entity that this familiar with the area and enterprise within the City of Mt Pleasant, as well as the current Michigan Tax Tribunal cases, the recommendation is to continue with Sunrise Assessing Services. Sunrise has provided a new proposed five-year contract in which to continue the statutorily provided assessing services to the City of Mt Pleasant. The contract is for the sum of \$102,900 for the first year with annual fee increases of 3% up to the Consumer Price Index limited to 6% for the four subsequent years.

SUBJECT: Mission Street Corridor Plan: Steering Committee

As discussed at the February 26, 2024 City Commission meeting, the City hired Progressive AE as the planning consultants who will be facilitating the development of a Mission Street Corridor Plan throughout 2024. This plan aims to develop a future vision and design for the corridor that addresses traffic congestion, pedestrian and bicycle safety, universal accessibility, and enhances access to businesses.

Such plan requires a robust outreach and involvement from the Mt Pleasant Community. Therefore, City staff is convening a Steering Committee – an advisory board, who will provide input and share expertise with the consulting team throughout the project development. The consulting team will be facilitating these meetings and will have city planners and engineers present during the meetings, which will also be open to the general public.

The Mission Street Corridor Plan Steering Committee aims to include the following inviduals who represent a variety of stakeholders in the community. The Steering Committee composition was identified by City staff, and the Planning Commissioners, DDA members and business owners were identified and selected during the Planning Commission & Mission-Pickard Downtown Development Authority Joint Meeting, which occurred on March 7, 2024.

Mission Street Corridor Steering Committee Job Description

As a member of the Steering Committee, you will be asked to participate in three meetings throughout the project, which will run through December 2024. You will be asked to advise and make recommendations regarding the Mission Street Corridor Plan and update to the City's Master Plan. Primary activities will include:

- Attending 3 Steering Committee meetings and attending 1 additional community event.
- Contributing to an analysis of existing conditions within the corridor.
- Facilitating partnerships to improve collaboration and share information about the project to support community engagement, for example, helping to share a survey about the corridor with community members.
- Providing insight and advice about where and how to engage key stakeholders within the community.
- Identifying potential pitfalls or issues in engagement efforts, use of language, or other areas that might compromise the integrity of the planning process.
- Vetting consultant recommendations.
- Collaborating with the consulting team, City of Mt. Pleasant, the Michigan Department of Transportation (MDOT), and community stakeholders to integrate efforts to increase the staying power of the engagement process and plan recommendations after the plan update is complete.

First, we will meet as part of a kick-off meeting during which we will walk portions of the corridor and discuss current conditions along with opportunities for enhancing the corridor. We will then meet two more times, approximately every-other month. Each meeting will be about one and a half hours long. During meetings we will review preliminary designs and recommendations and discuss any changes in the community or important updates to the process. We will also discuss results of community engagement efforts.

Once the project is complete, Steering Committee members will have the opportunity to discuss their role and opinions of the process and recommendations during presentations to the City of Mt. Pleasant Downtown Development Authority, Planning Commission, and City Commission.

SUBJECT: 2024 Michigan State Housing Development Authority (MSHDA) MI Neighborhood

Program Grant Application and Authorizing Resolution

MSHDA has launched the MI Neighborhood Program which will provide up to \$60 million dollars in funding to be regionally distributed statewide for housing activities. This new program's application process streamlines access to three main housing activities: rehabilitation, new units, and/or community based public amenities. Staff is intending to apply under the public amenity segment of the program as part of the Town Center Civic Space project.

Highlights of the grant application include:

- \$75,000 (maximum grant request) for the site amenities (benches, tables, lighting and walkways) as part of the Town Center Civic Space project;
- City match for grant will be \$1,138,000, the approved general fund project budget;
- MSHDA MI Neighborhood public amenities are intended to provide public benefit to health, safety,
 or overall quality of life within a community. The primary goal of this component is to identify and
 fund innovative activities to address community or neighborhood needs. All components are
 designed to fund tangible activities that are implementation ready, highly visible, impactful to the
 neighborhood and residents qualify of life, and will benefit the community/region overall.
- No public hearing is needed for this grant.

The pursuit of grants continues to be a resource to help provide additional funds for capital projects and programs to assist our citizens. Staff looks at upcoming projects and analyzes the best funding opportunities for proposed projects and programs.

The application deadline for the first round of applications for the MSHDA MI Neighborhood Program grant is April 15, 2024 and awards will be announced on May 15, 2024.

Staff requests the attached resolution be approved for this grant application.

SUBJECT: Purchase of two (2) 2024 Chevrolet Tahoe Police Pursuit Vehicles

Request:

The City Commission is requested to authorize the purchase of two (2) 2024 Chevrolet Tahoe Police Pursuit Vehicles from Berger Chevrolet Grand Rapids in the amount of \$51,889 per vehicle for a total cost of \$103,778. Berger Chevrolet Grand Rapids is the State of Michigan Contract Holder (MiDEAL) for pricing.

Reason for Purchase:

Two (2) of our current Ford Utility Patrol Vehicles are at the end of their service life for an emergency response vehicle. One of the vehicles has required constant repairs and is out of service more than is available to be used. The other vehicle has been removed from service due to it needing major repairs to the "hybrid" components. The cost of this repair exceeds the value of the vehicle.

For reference, Ford Explorer Police Interceptor Utility Vehicles recognized years of service as 100,000 miles. However, we are finding the latest Ford Explorer Police Interceptor Utility Vehicles have a life expectancy of approximately 80,000 miles before they need extensive or continual repairs or need to be taken out of service all together.

Process:

Several dealerships were contacted to obtain pricing for the Chevrolet Tahoe Police Pursuit Vehicle. Berger Chevrolet was the only dealership that had inventory available. In addition, Chevrolet Dealerships typically will not provide counter bids due to Berger Chevrolet being the State Contract Holder.

Budget Amendment:

The purchase of two (2) police vehicles in the amount of \$95,620 is budgeted for 2024. I am requesting a budget amendment of \$8,158 to allow for the purchase of two (2) 2024 Chevrolet Tahoe Police Pursuit Vehicles.

Recommendation:

The City Commission is requested to authorize the purchase of two (2) 2024 Chevrolet Tahoe Police Pursuit Vehicles from Berger Chevrolet for \$103,778 as well as authorize a budget amendment of \$8,158 for the purchase of the same.
