### 2023 Mt. Pleasant Farmers' Market Community Organization/Non-Profit Guidelines

The Mt. Pleasant Farmers' Market will offer a limited number of Community Organization/Non-Profit booths for free each week at the Market. Local non-profits, community organizations and health and human service agencies are encouraged to apply for these booths. The Mt. Pleasant Farmers' Market reserves the right to approve only Community Organizations/Non-Profits, whose mission/purpose is compatible with the mission/goals of the Mt. Pleasant Farmers' Market, to occupy a booth for free to promote that Community Organization's/Non-Profit's mission and projects. In order to be eligible for a Community Organization/Non-Profit booth at the Mt. Pleasant Farmers' Market, Community Organizations/Non-Profits must serve the residents of the City of Mt. Pleasant.

Community Organizations/Non-Profits may not interfere with the orderly operation of the Market, must adhere to all Mt. Pleasant Farmers' Market COVID-19 pandemic protocols, and may not offer for sale any products that compete with those sold by a paying vendor. Community Organization/Non-Profit booths soliciting items competing with established vendors are not eligible for a free booth. Community Organization/Non-Profit booths soliciting items competing with established vendors may purchase booth space at the City Resident Rate.

Community Organization/Non-Profit booths must offer educational materials and information about programs and/or activities that apply to residents of the City of Mt. Pleasant and must not solicit donations or payments of any sort, without prior approval from the Market Manager.

A Community Organization/Non-Profit is strictly prohibited from promoting any political party or slate of candidates, and from passing out political flyers or information. Community Organizations/Non-Profits shall refrain from promoting a particular religious cause or affiliation.

A limited number of Community Organization/Non-Profit booths will be permitted each week at the Mt. Pleasant Farmers' Market and each Community Organization/Non-Profit will be permitted to occupy only one booth and one time per month. Requests will be granted on a first-come, first served basis.
