FUNDING OPPORTUNITY FOR LIFTS PROGRAM

The Linking Iowa Freight Transportation (LIFTS) program is a \$1.3 million grant funding opportunity to improve Iowa's multimodal freight transportation system. The purpose of the LIFTS program is to provide grants for projects that help meet the changing demands on Iowa's multimodal freight system. The program will provide funding for freight projects that have economic and public benefit by enhancing the shipment of freight, but are typically ineligible for state or federal highway funding. The funding program is designed to: (1) Enhance economic development by improving the multimodal freight transportation system. (2) Provide flexible funding for the changing demands of the freight transportation system. (3) Enhance the ability to provide competitive transportation options for shipment of products and moving goods. (4) Provide incentives to alternate modes for economic development opportunities.

The LIFTS Program is open to transportation providers/users, cities, counties, planning organizations and any other entity interested in freight transportation. The program requires that projects funded by the LIFTS Program be carried out under the same rules and procedures as a highway project on a federal-aid highway.

Applicants will fall under one of two categories. (1) Public applicants or public-private partnerships which will be eligible for 80% grant funding. (2) Private applicants which will be eligible for 50% grant funding.

Applications will go through a review/scoring process and a recommendation will be presented to the Iowa DOT Commission for approval with final awards expected in May 2019. All applicants must submit a Minority Impact Statement along with their application. Applications must be postmarked or emailed by 5:00 p.m. on December 10, 2018.

COMMUNITY CATALYST BUILDING REMEDIATION

Through the Community Catalyst Building Remediation Program, the Iowa Economic Development Authority will provide grants to communities for the redevelopment, rehabilitation or deconstruction of buildings to stimulate economic growth or reinvestment in the community. Strong applications will show the potential of catalytic economic growth in the community; improve appearances & safety; make use of underutilized property, exhibit appropriate design standards; and be well-funded. Economic growth may include the creation of additional jobs, growth of new or existing businesses, development of new housing units, increase property values, or potential population growth.

Funding:

- \$1.8 million available, with \$1.2 million of that going to towns of less than 1,500 people
- Maximum grant: \$100,000

Eligibility:

- Funds available for the rehabilitation of one commercial building per community or two buildings with same ownership that are adjacent
- Deconstruction is allowed in dire situations or for safety reasons
- City must be the applicant and provide financial and/or in-kind resources

The required pre-application is fairly simple and just lays out the concept and goals of the project. It is due November 14th. Once invited for a full application, it is due December 14th. If you submit a pre-application before the deadline, your invitation for a full application is likely to be sooner, thereby giving you more time to prepare and submit a full application. U.S. DEPT. OF TRANSPORTATION ANNOUNCES \$366.2 MILLION



U.S. Transportation Secretary Elaine L. Chao announced that the Federal Transit Administration (FTA) will award \$366.2 million

in grants to improve the safety and reliability of America's bus systems and enhance mobility for transit riders. A total of 107 projects in 50 states and territories will receive funding from FTA's Buses and Bus Facilities Infrastructure Investment Program

"These grants will help rebuild and modernize bus systems across the country for greater safety," said Secretary Chao.

The funding supports projects to replace, rehabilitate, and purchase buses and related equipment, as well as projects to purchase, rehabilitate, and construct bus-related facilities

"Bus transportation is the most widely available form of public transportation across the country," said FTA Acting Administrator K. Jane Williams. "These grants are a significant step in achieving the Administration's goal of rebuilding our nation's transportation infrastructure."

Among the projects selected to receive funding locally:

- Region 2 Transit System will receive \$658,300.00 to replace eight older buses
- Mason City Transit will receive \$284,235.00 to replace three older buses.

Demand for FTA's Buses and Bus Facilities Infrastructure Investment Program far exceeded available funds, as FTA received applications for 339 eligi

ble projects totaling approximately \$2 billion in funding requests, from a total of 255 applicants. Project proposals were evaluated based on criteria outlined in the Notice of Funding Opportunity. The selected projects will receive fiscal year 2018 funds.

Federal public transportation law (49 USC § 5339(b)), as amended by the Fixing America's Surface Transportation (FAST) Act, authorizes FTA's Grants for Buses and Bus Facilities Infrastructure Investment Program through FY2020.

In Fiscal Year 2018, FTA has awarded more than \$15 billion in funding through both formula and competitive grant programs to support public transportation.

NIACOG RECEIVES ICAP GRANT

NIACOG has been notified that their funding request to Iowa Communities Assurance Pool (ICAP) for \$1,000 has been approved for the purchase of security cameras. NIACOG will be replacing all of its outdated analog security cameras with new high resolution 4k digital cameras.

The ICAP Grant is a special initiative in celebration of ICAP's 30th Anniversary and provides up to \$1,000 towards the purchase of select loss control or risk management items.

NIACOG is extremely appreciative of ICAP's grant award and looks forward to its continued relationship with ICAP as its property and casualty coverage provider.
