NEWS FROM THE DIRECTORS

<u>Annual Board Meeting</u> - The IIMC Board of Directors met on May 6 and 7, 2011, immediately prior to the IIMC Conference. The first day consisted of board development, followed by the board's regular meeting.

The board development session was facilitated by Lance Decker and the focus was on volunteers. How do we get more IIMC members to volunteer to serve on committees, and how do we keep them engaged? The day focused on many ideas which will encourage members to help IIMC by serving on a committee.

2011 IIMC Conference - The 2011 IIMC Conference, held in Nashville, Tennessee, was wonderful! If you were unable to attend, you missed a grand conference. The most exciting part of the conference was when our very own Region IX member, Colleen Nicol, was installed as IIMC President! Way to go Colleen!

<u>IIMC Conference Education Handouts</u> - With the Board's approval to go green, IIMC Conference handouts for 2011 were posted on the website, and a DVD of the concurrent education session handouts was distributed to all conference delegates. It is anticipated that this practice will continue.

<u>Education Update</u> - The Education Department continues to distribute E-briefings, specifically announcing education programs, information and news. The IIMC Education Department has added to the online learning opportunities with ed2go. Courses completed through ed2go will earn 1 CMC Experience-Continuing Education point per 6 hours, or 1 MMC Advanced Education point per 6 hours. Each course is approximately 24 hours long; and there are 17 courses currently approved for credit. At less than \$100 each, this is a great way to earn points.

The ed2go network consists of more than 1,800 top colleges, universities, and other organizations. Each ed2go course can be taken from home or the office, as they are taken completely online over 24 hours in a 6-week period. There is a variety of courses ranging from accounting to grant writing to project management and more. Each of the courses is lead by a well-qualified instructor, and is priced under \$100. Once enrolled, students will be able to engage with their classmates, post questions and comments, and take quizzes that are automatically graded upon completion. Upon successful completion of the course assessment, a certificate will be awarded.

<u>Constitutional Amendments</u> - On June 10, 2011, an official ballot was emailed to IIMC members regarding the Amendment to IIMC's Constitution. The amendments were presented at the Annual Business Meeting in Nashville on Thursday, May 12, 2011. The Amendment was passed by two thirds of the members present. Per Article XIII of IIMC's Constitution, the amendment must be distributed to the entire voting membership to vote. The last day to vote will be Wednesday, August 10, 2011. If you have not already voted, please vote today!

Budget and Planning - Highlights of the IIMC finance picture for 2011-12 include: IIMC ended the 2010 fiscal year with an outstanding net profit of \$187,215. This is the fourth consecutive year that IIMC has realized a year-end profit; A general reserve fund of approximately \$230,000 has been established and untouched; A building reserve fund of \$20,000 has been funded; 2010 was the third consecutive year in which membership dues exceeded \$1 million; Created an emergency 2011 conference reserve; Implemented a policy that IIMC Conferences must meet a 10% net profit of revenue; A membership dues increase of \$10 per municipality was implemented in 2011; Board meetings and Executive Committee travel are under projected budgets; Both tenants at IIMC headquarters are secured through April 2013 and 2014, respectively; Monthly Financial and Year-End Statements are shared with the IIMC Board; New fiscal policies and procedures are being adhered to by the Executive Committee and the IIMC Board of Directors; New recommended Board Policies that will ensure fiscal reliability for IIMC and improve the financial processes include the allocation of travel funds and establishing future conference reserves. IIMC has come a long way over the past few years in its goal of achieving financial stability.

<u>Municipal Clerks Education Foundation</u> - We continue to encourage you to make a donation to the Municipal Clerks Education Foundation (MCEF). One way to support MCEF is by buying raffle tickets for the annual MCEF Hawaii Raffle sponsored by American Legal Publishing. This year the raffle was won by Amanda Charles, Deputy Clerk of Wasilla, Alaska! MCEF is supported through donations and every contribution, regardless of size, is destined to support education. Tax-deductible contributions may be made by completing the pledge card on the IIMC website. Credit card payments are accepted, and pledges can be paid monthly or at the end of the calendar year. MCEF's tax ID number is 95-3926604.

<u>Travel Plans</u> - In September, we will attend the Oregon Association of Municipal Recorders (OAMR) Conference in Portland September 21 - 23. Then, we're heading north to Alaska to attend the Alaska Association of Municipal Clerks (AAMC) Conference, November 5-8 in Fairbanks. And from Fairbanks, we will head directly to the IIMC Mid-Year board meeting in Riverside California, November 10 - 12.

Speaking of travel, did you know that the Region IX states has a travel policy in place that creates an assessment of \$4 per member to fund Region IX Director travel costs? This funding allows both Region IX Directors to travel to each of the four state annual conferences. Region IX has found this to be an invaluable means of establishing a strong regional voice and creating a partnership among the states to allow every member access to their IIMC representatives.

WASHINGTON—WMCA President Treva Percival, CMC, Reports...



CITY OF NORTH POLE RESOLUTION 11-18

RESOLUTION TO PLACE AN INITIATIVE ON THE OCTOBER 4, 2011 CITY OF NORTH POLE BALLOT AUTHORIZING THE CITY TO INCUR \$1,416,500 OF DEBT IN THE FORM OF A LOW-INTEREST ALASKA DEPARTMENT OF ENVIRONMENTAL CONSERVATION LOAN FOR THE PURPOSE OF REDUCING INFLOW AND INFILTRATION OF GROUND WATER INTO THE WASTE WATER COLLECTION SYSTEM

WHEREAS, the City of North Pole created its utility system to provide residents with the sanitation, protection and convenience afforded by a municipal utility system and to promote an improved community environment; and

WHEREAS, a portion of the waste water collection system contains over 7,000 feet of Techite sewer mains, a material that is prone to failure resulting inflow and infiltration of ground water and blocked sewer mains; and

WHEREAS, numerous sewer manholes in the waste water collection system are experiencing inflow and infiltration of groundwater; and

WHEREAS, approximately one third of all waste water delivered to the waste water treatment plant is ground water that enters through inflow and infiltration through damaged sewer lines and manholes; and

WHEREAS, the large volume of inflow and infiltration reduces the efficiency and capacity of the waste water treatment plant leading to increased treatment costs; and

WHEREAS, the large volume of inflow and infiltration to the waste water treatment plant restricts expansion of the utility system which in turn restricts future development of the City.

WHEREAS, damaged sewer mains represent public health and environmental threats that could permit the discharge of untreated domestic waste water into surface and groundwater sources where lining the sewer mains will mitigate these hazards; and

WHEREAS, the Utility has existing capital charges levied on all utility rate payers that generate sufficient revenues to repay the loan over its 20-year life without the need to raise utility rates or tax revenues.

NOW, THEREFORE, BE IT RESOLVED that the North Pole City Council approves that the following question shall be placed on the October 4, 2011 ballot as follows:

The North Pole Utility is requesting authority to accept a \$1,416,500 loan offer from the Alaska Department of Environmental Conservation for the purpose of repairing leaking sewer mains and manholes. Approximately one third of all the water flowing to the waste water treatment plant is ground water that leaks into sewer mains and man holes. The loan will be for a period of 20 years at an annual interest rate of 1.5%. The loan will be repaid from the existing Facility Repair and Replacement utility charge collected from all utility rate payers. This loan will

not raise property taxes or sales tax for th	his project. The Utility's annual	loan
payment will be approximately \$83,000.

WHEREAS, the citizens of the City need information to make an informed decision related to the ballot initiative; and

WHEREAS, the Utility Department will send informational materials to all residents of the City based upon a mailing list obtained from the Fairbanks North Star Borough; and

WHEREAS, the Utility Department will finance the distribution of informational materials from the Sewer Department's budget accounts Publications and Advertising, 02-12-00-7001; Utility Postage, 02-12-00-7039; and Miscellaneous/Training, 02-12-00-7029.

NOW, THEREFORE, BE IT RESOLVED that the North Pole City Council authorizes the Utility Department to distribute educational materials about the Alaska Department of Environmental Conservation loan offer to the City for the reduction of inflow and infiltration of ground water into the waste water collection system.
