Police Department, Chief Dutra

- Awards ceremony was last week.
- Patrol car was damaged in an accident last week and there was approximately \$8,000 in damages.
- Sgt. Kvitem will be joining the drug unit next week. The department is excited as he did a good job in that position in the past.
- Patrol staffing is at a critical point. Grant positions have requirements and the city signed an agreement to have those position filled. It moves the Lt. to the day shift and there will only be 6 officers on duty. Two officers are in training at the academy and the other is still in FTO training. This will be in effect until August.
- The NPPD will be pulling the detective and putting him back on patrol.
- Compeau's sold one sled and a trailer for the NPPD.
- The Dept. just turned over to Microsoft 365. Email was down for a week but they are up and running now.
- The NPPD received a check in the amount of \$8,700 for the equity sharing in the gold off of the drug bust on CHSR.
- The presentation to Santa's Seniors was a success. Talked with them about the importance of the department.
- NPPD did a presentation for Rotary this past month.

Utility Department

 - Balance in award is \$663,378--working with ADEC to convert this funding to second stage of treatment plant renovations
- Request for Bids will be released March 19 for wireless communication connection between well house and water treatment plant
 - This is our trial project to test if City-owned wireless network can replace commercial land line connections between utility infrastructure

Natural Gas Utility Board

- No updates since previous Council meeting
- Front page article in Monday, March 18, 2013 *Daily News Miner* related to Interior Gas Utility

Mr. McGhee asked what the product was that DOT uses to take the ice off of the Parks Highway. He would like Mr. Butler to look into it to see if they can do something in the City and on the highway to EAFB.

Ms. Hunter gave her concerns on NPHS Blvd and the dangers of that street. She also asked if PW would be able to use peonies in the round abouts.

City Accountant, Lisa Vaughn

Ms. Vaughn informed council that they had the February financial statement. She asked them to note that due to audit work, she had not had any time to do reconciliations, including the bank reconciliation for February.

Ms. Vaughn stated that the auditors were here last week and they will start writing the audit report this week. She is hoping to get their audit entries early next week so there will be some changes to the overall financial statement.

Currently, the December financial statement shows Revenues in the General Fund have exceeded budget revenues by \$14,843.42. This is a bit misleading. The state of Alaska, pays a portion of the PERS unfunded liability on our behalf. Because of this, we have to book as revenue, that amount under PERS Relief, along with booking the expense as well (in each department as part of the PERS expense.) General Fund revenues were actually under budget by \$238,919. Expenses, at the department level, for all departments with payroll, show that the PERS expense is much higher than budgeted as well. This is booked into the General Fund, Utility Fund, and the AHSO and Jag grant funds. Note: that in the general fund, Police, Fire and Public Works show that they went over budget by a small amount, this is due to booking the PERS relief monies.

Currently, the financial statement shows that the City has expenses over revenues of a little over \$79,000. Of this amount, \$35,000 were monies that the council voted on for the Arctic Winter Games and the Sled Dog Championships. This may go up or down, depending on any audit adjustments.

Borough Representative

- Mayor Ward stated that there wasn't anything on the agenda that affected the City of North Pole.

City Clerk

- Auditors were here this past week and I spoke briefly with them. They looked at various personnel files and did a brief interview.
- March 6, 2013 we had a group of seniors that came over and had a tour of City Hall, the Police Department, and Fire Department. We gave them power point presentations and toured each of the facilities. The seniors will be getting a tour of the public works and utility buildings in April
- On Monday, March 11, 2013 I swore in the new board for the North Pole Library Foundation.
- The city health plan comes up for renewal again in July. I will be working closely with Dianna Stewart from Alaska USA Insurance Brokers to bring you a competitive package. The life insurance package will renew next year.

ONGOING PROJECTS

- Start up – Sharron Hunter

Ms. Hunter reported on the Start-Up program that she attended last weekend. She was able to pitch her idea on a non-profit organization that was comparable to Festival Fairbanks. Ms. Hunter recalled other entrepreneurs that also attended and pitched their ideas.

CITIZENS COMMENTS – 5 Minutes

Mike Starkey – Troop #49

Mr. Starkey stated that the roads are treacherous and that DOT needs to get on it and get the roads fixed. HE said that Troop #49 is working on Citizenship and Community Merit badge. He has a copy of agenda and will be here for the next meeting. He would be encouraging the Scouts to contact the council members for any questions they have on the meeting.

North Pole Community Chamber of Commerce, Bridget Lawson & Rob Scheckhise

Ms Lawson commented that the Calcium Chloride helps with temperatures above -25 and has done a science fair project on that subject.

The NPCCC announced that they would be holding the event “Christmas in July” from July 26, 27, and 28. This is an additional event to the July 4th celebration. She reiterated that this would not replace the July 4th celebration. Ms. Lawson said there are some great vendors and a dance on Saturday night. There will also be a balloon release and on Sunday a Santa Claus costume contest.

Re: Legal Review of NPMC

Over the years the council and myself have wanted to go over our NPMC to find discrepancies or to make sure that things are legal and within our right to govern. I have asked Code Book Publishing to an estimate. They have come back with the following:

The legal review applies principles of statutory construction and applicable common law for every state. The review will encompass state and federal constitutional questions, case law conflicts, and court interpretations. The code will be scrutinized for vagueness, fair notice to citizens, free speech infringement, danger of selective enforcement, and equal protection in view of fundamental rights. The attorney will review all sections of the code for consistency, archaic language, and internal conflicts, as well as to ensure accurate references to state statutes. The review also identifies conflicting, duplicative or out of date fees fines, and penalty provisions. The City of North Pole will receive a detailed written report, including a thorough analysis and basis for amending or revising ordinances as necessary.

The cost to the City of North Pole will be \$2,500.

The University of Alaska has led the way for research on unmanned aircraft systems (UAS) and continues this pioneering work in its bid to become one of the nation's six test sites for aircraft systems testing and research. The Resolution recognizes this substantial effort. More significantly, it establishes a legislative Task Force to address potential impacts and opportunities of unmanned aircraft systems for our state.

Alaska's immense land mass and associated airspace presents opportunities no other state can offer for testing and flight training. Vast existing Military Operations Areas and expansive ground maneuver areas can easily support virtually all military applications for current and future UAS technology, and military UAS infrastructure can only complement civilian and commercial applications.

As with any new technology, a myriad of concerns must be addressed before unmanned aircraft become a common fixture in our National airspace. This resolution takes the necessary step to begin addressing those concerns to insure Alaska leads the way for this transformative and dynamic flight environment.

I explained the situation to him and also told him if they find out there is a leak that has not gone down the sewer we will need to verify it so we will be able to wave the sewer charge on this billing.

On Monday, Hollis contacted me and told me there was no leak. I suggested to him that we could do a profile on the meter and would be able to show him what occurred with the leak hour by hour.

During the next few days we had 2 of our utility personnel over to this residence for the profile and to inspect the condition of the meter. They did not see any evidence of water on the ground or a sink hole.

It is approximately \$3200.00.

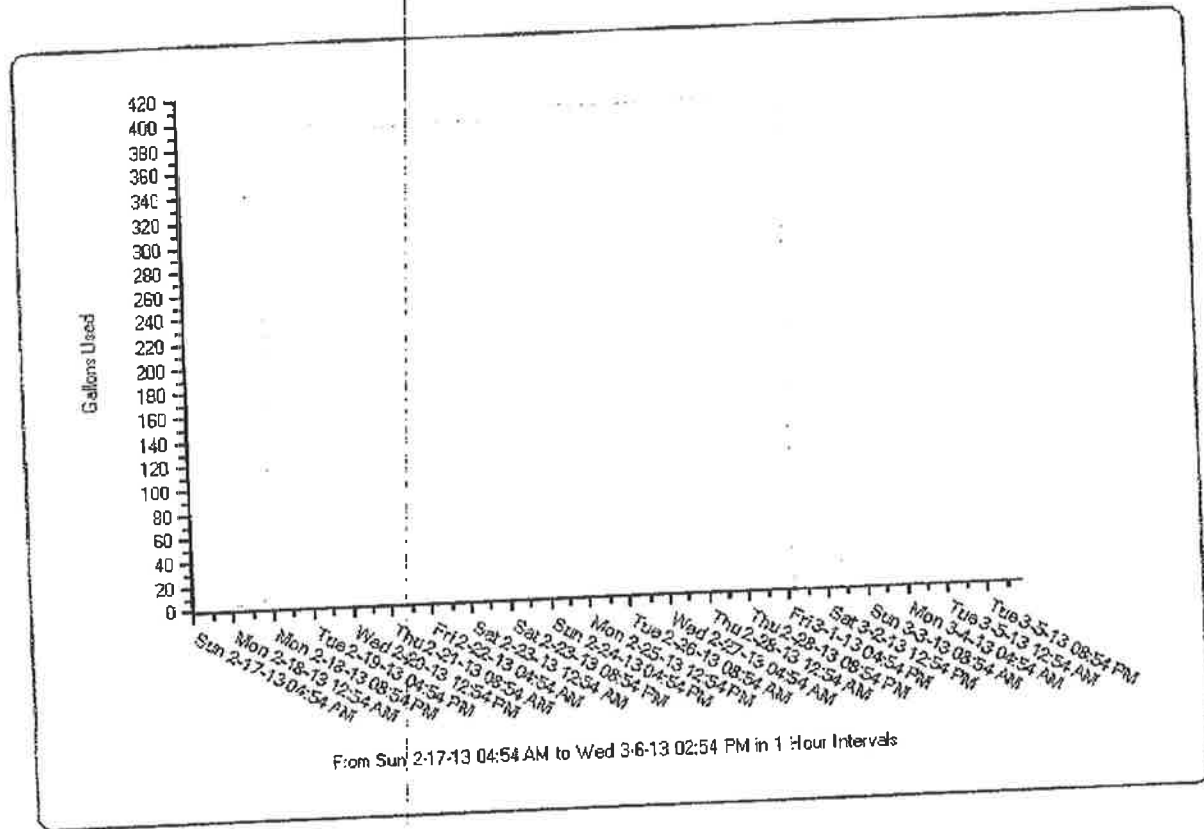
I was hope to get this reduce to the 12 month average of

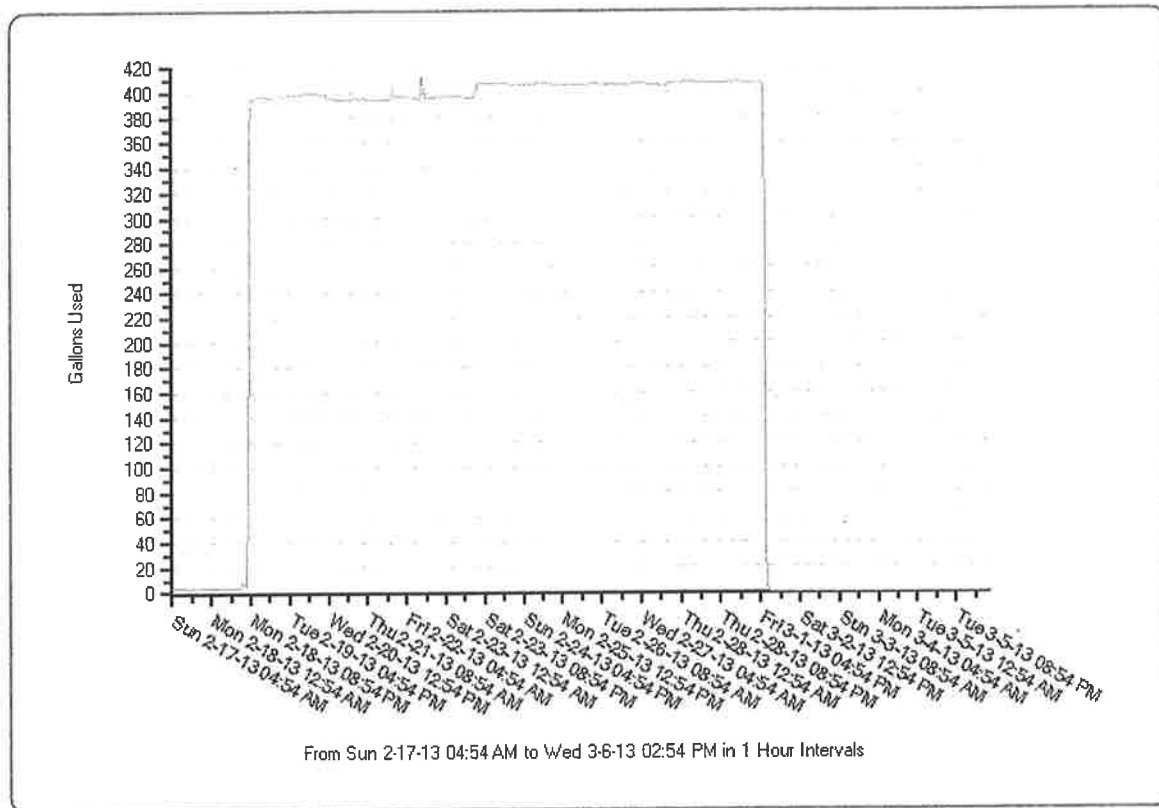
