COMMUNICATIONS FROM THE MAYOR

We are seeking donations for the Trooper Park. If you are interested in donating your time or resources please talk to me or Chief Dutra with the Police Dept. We had a great contractor meeting today and look forward to starting work when the road weight restrictions are lifted.

The 4th of July festival "A Patriots Christmas" is only 3 short weeks away. If you are interested please contact me or Katy Englund for details. Flint Hills Resources has graciously agreed to come on as title sponsor again this year, Thank YOU! The next meeting will be here at City Hall tomorrow evening at 6:15pm.

The ground breaking ceremony was a great success on the 5th. Governor Walker was present in North Pole for the fusing of the pipe and a short speech on this momentous event.

I was able to attend the change of command for Col. Snelson at FT. Wainwright last Friday. Col Snelson was in charge of the air brigade and is responsible for my introduction to golf. He was a great leader here in the Interior and is planning on staying because he loves it so much here.

I was also able to attend the ribbon cutting for the Tanana Trails housing project. This project was over 10 years in the making at it was great to tour the new buildings. It was interesting to see the change in the terrain from 15 years ago when me and my buddies used to play there.

The State announced last week that they are not going to make a determination on the cleanup level for sulfolane for 2 years citing the need for the results of the NTP study that will be completed in 2017. Not having a cleanup standard poses a significant challenge for the City and for the responsible parties to determine what needs to be done achieve a reasonable cleanup plan.

The Audit should be completed on Wednesday of this week. Staff met with the auditors last week and it was clear it would not be ready for this meeting. We have scheduled a special meeting for Monday June 29th at 6:00 p.m. for the presentation of the audit, per our charter. This year even with significant economic challenges we still managed to keep our expenditures under budget and our revenues came in over expected.

COUNCIL MEMBER QUESTIONS OF THE MAYOR

Ms. Hunter asked where the Tanana Trails housing was located. She also asked about the Amazing Race during the July 4^{th} celebration.

Presentation by Water & Soil Conservation on Elodea

Joni Scharienberg stated that they had worked with the City of North Pole for over ten years, along with federal, state agencies and legislators on Chena Slough to improve water flow. In 2010 an aquatic invasive was discovered and work has shifted over to trying to eliminate the invasive. She introduced Adidi Shanov, the invasive weed specialist who gave a presentation on the work they have done so far. Adidi explained what Elodea was and how it was introduced to the interior. It was discovered in Chena Slough in 2010 and in 2011 it was found in the Chena Lakes Recreation area. She said that it's been found in Badger Slough, Chena Lakes and in some sections of the Chena River. Once it's established in the water body it can convert a gravel bed and increase sedimentation and alters the environment that salmon and grayling need for spawning and rearing. It will have huge impacts on commercial and sport fisheries, will create problems for recreation and reduce waterfront property values. The biggest problem with Elodea is that it reproduces and spreads easily across the state. The infestation in the slough is the most difficult in the state to get rid of because it's in moving water. It's a high priority because it can easily bleed into the Chena River and infest bodies of water along the Tanana and Yukon so a lot of salmon habitat could be lost if Elodea moves from the slough throughout the water sheds. The management goal is to eradicate Elodea in these interior water bodies and to prevent spreading. She described the various methods they've used to try to eradicate. They are currently applying for permits to use fluridone in the Chena Slough and Chena Lakes because Elodea is very dense in those areas. There is a lot of permitting required with the DEC and DNR. It will be a very expensive project in the region of \$700,000 for the three to four year treatment plan. There are a lot of pieces that need to fall into place for the plan to be successful. There will be a community information session in the chambers on Thursday. She answered questions of the council.

OLD BUSINESS

Ordinance 15-07, An Ordinance of the City Of North Pole, Alaska to amend Title 2, Personnel System, Chapter 36, Section.480 Insurance and Disability Benefits

Mayor Ward stated that this ordinance changes the contribution amount for employees from \$0 to \$45 per month and for dependents to go from \$100 per month to \$175 per month. This works out to be approximately \$101 per month for a family.

Public Comment

Steve Dutra – 125 Snowman Lane

Mr. Dutra finished his presentation that he didn't get to finish at the last meeting. He felt that the contribution would be a significant impact to some of the employees' wages. He felt that with the healthcare renewal coming in the middle of the year that it doesn't let the Department Heads come up with budgetary fixes. He felt there could have been other alternative to consider.

Mr. Smith asked if we are asking the right questions to the broker for what we need for the employees. He asked if the NPPD could put together a wellness program for the officers.

Ms. Holm asked if he could give his presentation to Agnew:Beck.

Mr. Welch asked how many employees the NPPD had hired this past year and what their expectations would be toward paying for their benefits. He asked Chief Dutra what would be fair for his employees.

Mr. McGhee said that every year he puts forth raising the sales tax and he doesn't have the support of the employees. He said the surplus he was proposing at the last budget session was shot down. The council needs the support of the employees at the budget session. He said we need to be proactive and the cost of doing business is going up for everyone.

Ms. Hunter asked if these were voted down would there be things that department heads would be able to do to decrease their budgets.

Mayor Ward asked if Chief Dutra thought 5% of the cost of healthcare was unreasonable.

Chief Dutra said he is speaking for the people at the lower end of the pay scale and that it is a lot of money.

Mayor Ward asked if he knew that 81% of the NPPD budget was personnel.

Mr. Welch asked if Chief Dutra was aware of the fact that this was going up from \$100 to \$120 before this was released.

Mr. McGhee said he was concerned about what Chief Dutra meant by cutting services and if it would be wiser to raise sales tax to pay for those services.

Chief Dutra did not want to be put on the spot. He stated that they had already cut a position. They represent the citizens and it's about what services they wish to have.

Mr. McGhee asked if it would not be wiser to increase the sales tax for people who are using services to start with and if he has Chief Dutra's support on that.

Mr. McGhee *moved to* Adopt Ordinance 15-07, an Ordinance of the City of North Pole, Alaska to amend Title 2, Personnel System, Chapter 36, Section.480 Insurance and Disability Benefits

Seconded by Mr. Welch

Discussion

Mr. McGhee said he supports Chief Dutra in what he wants for costs. He hopes to see the sales tax raised to help see these services kept. He asked to move this forward and hopefully in the budget session they can find a way to readjust it.

Mr. Welch said he has talked with other employees and department heads and said that they have said they had expected lower pay because they had better benefits. He's heard the chief and employees loud and clear regarding a more than \$2 an hour decrease towards the insurance.

Mr. Welch *move to* amend line 33 amend to employees shall pay a \$25 monthly premium and \$150 for dependent coverage

Seconded by Mr. McCarthy

Discussion

Mr. Welch stated that what that means is approximately a 3% towards the overall premium. We are our employees employer. We represent new employees. In all fairness this is doable and that in next years' budget it will probably go up because costs are going up.

Mr. Smith commented on the free ambulance fee for the residents and the changes over the years. Because of an error in the code residents now pay a higher ambulance fee. Is this a similar situation?

Mr. McCarthy stated that he is in favor of the amendment.

Ms. Hunter asked if there was an option of offering a percentage of salary as opposed to a flat rate.

Ms. Holm said that the average employee makes about \$60,000 a year. She has a good feeling that with getting Agnew:Beck on board that they can help reorganize and restructure the city. She's really excited about the future of North Pole. Hopefully the increase can be reduced by next June.

Mr. McGhee asked how this amendment will affect the budget.

Mr. Smith asked about increasing the deductible.

City Clerk Kathy Weber said the city did increase the deductible from \$300 to \$375.

Ms. Hunter said she is in favor of the amendment and using the approach of Ms. Holm in reverse and if we have to increase it next year we have more time. The best solution goes with Councilman McGhee on the proposal for sales tax and hopes the council will consider that. They need the support of the residents and the council is the body that needs to look at this and keep a balance with the services that the City needs to provide.

Mr. Smith asked if the City could put together a wellness program and capitalize on these gains.

Mayor Ward said he has run some of the numbers and he is not in support of this. He stated that they have to look at how they manage the City in an effective way and provide benefits to all employees. With the numbers the employee would be paying \$46.15 per pay period for health care. With the changes as presented it would increase to \$101.54 per pay period and with the changes proposed by Mr. Welch it would be \$68.09 per pay period increase. The reason why we brought this forward is because they've lost \$200,000 property tax revenue and had a double digit increase in health insurance. 80% of costs are wages and when it comes out of operational costs it affects the employees and services provided and it is not in the best interest of the City and in looking after the wellbeing of our employees. The 5% is in the best interest of the city. Reducing the amount that employees contribute will create a wider gap in the budget and where they are going to find that money. To find 30,000 - 40,000 in a budget is a difficult thing to do. The only place that is left to cut is personnel. That is the only way he sees this happening. It is difficult and a challenge. He is not in favor of the amendment.

Mr. Welch said his numbers were based on 30 families and approximately 12 other employees. Instead of \$540 a year it would be \$340 a year so that's \$19,000 instead of \$30,000. Keep in mind that we don't know how much the spousal coverage would be barred in the contract before us.

Ms. Holm said she ran the numbers she came up with different numbers.

Mr. Welch said that it was \$220 per family (\$2640 a year). Under his plan it would be \$2,100 a year out of employee pockets. In the same token looking at an employee without dependents it would be \$300 a year instead of \$540 a year and it brings it to 80% for a family without the amendment and 55% for the employee.

Mr. McGhee said he supports the Mayor on this and if we support this amendment we need to look at cutting services. We need to look at our budget for 2016 and support what the mayor has brought forward. Right now is not the time to do this amendment.

In regards to what he means by their support is that this is what it takes to run a city.

Ms. Hunter moved to amend line 33 – shall pay .5% of their monthly salary for healthcare coverage and .5% for dependent coverage.

Seconded by Mr. Welch

Discussion

Ms. Hunter said this will address the Chiefs comments that people that make a larger salary can afford and have a more disposable income and not putting such a big burden on those employees that are making \$20/hr.

Mr. McGhee said he doesn't think this is a fair deal. The cost is the same for a doctor visit no matter who you are. I don't agree that someone who makes more should pay more for the same type of service. The mayor has already set up what the cost of the budget is at this time I think it is something we need to address at the budget session and not over charging people because they have been here longer, they have a higher pay scale and assuming that it's okay for them to pay more. That's not a fair system.

Ms. Holm said her numbers didn't make sense.

Mr. Kestram said this would put us over if it exceeded \$45 and the City would lose their grandfather rights.

Public Comment

Steve Dutra – 125 Snowman Lane

Mr. Dutra said he liked to see all the discussion. He doesn't think the denial of spousal coverage is fair. He said that the \$100,000 for spousal coverage and dependents doesn't make any sense and the 2nd is that what if a person works at a business and that business offers a healthcare plan that's 50% of what we offer and twice as much. Is my wife or spouse now going to be forced to purchase that health insurance because he/she can't be covered under the city? I don't think that is fair. Most of us work here for the benefits for our families and that includes our spouse. I do not object to the deductible changes, I get it, but I don't get this one. We don't even have an accurate number and can't even tell what it is going to save us. I am asking that you pull the spousal additive out of the contract because it's really not fair treatment.

Geoff Coon – 110 Lewis Street

Mr. Coon said he is also affected by this. It is not clear to him and not clear to other employees that this was a mandatory drop of the dependent. This is a small City and 20% or so this will effect should have gotten a phone call letting us know that this IS going to affect us. I know it is in the fine print and all this was put out there but if he didn't get it then they didn't get it. He would like to have it dropped as well and make a comment on and council member who talked about the squeaky wheel. He likes the fact that you the council members are elected for your opinion. Thank you.

Buddy Lane, 110

Mr. Lane echoed chief Dutra and Coon. You will penalize a family because you have a spouse that works outside the home and I don't think that's fair on any level. You are not treating all your employees the same and therefore he encourage you to drop that part off of this. Thanked the council for their work and encouraged them to drop that portion.

Bill Bellant, 125 Snowman Lane

Mr. Bellant said he objected to the removal of the spousal coverage as well. He doesn't see where it will benefit the city. Our children can be double covered and the spouse cannot? It's not fair especially if no one can tell us the benefit.

Chad Rathbun, 125 Snowman Lane

Mr. Rathbun said that this is a guestiment and that it doesn't seem responsible. The other thing that will happen is you are dividing the employees, we stand unified, you are our union, you are our representatives as well as for the city. My wife currently doesn't have insurance so this will not affect me but I would prefer that you not divide us like that way as a city and a group of people.

Tricia Fogarty, 125 Snowman Lane

Mrs. Fogarty encouraged council to drop that part of the contract. If our spouse lost their coverage they wouldn't be able to get health insurance because we can only sign up once a year. So that family member would be without insurance until it was renewal time.

NEW BUSINESS

REQUEST FOR REIMBURSEMENT BY BUDDY LANE FOR DAMAGES SUSTAINED TO PERSONAL ATV WHILE PERFORMING CITY BUSINESS.

Chief Lane gave introduction to this request: During the early morning hours of June 19th somewhere around 3am, we were dispatched to a large column of black smoke coming from somewhere behind the high school. We could see the smoke from the dyke so we knew it was outside the city but we didn't know what was burning or how intense it was burning, if it was spreading...due to the weather conditions he did not want to wait. They contacted Forestry and they had nothing that could respond at the time. So he made the decision that they needed an ATV and also made the decision to grab his personal one because it was the closest one available. We were making our way down the slow at a very slow speed and came across a hole that was deeper than 4.5 feet or so. At that time the ATV rolled over onto its side and disappeared under the water as we escaped out the passenger side of the ATV. The machine was under the water for about 2 hours maybe a little bit longer before we were able to retrieve it and take it to Fairbanks and have the fluids changed and the motor gone through. It was not a joy ride. I would have commandeered another ATV if it had been there or closer. The fire was dangerously close and we wanted to make sure it didn't spread to the Refinery, the High School and other places that were nearby. I felt it was important to go back there and see what was burning. It ended up being a pickup truck that was sitting in the middle of one of the sloughs and was not going anywhere.

Discussion

Mr. Welch – When you went into the water, you said you had to get out on the passenger side? How deep was the water for you?

Chief Lane state that he ended up having to swim to shore.

Ms. Holm – Chief do you have insurance coverage?

Mr. Lane stated that no he did not.

Mr. Smith – Same question as Ms. Holm. He asked how far away was the fire was from where the ATV tipped?

Chief Lane said it was about 500 yards as a crow flies.

Mr. Smith asked if there anyway the Fire Department could have used their cool new ladder truck with the water?

Chief Lane said no.

Mr. McGhee – At first glance I am not in favor of it, as you being the Chief, what would happen if a subordinate did that and you were out of town? Another thought, as a trained fire person, wouldn't you have noticed that the column of smoke hadn't moved in the time it took for you to go to your house and grab your own ATV? The other thing about the commandeering, we do not have the right to do that, we are not in marshal law. Why didn't you think about using the ladder truck to get a higher view? So I am struggling to approve this.

Chief Lane said that if one of his subordinates had done this he would have taken the same action. He people don't sit around in his department. A lot of people in the fire service use their own person stuff because budgets don't allow it. The Police Dept. has an ATV and there was a police officer on duty and at no time did he say that the Fire Dept. could use the ATV. They have asked before and the Police Dept. did not allow it because the Fire Dept. did not have certified training on the apparatus. Chief Lane stated that he had more hours on an ATV than most of the officers that are certified.

Ms. Hunter – How did you end up getting involved? Were you on duty?

Chief Lane said that a police officer saw the column of smoke and called it in and the fire department was dispatched. He is on call 24 hours a day.

Ms. Holm – How many employees assisted you while you were on your ATV with another deputy chief?

Chief Lane said that their engine responded initially and they staged it until they found out what was going on.

Ms. Holm asked if he had pictures.

Chief Lane said that there were pictures but he had not seen them.

Ms. Holm asked if this took place in city limits.

Chief Lane said that it did not take place in city limits.

Ms. Holm said that she almost feels like we need to ask a lawyer on what we are responsible for as a City because if Bill Butler had a piece backhoe and needed to get into the ground and something happened and his piece of machinery was broken because he made that decision would the City be liable because we are paying employees to sit around and wait for something to happen.

Chief Lane stated that if another call had come in his employees would have responded to that call.

Mr. Welch – Had forestry not been able to respond and had it been a bigger issue would you still have used your personal ATV to go back there even though you didn't know what you were up against?

Chief Lane said that if it had gotten into the black spruce they would have had to take action.

Mr. McGhee – How many other respondents would have come if there were an actual fire in the black spruce?

Chief Lane stated that probably everyone in the borough would have responded to it.

Discussion

Mr. McGhee – My only concern is that going out in a personal ATV to go investigate what the fire was seems like a high liability. I have a hard time justifying using a personal vehicle when we have vehicles here.

Mr. Welch – I'm of the opinion that the chief acted for the wellbeing of the city and to protect it like he should. We need to create an SOP for the city between the police and the fire department. I would like to see him reimbursed.

Mr. McCarthy - I am really happy that we have a fire chief that is willing to go out there and I am glad that nobody got hurt. It would have been very risky and scary if he were to have done nothing. I am fully in favor for his reimbursement. It brings up a few points that the Police Department and the Fire Department can work out.

Mayor Ward – developing an official SOP is definitely something that will be coming up. Chief

Dutra has said there is no issue with the fire departments use of the ATV. It was the previous chief that had issues.

Ms. Hunter – I also am uncomfortable about what took place. Taking matters into your own hands is something I kind of have an issue with but will probably be leaning more towards the reimbursement. Somehow I am just not in full agreement with the action he took.

Mr. McGhee – He is the chief, he made the decision. Chief Lane should decide which line item it will come out of the department. I would think that with his expertise he would be able to tell by the coloration of the fire, the disbursement of the fire, how fast the fire is growing in the amount of time he has been watching it. I challenge him on the fact that he had to go and see if it was an actual forest fire.

Ms. Holm – Maybe we should bring this to the borough since it wasn't in city limits. We shouldn't punish our own citizens because of this situation. We shouldn't have to pay for personal items.

Recommendation

Accept \$1,960,000 Municipal Matching Grant for Sewer Lift Station Rehabilitation Phase 3 from the Alaska Department of Environmental Conservation (ADEC). The MMG requires a 30% match that totals \$840,000 for a total project cost of \$2.8 million.

Background

The Utility Department has received over \$5 million in state and federal grants to rehabilitate eight sewer lift stations. The Utility has conducted sewer lift station rehabilitation in phases. Phase 1 addressed the lift stations in greatest need of upgrading; for example, the lift station that serves the industrial park had seriously corroded pipes and undersized pumps. Phase 2 addressed the next set of lift stations in need or rehabilitation. A significant upgrade incorporated in Phases 1 & 2 was modernization of the lift stations' controls that included electronic controls that provide energy efficient pump management; remote system monitoring; detailed operational data; historical data collection; and telephonic emergency notifications.

The Utility has five remaining lift stations not rehabilitated in Phases 1 or 2. These include Cary (adjacent to City Hall), Hurst Road, Tanana Road, Mockler Road and Stillmeyer lift stations. The Utility built the Stillmeyer lift station in 2004, and it is relatively good condition. Upgrading the electronic controls and telephonic warning notifications would be useful upgrades for this lift station, but these upgrades to the Stillmeyer lift station are not as high a priority as the total overhaul of the other four other lift stations. The Utility's plan is to solicit bids to upgrade the Cary, Hurst, Tanana and Mockler lift stations to the standards developed in Phases 1 & 2. Upgrades to the Stillmeyer lift station would be included in a request for bids as an added alternate that would occur only if the cost was within the project budget of \$2.8 million.

The Utility plans to amend the professional services agreement with Stantec (formerly USKH) that provided engineering services for the Utility for Phases 1 & 2. Stantec will provide engineering and

design services, generate and manage the bidding process and provide construction management services.

The City of North Pole was one of only four communities awarded MMGs in the State 2016 capital budget—there were 51 grant applications. Of the four communities awarded grants, the State awarded only three their full request, North Pole was one of these three communities.

The Utility will pay the required 30% match from its Utility Fund reserves. As of July 28, the Utility had total Utility Reserves of \$910,445. The Utility will continue to routinely collect capital revenues with its Facility Repair and Replacement and Base Charge utility rates. These capital revenues will continue to grow the Utility's capital reserves.





My grant manager at ADEC contacted me last week to discuss my application for consideration of a Municipal Matching Grant (MMG) for upgrades of emergency equipment at the water treatment plant. He said the Utility's application was strong because it was "shovel ready"—the proposed project has engineering plans, bid specifications, and the local ADEC office has reviewed the project and issued an Approval to Construct for the project. He also stated that the competition for any grant funding next year will be very intense and every point an applicant can earn is critical. He encouraged me to modify the resolution passed by the City Council on July 6 approving the water treatment project as the City's number one capital project priority for a MMG. He said that a stronger resolution that has the greatest likelihood of receiving the 50 points for a council resolution would be one that named the project as the City's number one capital project for state funding in state fiscal year 2017.

I have modified the original resolution approved by the Council and am requesting that the revised resolution be passed to replace the original resolution.

PURPOSE:

The City of North Pole will take reasonable steps to ensure that persons with Limited English Proficiency (LEP) have meaningful access and an equal opportunity to participate in our services, activities, programs and other benefits.

PROCEDURES:

1. IDENTIFYING LEP PERSONS AND THEIR LANGUAGE

The City of North Pole will promptly identify the language and communication needs of the LEP person. If necessary, staff will use a language identification card or poster to determine the language.

2. OBTAINING A QUALIFIED INTERPRETER

The City of North Pole Human Resources Manager is responsible for obtaining an interpreter, if needed.

3. PROVIDING WRITTEN TRANSLATIONS

The City of North Pole will translate vital documents when a significant number or percentage of the population eligible to be served or directly affected by the program needs services or information in a language other than English.

4. PROVIDING NOTICE TO LEP PERSONS

The City of North Pole will inform LEP persons of the availability of language assistance, free of charge, by providing written notice in languages LEP persons will understand.

5. MONITORING LANGUAGE NEEDS AND IMPLEMENTATION

The City of North Pole will assess changes in demographics, types of services or other needs that may require reevaluation of this policy and its procedures.
