COMMUNICATIONS FROM THE MAYOR

- Introduced the Dave and Mami Monicken who brought visitors from the Sister City who in turn presented gifts to Council.
- The Violations Committee will be meeting before the first meeting of every month in the Council Chambers starting at 5:30 p.m. The public is welcome to attend.
- The Access Alaska Youth were at City Hall last week for a mock meeting and an introduction to local government. We debated the merits of applying for a grant to open a City run community center. It was a great experience and we hope to do it again with the summer work programs next year.
- Last weekend was the Eielson AFB open house, I was given a tour of several of the types of aircraft the air force has in service which included a 1959 B2 Bomber. The open house was well attended; thank you to the 354th FW for making this a reality.
- I have met with the Planning and Zoning staff with the Borough to begin calling property owners in the proposed rezone area. Most of the land owners we have contacted so far are in support of do not oppose the rezone. We are tentatively planning to have a community meeting in October to try and address concerns before it is brought to the Borough assembly.
- I have been meeting with the Borough Mayor's air quality group to review the monitoring plan for the non-attainment area. The monitoring plan consist of using non-regulatory monitors (similar to those used in the saturation study) to give data on neighborhoods not near the regulatory monitors (FNSB, State building and Firehouse on Hurst). Neighborhood monitors will also be collocated to establish trending between the monitors so that the neighborhood monitors can be better used. One of the ideas is to better understand if airflows from outside the non-attainment area affect the air in the non-attainment area.
- I had a meeting with FEDC president Jim Dobson to explore how the community can plan for the F-35 expansion and how we can take advantage of the newly revised Military Facility Zone legislation. One of the concepts is to make the entire city a military facility zone.
- August 19th from noon 5 p.m. at Pioneer Park is military appreciation day, if you have an opportunity to attend the event is always great.

COUNCIL MEMBER QUESTIONS OF THE MAYOR

• Mr. McGhee - Asked Mayor Ward if he could clarify who the city attorney is. Mayor Ward answered that our current city attorney is Zane Wilson with CSG. Zane had been out of town on vacation so his sister, Rene Broker, has been substituting. Mr. McGhee asked if the Mayor is aware of the social media outcry from the flagging of the potential

placement of street lights in the subdivision across the highway. Mayor Ward stated that he has heard some discussion and received some phone calls, but hadn't realized there was a social media outcry. Mr. McGhee stated that he was just wondering if this had made its way to the Mayor's office and if they were going to discuss, or do anything about it. Mayor Ward informed everyone that the State has taken over the project and will let everyone know when the public meeting schedule is published.

 Mr. Isaacson – Regarding the military facility zone, he questioned that as they look at North Pole, are they planning on going all the way through to Moose Creek. Mayor Ward stated that, at this point, it has to be the jurisdiction in charge. So, either the City or the Borough would apply for that. Since no one has applied for the military facility zone there have been questions from private individuals in the community. The discussion the Mayor had with Mr. Dobson is that they have to know how to do it, and what the benefit is to the developer or contractor. There has been some discussion in regards to the Eielson area, and that would fall to the Borough. The Mayor then stated that he thinks we are the first ones to talk about making an entire jurisdiction to fall under the military facility zone. Mr. Isaacson replied that it is all really encouraging. Mayor Ward stated that it is all still in discussion at this point, but he does anticipate being able to bring something to the council in the future.

<u>COMMUNICATIONS FROM DEPARTMENT HEADS, BOROUGH</u> <u>REPRESENTATIVE AND THE CITY CLERK</u>

Fire Dept., Chief Coon

- Hydrant, Pump, and Hose testing are complete without incident
- Two members attended Image Trend Elite training in Minneapolis. Image Trend is our new program for fire and EMS reporting. This new system has been implemented borough wide. The report will start with dispatch and will follow the patient all the way through the hospital. The department is excited about the new system and especially the speed at which reports can be completed.
- The department is expecting a vacancy with one member accepting a position at Fort Wainwright Fire Dept. The Department will be recruiting for the vacancy.
- Deputy Chief Heineken just returned from the National Fire Academy in Emmitsburg, MD. He attended a two week class on "Training Program Management." This class was at no cost to the City with all fees taken care of by the Federal Government.
- The Department is getting ready to take surplus items to the auction company and the Chief will have a report for the council after the sale.
- The Department will be assisting with the goodbye party for out Sister City on Wednesday at 1830 hrs.
- Department members participated in the rodeo at the fair last weekend. The proceeds from the event benefit all local firefighters.
 - Mr. McGhee questioned that recently there was an issue with fire marshal

inspections and wanted to know why North Pole doesn't have one. Chief Coon answered that he has been in discussion about this with the Mayor.

 $\circ~$ Mr. Isaacson thanked Chief Coon for his support with the Sister City.

Police Dept., Chief Dutra

- Lt. Rathbun filled in for Chief Dutra
- Two recruits in training status. One is heading off to the academy at CTC in Fairbanks, and the other recruit just entered 2nd phase of FTO.
- Officer Phil McBroom is going to Data Master Supervisor course.
- August is a pretty big training month, and we will be assisting with the airport for their tri-annual training event that is going to be an active shooter training. We are contributing 3 individuals and 1 evaluator.
- Meeting with the school district and moving forward with an active shooter response plan.
- We had a near fatality vehicle accident at the intersection of the Richardson and Peridot. Hopefully we can get that intersection improved.
- Two new patrol vehicles arrived from Anchorage.
- IT audit came back with stellar reviews.
- Looking into the ramifications of marijuana social clubs in regards to Police officers and the effects these types of business might have on the police officers if they are called to the establishments.
 - Mr. McGhee asked which officer was sent for additional marijuana detection training in regards to marijuana. Lt. Rathbun replied that we sent two. One is currently out of certification because he has joined the military. So, we have one current drug recognition expert and that is SGT Bellant. Mr. McGhee asked if there are any official/federal studies on the effects of 2nd hand marijuana smoke. Lt. Rathbun stated that there aren't as far as he is aware of.
 - At this point Mayor Ward states to note for the record here we did just have the computer do a mandatory restart so we are off record essentially until we get that up and running again.
 - Mr. Isaacson asked Lt. Rathbun if respirators are going to be needed in some regards for the officers. Lt. Rathbun answered that it is going to come up as a problem in one way or another when individuals are smoking marijuana, and officers are present.
- There was discussion in regards to upgrades to the Richardson and Peridot. Lt. Rathbun stated that in another conversation with the Mayor, he learned it is a combination of 12 Mile and the Peridot intersection that is being looked at. They are looking at being merged into another overpass or non-crossable area. Mayor Ward joined in at this point to clarify that there is an HSIP from 12 Mile to do an overpass. We have been advocating for improvement of the frontage road system which could potentially be the elimination of the Peridot Road crossing.

Finance, Tricia Fogarty

- A full financials report was ran, but a "summarized" financials report was provided.
- All departments are at less than 50% spent, as of the end of June.
- Sally Terch has been on vacation. Jamie Duncan has been filling in with accounts payable, and has been very helpful.
- Working on payroll, and we now have two signers Judy Binkley and Mayor Ward.
 - Mr. Thompson thanked Mrs. Fogarty for providing easy to read documents.

Director of City Services, Bill Butler

- Building Department
 - Santa Claus House: Issued a framing permit only based upon Fire Marshal approval. This allows project to proceed while remaining issues are resolved.
 - Complete permit package issued to Ouida Way tri-plex.
- Public Works
 - Hired a new summer hire for the remainder of the summer: Maddie Rathbun
 - Park location signs delivered and hope to begin installing them this week.
 - City received a \$10,000 award from the FNSB for our beautification efforts. For FNSB fiscal year July 1, 2017 to June 30, 2018.
 - Began brush clearing. Started on Homestead Road.
 - FMATS 2017 paving project of Dougchee Ave.; San Augustin Drive; Perimeter; and portion of H&H Lane (in area of Petro Star) began two weeks ago.
 - DOT is replacing sidewalks on Santa Claus Lane (next to slough) and on east side of Badger Road (near Tesoro). Also replaced two ADA ramps installed last year on Badger Road that had curbs that interfered with snow removal.
 - Change of terms of a grant request before the Council this evening for \$10,000 Kickstarter grant.

• Utility Department

- Sulfolane settlement
 - Project has begun to purchase utility easements in support of project.
 - Permit applications that support construction submitted to variety of local, state & federal agencies.
 - 95% engineering and design documents will be completed before next Council meeting.
- Odor from wastewater treatment works appears to continue to lessen.

- Two utility issues before Council this evening:
 - Transfer of Utility land to City to be used as location of impoundment lot.
 - Authorization of a scope of services with HDR to build a GIS data base for existing Utility infrastructure

• Natural Gas Utility Board

- Agreement appears to have been reached to resolve the funding dispute between ADIEA and IGU where ADIEA considered funds spent by IGU that IGU was not authorized to spend; for example, acquiring a natural gas supply contract.
 - Will enable IGU to restart halted work on project that was stopped due to concerns at IGU that its funding would dry up.

Borough Representative

- Ordinance 2017-42 repealed the Vision Fairbanks Downtown plan as an element of the FNSB comprehensive plan.
- Ordinance 2017-20-1B added over 2.3 million in Federal grant dollars to the Woodstove exchange program.

City Clerk's Office, Judy Binkley

- The 2017 candidate filing period and withdrawal period are both closed now.
 - We have 2 candidates: Sharon Hedding and Aino Welch.
 - This week I will be working on verifying the qualification of both candidates.
 - I have a meeting at the Borough office later this week to start discussions on putting together the ballot and the formatting.
- The annual workman's comp audit is later this month and I am working with Tricia to pull together all the documents the auditor has requested.

DEVELOPMENT AGREEMENT FOR THE FORD SUBDIVISION – 4TH ADDITION BETWEEN THE CITY OF NORTH POLE AND DEBRA K. ROSSON, 2017.





Subject:	Request PDC Engineers to generate a Source Water Protection Plan for the North Pole Utility drinking water wells

Recommendation:

Approve PDC Engineers' fee proposal of \$28,765 to generate a Source Water Protection Plan for the North Pole Utility's drinking water wells.

Background

In 2010, due to sulfolane contamination of the North Pole Utility drinking water wells located on Snowman Lane, Flint Hills Resources constructed two new wells for the Utility. The new wells are located on 791 Clear Water Court (south of Baker and west of North Star Subdivisions). The land surrounding the wells is largely undeveloped at present (except to the east). The aquifer that supplies the wells moves from southeast to northwest.

To ensure that the water that supplies the drinking water wells is not contaminated, it is critical that the Utility develop and implement a source water protection plan (SWPP). The Utility has approximately 600 utility accounts. When the new water system extension is completed, there is a potential for over 700 new utility accounts. The utility expansion within the city limits and in the new water system expansion has the potential to add several hundred more utility accounts should residential and commercial development occur. The USAF has identified the North Pole Utility as its preferred option to be the drinking water source to address the PFOS/POFA groundwater contamination in Moose Creek. Should the Moose Creek project be constructed, this expansion could add up to 150 new utility accounts. Within a decade, the Utility could triple its number of utility accounts and be the drinking water sources for thousands more people.

The Utility's current treatment process involves the removal of iron and manganese. There is no chlorination. The treatment works has limited physical capacity to include additional treatment options. Should the Utility's water supply become contaminated, the Utility would need to build an addition to the treatment works or a separate new treatment works. Depending upon the contamination that the Utility had to treat would drive the cost of plant expansion. Bottom line, there is no "cheap"

treatment plant expansion options. A treatment plant expansion would likely cost between five to ten million dollars and require additional staffing and increased treatment costs. Any such costs would be borne by the utility rate payers

The most cost effective approach is to prevent contamination of the aquifer that supplies the wells. A sound SWPP is the Utility means to implement best management practices to prevent the contamination of the Utility's water supply.

The Utility requested quotes from three local engineering firms to assist the Utility to develop a SWPP. The Utility asked the firms to address the following issues when developing their cost proposals:

- 1. Recommend the public water system protection area.
- 2. Inventory potential sources of contamination.
- 3. Propose management tools and strategies to mitigate the potential for contamination.
- 4. Propose utility operation and maintenance strategies.
- 5. Propose strategies to mitigate external influences.
- 6. Propose contingency or an Emergency Response Plan (ERP) to identify alternative water
- 7. Sources.
- 8. Prioritize an implementation plan for the protection strategies.
- 9. The Source Water Protection Plan needs to be compliant with Alaska Department of Environmental Conservation criteria for an "ADEC Endorsed" drinking water protection plan.

The Utility has worked with each of these firms and they all have reputable qualifications. PDC was involved in the design of the new wells, well house and connecting water mains. Shannon and Wilson was involved is geotechnical and environmental work as part of the new wells' construction. Stantec served as the Utility's plan reviewer and inspector of the new wells' design and construction. The Utility recommends PDC not solely based upon cost, but also based upon PDC's involvement with engineering, design and construction of the wells 9and their work with the subcontractors associated with the new well project.

The Water division has approximately \$781,565 in its reserves as of August 16, 2017.
