General RequirementsClass "C" Retail Fireworks

Retail sales are allowed June 20 through July 5 and December 15 through December 31. Permits issued are valid until December 31 of the year issued. Permit fee is \$3000.00 {three thousand dollars) for a single location within the City limits. An additional fee of \$200 (two hundred dollars) shall be paid during each permit period to the North Pole Fire Department fire/accident prevention fund.

Before you open:

- I. Obtain all State and Local permits as required, include State permit, City of North Pole sales tax registration,
 - Borough Conditional Use or Zoning Permit, Certificate oflnsurance listing City of North Pole as co-insured.
- 2. Assure stand placement is in accordance with State and Local regulations.
- 3. Schedule an inspection with the fire department. Time of inspection will be set by the Fire Department.
 - Inspection must take place prior to opening.

While you are open:

- 1. One person at least eighteen (18) years old must be in the stand at all times while it is open for business.
- 2. The person in charge, as listed on the permit, or their representative, must be available for contact day or night by telephone or other reliable means.
- 3. "No Smoking" si_{g n}s shall be posted on all outside walls of the stand. The si_{g n}s shall be readily visible to all engaged in retail sales, customers or others near the sales outlet. Si_{g n} lettering shall be red and at least 2 Yi inches high and on a white background.
- 4. One water-type, 2A Fire Extinguisher or equivalent water-type extinguishing system or as determined by local jurisdiction must be at the stand at all times when the stand is open.
- 5. Sales to children less than eighteen (18) years old are prohibited.
- 6. No smoking, open flames or lighting fireworks within (50) feet of the stand is allowed.
- 7. Heaters having exposed electrical elements or open flames shall not be used.
- 8. The area within fifty (50) feet of the stand must be kept clean and orderly.
- 9. The retail sales permit or a copy must be posted at the stand while it is open.
- 10. On site storage of fireworks shall be limited to stock within the stand. Storing fireworks adjacent to or in the vicinity of existing stands is prohibited.
- 11. The following types of Class "C" fireworks are prohibited:
 - a. Pop bottle rockets
 - b. Reserved
- 12. The City of North Pole reserves the right to make periodic inspections of retail premises as is deemed necessary. All State, Federal and Local regulations governing the sale of fireworks must be observed.
- 13. The sale of fireworks from any motorized vehicle is prohibited.
- 14. The sale of fireworks to a person under the influence of alcohol or drugs is prohibited, a $\sin_{g} n$ stating this must be posted on the premises in plain sight.
- 15. The only fireworks allowed on the premises are fireworks that can be stored in the building. The only time fireworks are allowed to be stored in the building is when the vendor is on the premises.
- 16. The following Alaska Statute must be posted on the premises:

"Section 41.15.070 Disposal o (Buming Materials." A person who dlItilg the fire seasol1. throws away lig/Ited tobacco. cigar, cigareile, maceli, /irec:racker o r other buming material (II forested land, whether public or private, is guilty of a misdemeanor. (4 ch 138 sla 1961)
