Introduction

The City of North Pole has adopted by reference the 1997 Uniform Administrative Code, including its methodology for calculating permit fees. According to the City of North Pole Municipal Code amendment to the Administrative Code:

The determination of value or valuation under any of the provisions of these codes shall be made by the building official. The value to be used in computing the building permit and building plan review fees shall be the total value of all construction work for which the permit is issued as well as all finish work, painting, roofing, electrical, plumbing, heating, air-conditioning, elevators, fire-extinguishing systems and other permanent equipment. Valuation shall be determined in accordance with the latest edition of the Building Safety Journal data chart as published by the International Code Council or based on the final contract amount, whichever is greater. When calculating the valuation utilizing the building valuation data chart the regional modifier shall be (1.3). A copy of the bid award may be required by the building official. In any case the final determination of value or valuation under any of the provisions of these codes shall be made by the building official. (Title 15, Section 15.04.050)

The Building Department has made the Building Fee Guide to help customers estimate permit and plan review fees. Any figures you generate are only estimates and the Building Department makes the final determination of permit fees. A worksheet is included with this guide to help you estimate your permit fees.

Each building project is unique and the permits required may vary. The permit fees for a project will depend upon the permits it requires. The total permit fees for a project may be a combination of one or more of the following:

- Building Permit and Plan Review
- Electrical Permit and Plan Review
- Mechanical Permit and Plan Review
- Plumbing Permit and Plan Review
- Storm Water Permit and Plan Review
- Utility Tie-In Permit and Utility Tie-In Inspection
- Excavation Permit and Plan Review
- Excavation Bond (returned if right-of-way restored)
- Fire Marshal Permit¹

The simplest way to estimate Building Permit and Plan Review fees is to use the Building Permit Fee Estimation Table. Using this method does not provide estimates for any other permits that the Building Department may require for your project. If you want to refine your cost estimate, you can find additional guidance and resources in this guide.

¹ Multi-Family, Commercial, Industrial and Institutional projects may require a Fire Marshal's Permit. The Building Department DOES NOT issue Fire Marshal Permits. Contact the Fire Marshal's office at 907-451-5200 to determine if your project requires a Fire Marshal Permit.

Determining Value of Project

The complexity of your project and how good an estimate you want will affect the effort you will need to invest when estimating the permitting fees. Below are directions you can use to help you estimate the value of your project and to calculate permit fees.

Step 1: Determine the total value of your project.

There are two approaches to estimate the value of a project—square footage cost of the project or contractor's bid price. The Building Department most frequently uses the square foot approach to estimate the value of projects like new construction of a building or an addition. The Building Department most frequently uses the contractor's bid approach for projects like renovation of a building, a "small" project like replacing a roof, adding a deck or installation of new heating system. The contractor's bid approach is also used for very large and complex projects where the square foot approach does not provide a reliable valuation. By City Code, the City uses the method that assigns the highest value to your project. The Building Department makes the final determination of the value of the improvement.

Square Footage Approach

First, identify what "Group" best describes your project. According to the 2009 International Building Code (IBC), Chapter 3: Use and Occupancy Classification, Section 302 Classification:

Structures or portions of structures shall be classified with respect to occupancy in one or more of the groups listed below. A room or space that is intended to be occupied at different times for different purposes shall comply with all of the requirements that are applicable to each of the purposes for which the room or space will be occupied. Structures with multiple occupancies or uses shall comply with Section 508. Where a structure is proposed for a purpose that is not specifically provided for in this code, such structure shall be classified in the group that the occupancy most nearly resembles, according to the fire safety and relative hazard involved.

- 1. Assembly (see Section 303): Groups A-1, A-2, A-3, A-4 and A-5
- 2. Business (see Section 304): Group B
- 3. Educational (see Section 305): Group E
- 4. Factory and Industrial (see Section 306): Groups F-1 and F-2
- 5. High Hazard (see Section 307): Groups H-1, H-2, H-3, H-4 and H-5
- 6. Institutional (see Section 308): Groups I-1, I-2, I-3 and I-4
- 7. Mercantile (see Section 309): Group M
- 8. Residential (see Section 310): Groups R-1, R-2, R-3 and R-4
- 9. Storage (see Section 311): Groups S-1 and S-2
- 10. Utility and Miscellaneous (see Section 312): Group U

You can find summary descriptions of the different groups in Appendix A: Building Groups List. Review the Building Groups List to identify the group that most closely matches your project.

Second, determine the Type of Construction you will use for your project. According to the 2009 *International Building Code* Council, Chapter 6, Section 602, Construction Classification:

Buildings and structures erected or to be erected, altered or extended in height or area shall be classified in one of the five construction types defined in Sections 602.2 through 602.5. The building elements shall have a fire-resistance rating not less than that specified in Table 601 and exterior walls shall have a fire-resistance rating not less than that specified in Table 602. Where required to have a fire-resistance rating by Table 601, building elements shall comply with the applicable provisions of Section 703.2. The protection of openings, ducts and air transfer openings in building elements shall not be required unless required by other provisions of this code.

There are five types identified by Roman numerals—I, II, III, IV and V. Most of these types have sub-types labeled A or B. Historically, most projects in the City of North Pole have been Type VB. You can use the IBC definitions to identify your Type of Construction. The sections of the IBC related to determining the building type can be found in Appendix B: Types of Construction.

Third, use Table 1 Square Foot Construction Cost to determine square foot cost of your project. The Group is listed in the left-hand column and Type Construction is listed across the top of the table. Where the two categories intersect is the square foot cost of your project. Multiple the square footage of your project by the square foot cost to get an estimated value of the improvement. All tables are found at the back of the guide.

Contractor's Bid Approach

Not all projects' value can be easily determined with the Square Footage Approach. As described above. If you have a contractor's bid you can use this value to estimate your project's permit fees. The Building Department will require you to submit this bid if you want to use this approach to determine the value of your improvement.

Step 2: Calculate Building Permit Fee and Plan Review Fee

With the value of your project determined in Step 1, you can estimate your Building Permit Fee. The Building Department uses Table 2 Building Permit Fees to calculate a Building Permit Fee. You can do the math as described in Table 2 to estimate the value of your project. A simpler way to estimate the Building Permit Fee or your project, is to use Table 3 Building Permit Fee Estimation Table. In the right-hand column of Table 3, find the value that most closely matches the value of your project. Read across the table to find the estimated Building Permit Fee and Plan Review Fee. The Building Department calculates the Plan Review Fee as 75% of the Building Permit Fee.

Step 3: Calculate Electrical, Mechanical and Plumbing Permit Fees

The Building Department uses the 1997 Uniform Administrative Code tables to determine Electrical, Mechanical and Plumbing Permit Fees. The Building Department calculates the plan

review fees for each of these permits as 25% of the individual permit fees. The tables the Building Department uses to calculate these fees are the following:

Step 4: Additional Permits

Depending upon your project, other permitting fees may apply.

Step 4a. If your project is privately funded; it will disturb a cumulative acre or more of ground; and storm water runoff from the project will flow into "waters of the United States" your project is likely to require a storm water permit. The North Pole Municipal Code, Title 15; Chapter 15.66 Construction Site Storm Water Runoff details storm water permitting requirements. In addition, if your project will discharge storm water runoff directly into "waters of the US" or the storm water conveyance system, it must comply with Title 15; Chapter 15.74 Post-Construction Storm Water Management. If your project requires a storm water permit, you will also be required to submit a storm water pollution prevention plan (SWPPP). Storm Water Permit Fees include SWPPP plan review and inspection fees. You can estimate these fees based upon Table 7 Storm Water Permit Fees.

Step 4b. Water and/or Sewer Utility Connection Fees

If your project includes connecting to the City of North Pole water and/or sewer system, you must get a Utility Tie-In Permit and have the work inspected by the Utility Department. According to the North Pole Municipal Code, any occupied structure within 200 feet of a water or sewer main must connect to the utility system; otherwise, the property owner will be charged monthly the flat utility rate. See the North Pole Municipal Code, Title 13, Chapter 13.12; Section 13.12.090 Compulsory connection to City water and sewer utility. Utility tie-in fees are presented in Table 8 Utility Tie-In Fees.

Step 4c. Excavation of a City Right-of-Way Fees

If your project includes excavation of a City-owned right-of-way (ROW), for example, road, sidewalk or alley, there are fees associated with the excavation. Excavation of a City ROW also requires submission of a bond to ensure that the ROW is reconstructed. You can estimate excavation permit fees using Table 9a Excavation Permit Fees and the required Excavation Bond using Table 9b.

Appendix A: IBC Building Group Summary Descriptions

ASSEMBLY GROUP A

Assembly Group A. Assembly Group A occupancy includes, among others, the use of a building or structure, or a portion thereof, for the gathering of persons for purposes such as civic, social or religious functions; recreation, food or drink consumption or awaiting transportation.

A-1 Assembly uses, usually with fixed seating, intended for the production and viewing of the performing arts or motion pictures including, but not limited to:

A-2 Assembly uses intended for food and/or drink consumption including, but not limited to:

EDUCATIONAL GROUP E

Educational Group E. Educational Group E occupancy includes, among others, the use of a building or structure, or a portion thereof, by six or more persons at any one time for educational purposes through the 12th grade. Religious educational rooms and religious auditoriums, which are accessory to *places of religious worship* and have *occupant loads* of less than 100, shall be classified as A-3 occupancies.

FACTORY GROUP F

Factory Industrial Group F. Factory Industrial Group F occupancy includes, among others, the use of a building or structure, or a portion thereof, for assembling, disassembling, fabricating, finishing, manufacturing, packaging, repair or processing operations that are not classified as a Group H hazardous or Group S storage occupancy.

Factory Industrial F-1 Moderate-hazard Occupancy.

Factory industrial uses which are not classified as Factory Industrial F-2 Low Hazard shall be classified as F-1 Moderate Hazard and shall include, but not be limited to, the following:

Aircraft (manufacturing, not to include repair)

Athletic equipment

Automobiles and other motor vehicles

Jute products

Laundries

Leather products

Factory Industrial F-2 Low-hazard Occupancy. Factory industrial uses that involve the fabrication or manufacturing of noncombustible materials which during finishing, packing or processing do not involve a significant fire hazard shall be classified as F-2 occupancies and shall include, but not be limited to, the following:

Beverages: up to and including 16-percent Glass products alcohol content Gypsum
Brick and masonry Ice

Ceramic products Metal products (fabrication and assembly)

Foundries

HIGH-HAZARD GROUP H

High-hazard Group H. High-hazard Group H occupancy includes, among others, the use of a building or structure, or a portion thereof, that involves the manufacturing, processing, generation or storage of materials that constitute a physical or health hazard. Hazardous occupancies are classified in Groups H-1, H-2, H-3, H-4 and H-5 the *International Fire Code*. Hazardous materials stored, or used on top of roofs or canopies shall be classified as outdoor storage or use and shall comply with the *International Fire Code*.

INSTITUTIONAL GROUP I

Institutional Group I. Institutional Group I occupancy includes, among others, the use of a building or structure, or a portion thereof, in which people are cared for or live in a supervised environment, having physical limitations because of health or age are harbored for medical treatment or other care or treatment, or in which people are detained for penal or correctional purposes or in which the liberty of the occupants is restricted. Institutional occupancies shall be classified as Group I-1, I-2, I-3 or I-4.

Group I-1. This occupancy shall include buildings, structures or parts thereof housing more than 16 persons, on a 24-hour basis, who because of age, mental disability or other reasons, live in a supervised residential environment that provides *personal care services*. The occupants are capable of responding to an emergency situation without physical assistance from staff. This group shall include, but not be limited to, the following:

Alcohol and drug centers Group homes
Assisted living facilities Halfway houses

Congregate care facilities

Residential board and care facilities

Social reliability of a division facilities

Convalescent facilities Social rehabilitation facilities

A facility such as the above with five or fewer persons shall

be classified as a Group R-3 or shall comply with the *International Residential Code*. A facility such as above, housing at least six and not more than 16 persons, shall be classified as Group R-4.

Group I-2. This occupancy shall include buildings and structures used for medical, surgical, psychiatric, nursing or custodial care for persons who are not capable of self-preservation. This group shall include, but not be limited to, the following:

Child care facilities Mental hospitals
Detoxification facilities Nursing homes

Hospitals

Group I-3. This occupancy shall include buildings and structures that are inhabited by more than five persons who are under restraint or security. An I-3 facility is occupied by persons who are generally incapable of self-preservation due to security measures not under the occupants' control. This group shall include, but not be limited to, the following:

Correctional centers Prerelease centers

Detention centers Prisons

Jails Reformatories

MERCANTILE GROUP M

309.1 Mercantile Group M. Mercantile Group M occupancy includes, among others, the use of a building or structure or a portion thereof, for the display and sale of merchandise and involves stocks of goods, wares or merchandise incidental to such purposes and accessible to the public.

Mercantile occupancies shall include, but not be limited to, the following:

Department stores Motor fuel-dispensing facilities
Drug stores Retail or wholesale stores

Markets Sales rooms

RESIDENTIAL GROUP R

310.1 Residential Group R. Residential Group R includes, among others, the use of a building or structure, or a portion thereof, for sleeping purposes when not classified as an Institutional Group I or when not regulated by the *International Residential Code* in accordance with Section 101.2. Residential occupancies shall include the following:

R-1 Residential occupancies containing *sleeping units* where the occupants are primarily transient in nature, including:

Boarding houses (transient) Hotels (transient) Motels (transient) Congregate living facilities (transient) with 10 or fewer occupants are permitted to comply with the construction requirements for Group R-3.

R-2 Residential occupancies containing *sleeping units* or more than two *dwelling units* where the occupants are primarily permanent in nature, including:

Apartment houses *Boarding houses* Monasteries

(nontransient) Motels (nontransient)

Convents Vacation timeshare properties

Dormitories Congregate living facilities with 16 or fewer

Fraternities and sororities occupants are permitted to comply with the Hotels (nontransient) construction requirements for Group R-3.

Live/work units

R-3 Residential occupancies where the occupants are primarily permanent in nature and not classified as Group R-1, R-2, R-4 or I, including: Buildings that do not contain more than two *dwelling units*. Adult care facilities that provide accommodations for five or fewer persons of any age for less than 24 hours. Child care facilities that provide accommodations for five or fewer persons of any age for less than 24 hours. *Congregate living facilities* with 16 or fewer persons. Adult care and child care facilities that are within a single-family home are permitted to comply with the *International Residential Code*.

R-4 Residential occupancies shall include buildings arranged for occupancy as residential care/assisted living facilities including more than five but not more than 16 occupants, excluding staff. Group R-4 occupancies shall meet the requirements for construction as defined for Group R-3, except as otherwise provided for in this code or shall comply with the *International Residential Code* provided the building is protected by an *automatic sprinkler system*.

STORAGE GROUP S

Storage Group S. Storage Group S occupancy includes, among others, the use of a building or structure, or a portion thereof, for storage that is not classified as a hazardous occupancy.

Moderate-hazard storage, Group S-1. Buildings occupied for storage uses that are not

classified as Group S-2, including, but not limited to, storage of the following:

Aerosols, Levels 2 and 3 Aircraft hangar Glues, mucilage, pastes and size

(storage and repair) Grains

Bags: cloth, burlap and paper Horns and combs, other than celluloid

Bamboos and rattan Leather
Baskets Linoleum
Belting: canvas and leather Lumber

Books and paper in rolls or packs

Motor vehicle repair garages

Boots and shoes Photo engravings
Buttons, including cloth covered, pearl or Resilient flooring

Low-hazard storage, Group S-2. Includes, among others, buildings used for the storage of noncombustible materials such as products on wood pallets or in paper cartons with or without single thickness divisions; or in paper wrappings. Such products are permitted to have a negligible amount of plastic *trim*, such as knobs, handles or film wrapping. Group S-2 storage uses shall include, but not be limited to, storage of the following:

alcohol in metal, glass or ceramic containers

Cement in bags

Gypsum board

Inert pigments

UTILITY AND MISCELLANEOUS GROUP U

General. Buildings and structures of an accessory character and miscellaneous structures not classified in any specific occupancy shall be constructed, equipped and maintained to conform to the requirements of this code commensurate with the fire and life hazard incidental to their occupancy. Group U shall include, but not be limited to, the following:

Agricultural buildings

Aircraft hangars, accessory to a one- or twofamily

residence

Greenhouses

Livestock shelters

Private garages

Retaining walls

Barns Sheds
Carports Stables
Fences more than 6 feet (1829 mm) high Tanks
Grain silos, accessory to a residential Towers

Appendix B: IBC Type of Construction Descriptions

CHAPTER 6 TYPES OF CONSTRUCTION

SECTION 601 GENERAL

601.1 Scope. The provisions of this chapter shall control the classification of buildings as to type of construction.

SECTION 602 CONSTRUCTION CLASSIFICATION

602.1 General. Buildings and structures erected or to be erected, altered or extended in height or area shall be classified in one of the five construction types defined in Sections 602.2 through 602.5. The building elements shall have a *fire-resistance rating* not less than that specified in Table 601 and exterior walls shall have a fire-resistance rating not less than that specified in Table 602. Where required to have a fire-resistance rating by Table 601, building elements shall comply with the applicable provisions of Section 703.2. The protection of openings, ducts and air transfer openings in building elements shall not be required unless required by other provisions of this code.

602.1.1 Minimum requirements. A building or portion thereof shall not be required to conform to the details of a type of construction higher than that type which meets the minimum requirements based on occupancy even though certain features of such a building actually conform to a higher type of construction.

602.2 Types I and II. Types I and II construction are those types of construction in which the building elements listed in Table 601 are of noncombustible materials, except as permitted in Section 603 and elsewhere in this code.

602.3 Type III. Type III construction is that type of construction in which the exterior walls are of noncombustible materials and the interior building elements are of any material permitted by this code. Fire-retardant-treated wood framing complying with Section 2303.2 shall be permitted within exterior wall assemblies of a 2-hour rating or less

602.4 Type IV. Type IV construction (Heavy Timber, HT) is that type of construction in which the exterior walls are of noncombustible materials and the interior building elements are of solid or laminated wood without concealed spaces. The

- a. Roof supports: Fire-resistance ratings of primary structural frame and bearing walls are permitted to be reduced by 1 hour where supporting a roof only.
- b. Except in Group F-1, H, M and S-1 occupancies, fire protection of structural members shall not be required, including protection of roof framing and decking where every part of the roof construction is 20 feet or more above any floor immediately below. Fire-retardant-treated wood members shall be allowed to be used for such unprotected members.
- c. In all occupancies, heavy timber shall be allowed where a 1-hour or less fire-resistance rating is required.

 d. An approved automatic sprinkler system in accordance with Section 903.3.1.1 shall be allowed to be substituted for 1-hour fire-resistance-rated construction, provided such system is not otherwise required by other provisions of the code or used for an allowable area increase in accordance with Section 506.3 or an allowable height increase in accordance with Section 504.2. The 1-hour substitution for the fire resistance of exterior walls shall not be permitted.
- e. Not less than the fire-resistance rating required by other sections of this code
- f. Not less than the fire-resistance rating based on fire separation distance (see Table 602).g. Not less than the fire-resistance rating as referenced in Section 704.10

TYPES OF CONSTRUCTION

details of Type IV construction shall comply with the provisions of this section. Fire-retardant-treated wood framing complying with Section 2303.2 shall be permitted within exterior wall assemblies with a 2-hour rating or less. Minimum solid sawn nominal dimensions are required for structures built using Type IV construction (HT). For glued-laminated members the equivalent net finished width and depths corresponding to the minimum nominal width and depths of solid sawn lumber are required as specified in Table 602.4.

602.4.1 Columns. Wood columns shall be sawn or glued laminated and shall not be less than 8 inches (203 mm), nominal, in any dimension where supporting floor loads and not less than 6 inches (152 mm) nominal in width and not less than 8 inches (203 mm) nominal in depth where supporting roof and ceiling loads only. Columns shall be continuous or superimposed and connected in an approved manner.

602.4.2 Floor framing. Wood beams and girders shall be of sawn or glued-laminated timber and shall be not less than 6 inches (152 mm) nominal in width and not less than 10 inches (254 mm) nominal in depth. Framed sawn or glued-laminated timber arches, which spring from the floor line and support floor loads, shall be not less than 8 inches (203 mm) nominal in any dimension. Framed timber trusses

supporting floor loads shall have members of not less than 8 inches (203 mm) nominal in any dimension.

602.4.3 Roof framing. Wood-frame or glued-laminated arches for roof construction, which spring from the floor line or from grade and do not support floor loads, shall have members not less than 6 inches (152 mm) nominal in width and have not less than 8 inches (203 mm) nominal in depth for the lower half of the height and not less than 6 inches (152 mm) nominal in depth for the upper half. Framed or glued-laminated arches for roof construction that spring from the top of walls or wall abutments, framed timber trusses and other roof framing, which do not support floor loads, shall have members not less than 4 inches (102 mm) nominal in width and not less than 6 inches (152 mm) nominal in depth. Spaced members shall be permitted to be composed of two or more pieces not less than 3 inches (76 mm) nominal in thickness where blocked solidly throughout their intervening spaces or where spaces are tightly closed by a continuous wood cover plate of not less than 2 inches (51 mm) nominal in thickness secured to the underside of the members. Splice plates shall be not less than 3 inches (76 mm) nominal in thickness. Where protected by approved automatic sprinklers under the roof deck, framing members shall be not less than 3 inches (76 mm) nominal in width.

602.4.4 Floors. Floors shall be without concealed spaces. Wood floors shall be of sawn or glued-laminated planks, splined or tongue-and-groove, of not less than 3 inches (76 mm) nominal in thickness covered with 1-inch (25 mm) nominal dimension tongue-and-groove flooring, laid crosswise or diagonally, or 0.5-inch (12.7 mm) particleboard or planks not less than 4 inches (102 mm) nominal in width set on edge close together and well spiked and covered with 1-inch (25 mm) nominal dimension flooring or 15/32-inch (12 mm) wood structural panel or 0.5-inch (12.7 mm) particleboard. The lumber shall be laid so that no continuous line of joints will occur except at points of support. Floors shall not extend closer than 0.5 inch (12.7 mm) to walls. Such 0.5-inch (12.7 mm) space shall be covered by a molding fastened to the wall and so arranged that it will not obstruct the swelling or shrinkage movements of the floor. Corbeling of masonry walls under the floor shall be permitted to be used in place of molding.

602.4.5 Roofs. Roofs shall be without concealed spaces and wood roof decks shall be sawn or glued laminated, splined or tongue-and-groove plank, not less than 2 inches (51 mm) nominal in thickness, 1½-inch-thick (32 mm) wood structural panel (exterior glue), or of planks not less than 3 inches (76 mm) nominal in width, set on edge close together and laid as required for floors. Other types of decking shall be permitted to be used if providing equivalent *fire resistance* and structural properties.

602.4.6 Partitions. Partitions shall be of solid wood construction formed by not less than two layers of 1-inch (25 mm) matched boards or laminated construction 4 inches (102 mm) thick, or of 1-hour fire-resistance-rated construction.

602.4.7 Exterior structural members. Where a horizontal separation of 20 feet (6096 mm) or more is provided, wood columns and arches conforming to heavy timber sizes shall be permitted to be used externally.

602.5 Type V. Type V construction is that type of construction in which the structural elements, *exterior walls* and interior walls are of any materials permitted by this code.

SECTION 603 COMBUSTIBLE MATERIAL IN TYPE I AND II CONSTRUCTION

603.1 Allowable materials. Combustible materials shall be permitted in buildings of Type I or II construction in the following applications and in accordance with Sections 603.1.1 through 603.1.3:

- 1. Fire-retardant-treated wood shall be permitted in:
 - 1.1. Nonbearing partitions where the required fire-resistance rating is 2 hours or less.
 - Nonbearing exterior walls where no fire rating is required.
 - Roof construction, including girders, trusses, framing and decking.

Exception: In buildings of Type IA construction exceeding two stories above grade plane,

fire-retardant-treated wood is not permitted in roof construction when the vertical distance from the upper floor to the roof is less than 20 feet (6096 mm).

Thermal and acoustical insulation, other than foam plastics, having a flame spread index of not more than 25.

Exceptions:

- Insulation placed between two layers of noncombustible materials without an intervening airspace shall be allowed to have a flame spread index of not more than 100.
- Insulation installed between a finished floor and solid decking without intervening airspace shall be allowed to have a flame spread index of not more than 200.
- 3. Foam plastics in accordance with Chapter 26.
- 4. Roof coverings that have an A. B or C classification.
- Interior floor finish and floor covering materials installed in accordance with Section 804.
- Millwork such as doors, door frames, window sashes and frames.
- Interior wall and ceiling finishes installed in accordance with Sections 801 and 803.
- 8. Trim installed in accordance with Section 806.
- Where not installed over 15 feet (4572 mm) above grade, show windows, nailing or furring strips and wooden bulkheads below show windows, including their frames, aprons and show cases.
- Finish flooring installed in accordance with Section 805.
- 11. Partitions dividing portions of stores, offices or similar places occupied by one tenant only and that do not establish a corridor serving an occupant load of 30 or more shall be permitted to be constructed of fire-retardant-treated wood, 1-hour fire-resistance-rated construction or of wood panels or similar light construction up to 6 feet (1829 mm) in height.
- Stages and platforms constructed in accordance with Sections 410.3 and 410.4, respectively.
- Combustible exterior wall coverings, balconies and similar projections and bay or oriel windows in accordance with Chapter 14.
- Blocking such as for handrails, millwork, cabinets and window and door frames.
- 15. Light-transmitting plastics as permitted by Chapter 26.
- Mastics and caulking materials applied to provide flexible seals between components of exterior wall construction.
- Exterior plastic veneer installed in accordance with Section 2605.2.
- Nailing or furring strips as permitted by Section 803.11.

TYPES OF CONSTRUCTION

- Heavy timber as permitted by Note c to Table 601 and Sections 602.4.7 and 1406.3.
- Aggregates, component materials and admixtures as permitted by Section 703.2.2.
- 21. Sprayed fire-resistant materials and intumescent and mastic fire-resistant coatings, determined on the basis of fire-resistance tests in accordance with Section 703.2 and installed in accordance with Sections 1704.12 and 1704.13, respectively.
- Materials used to protect penetrations in fire-resistance-rated assemblies in accordance with Section 713.
- 23. Materials used to protect joints in fire-resistance-rated assemblies in accordance with Section 714.
- Materials allowed in the concealed spaces of buildings of Types I and II construction in accordance with Section 717.5.
- Materials exposed within plenums complying with Section 602 of the *International Mechanical Code*.
- **603.1.1 Ducts.** The use of nonmetallic ducts shall be permitted when installed in accordance with the limitations of the *International Mechanical Code*.
- **603.1.2 Piping.** The use of combustible piping materials shall be permitted when installed in accordance with the limitations of the *International Mechanical Code* and the *International Plumbing Code*.
- **603.1.3 Electrical.** The use of electrical wiring methods with combustible insulation, tubing, raceways and related components shall be permitted when installed in accordance with the limitations of this code.

All contractors submitting plans for review are required to comply with the following procedures.

The administrative charge for a permit is \$50.00.

Cost of a permit: When the City deems at its sole discretion that plan review and inspection of a construction project exceeds the expertise of the City to perform, the City shall retain external expertise to perform plan review and inspections services. When the City determines that a project requires the use of external expertise to conduct plan review and/or inspections, the City shall negotiate a Reimbursable Services Agreement (RSA) between the City and the construction contractor. The RSA shall fully cover the City's costs plus a five (5) percent administrative charge.

- 1. Permits are valid for one hundred twenty (120) days, after which they automatically become void and must be updated and re-approved by the City before any construction will be permitted.
- 2. The Contractor shall have one (1) copy of the approved permit, the approved construction plans, and the approved traffic control plan (if required) at the job site at all times.
- 3. Two (2) complete sets of prints of the project drawings or schematics shall be submitted to the City for review.
- 4. The following items shall be included on the plan:
 - a. North arrow and scale
 - b. Existing and proposed streets with names and widths
 - c. Driveway locations with accurate width
 - d. Easement and right-of-way information recorded with the Borough
 - e. All existing utilities (type and location)
 - f. Proposed utility location showing approximate dimensions in relation to right-of-way and/or easement line
 - g. Legend of symbols
 - h. Minor construction notes indicating the type of excavation and or boring under streets and driveways or other permanent structures. Additional information may be required by the City as necessary.
 - i. A traffic control plan will be required for all work that includes temporary lane reductions or closures. The traffic control plan shall be approved by the City of North Pole prior to any permit being issued.
