INSPECTION CHECKLIST FOR RESIDENTIAL RENTALS/TRANSIENT HOUSING 3/2013

USE THIS SHEET AS A CHECK SHEET TO MAKE SURE YOU ARE IN COMPLIANCE PRIOR TO OUR INSPECTON.

The facility shall be used for providing accommodations to <u>not more</u> than 10 people and contain <u>not more</u> than five bedrooms.

FIRE EXTINGUISHERS

____Fire Extinguishers shall be selected, installed and maintained in accordance with Section 906 and NFPA 10.

_____ One 5 lb. ABC extinguisher is required for a maximum floor area of 3000 square feet per extinguisher. Section 906.3

_____ Maximum travel distance to a portable fire extinguisher is 75 feet. Section 906.3

Fire extinguishers shall be of the rechargeable type. Section 906.3 and NFPA 10

Fire extinguishers shall be professionally serviced or replaced annually, and shall have a current service, inspection or purchase tag attached at the time of the inspection. Section 906.2 and NFPA 10.

_____ Fire extinguishers must be located in a conspicuous location where they will be readily available for use. Section 906.5

_____ Portable fire extinguishers may not be obstructed or obscured from view. Section 906.6

Extinguishers not housed in cabinets shall be installed on hangers or brackets supplied. Section 906.7

____ Extinguishers shall be mounted so that the top is no higher than 5 feet above the floor and the bottom is no less than 4 inches above the floor. Section 906.9

EXITS AND EGRESS

_____ Egress doors shall be operable from the egress side without the use of a key or special knowledge or effort. Section 1008.1.8

____ Exits shall not be obstructed in any manner and maintained fully operable. Section 1001

Egress windows shall be operable from the egress side without the use of a tool or special knowledge or effort. Section 1025.4

____ Each sleeping room shall have at least one unobstructed egress window of suitable size to allow emergency egress. A room with only one window is not allowed to be covered with an window air conditioner. Section 1025.1

_____ Basement bedrooms must meet egress requirements per the NYS Building Code and must be approved.

FIRE DETECTION AND PROTECTION

_____ All fire detection, protection and safety equipment shall be operable at all times. Section 901.6

____ Each sleeping room shall have an operable smoke detector located in an appropriate location within and one operable smoke detector and carbon monoxide detector located immediately outside each sleeping area. Section 907.2.10.1.2 New 2013

If the house is heated by forced air, a carbon monoxide detector must be installed inside each bedroom also.

_____ There shall be at least one smoke detector on each floor level and the basement (excluding crawl spaces and attics). Section 907.2.10.1.2

_____ There shall be a carbon monoxide detector within 15 feet of a sleeping area on each level with a fuel burning appliance, fireplace, or attached garage. Section 610

_____ Fire doors and smoke barrier doors shall not be blocked or obstructed or otherwise made inoperable. Fire door assemblies shall not be modified. Section 703.1

Swinging fire doors shall close from the full open position and latch automatically. The door closer shall exert enough force to close and latch the door from any partially open position. Section 703.2.3

_____ Fire and emergency service phone numbers along with the rental property address shall be posted next to or on each phone. Section 404

HOUSEKEEPING

Storage of combustible materials shall be maintained in a neat, orderly and safe manner. Section 315.2

_____ Storage of combustible materials shall be separated from heaters or heating devices by a safe distance of 36 inches or more so that ignition cannot occur. Section 305.1 and section 305.2

____ Combustible materials shall not be stored in exits, exit enclosures or under unprotected stairwells. Section 315.2.2

____ Combustible materials shall not be stored in boiler rooms, mechanical rooms or electrical rooms. Section 315.2.3

_____ Appropriate collection containers shall be provided for waste and garbage. Section 304.3

____ Combustible waste containers larger than 40 gallons shall have lids and must be made of non-combustible materials. Section 304.3.2

____ Dumpsters shall not be located within five feet of combustible walls or eaves. Section 304.3.3

_____ Materials susceptible to spontaneous ignition, such as oily rags, shall be stored in listed disposal containers with self closing lids and removed and disposed of daily.

_____ Storage of flammable and combustible liquids and gases shall be maintained in a safe and orderly manner. In no case shall flammable liquid or gases be stored below grade or in a basement.

ELECTRICAL

Portable un-vented fuel-fired heating equipment shall be prohibited. Section 603.4.1

____ Extension cords shall not be a substitute for permanent wiring and are not allowed except for portable equipment. Section 605.5

_____ A working space of not less than 30 inches in width, 36 inches in depth and 78 inches in high shall be provided in front of electrical service equipment (panel). Section 605

____ Open junction boxes, open electrical panel slots, open wiring splices shall be prohibited. Approved covers shall be provided for all such devices. Section 605.6

____ Multi-plug adapters, such as cube adapters or un-fused plug strips are not allowed. Section 605.4

MISCELLANEOUS

_____ All buildings shall have the approved 911 address posted so that it is clearly visible from the street in 4 inch numbers that have a stroke of .5 inches and contrast with their background. Section 505.1

_____ The building owner shall be responsible for ensuring that the fire and life safety systems are maintained in operable condition at all times. PMC 701.2

____ A approved diagram depicting two evacuation routes shall be posted on or immediately adjacent to every egress door of every sleeping unit.

This is similar to the diagrams seen on the back of hotel room doors. Section 404

_____ The premises shall be maintained in a clean, sanitary and safe manner. PMC Section 301.2

_____ No bedroom requires passing through another bedroom as the only means of entrance and every bedroom has an available bathroom without passing through another bedroom. PMC Section 404.4.2

POOLS/HOT TUBS

Pools and hot tubs must be provided with a barrier at least 48 inches in height, with a locking gate per the Property Maintenance code Section 303. Spas or hot tubs with a locking safety cover that complies with ASTM F 1346 shall be exempt from the provisions of this section. The cover must have the appropriate warning labels and safety information visible to the inspector. A power disconnect is also required to be placed at least 5 feet from the hot tub. A permit and electrical inspection will be required to install the power disconnect. Please contact our office for more information on pool and hot tub requirements.

* Exception: Carbon Monoxide Detectors are not required in dwellings where there are no fuel burning appliances and no attached garage. All appliances and heat are electric.
