REGULAR SESSION FIRST DAY

Wednesday, April 5, 2017

The Board Chair called the Board to order, the roll was called and the following Representatives were found to be present:

Frazier, Clark, Stammel, Kennedy, Oberacker, Bliss, Marietta, McCarty, Koutnik, Gelbsman, Carson, Stuligross.

Board Chair Clark asked everyone to observe a moment of silence for past Board Representative Betty Anne Schwerd.

Under Privilege of the Floor, Maria Ajello, concerned tax payer and County Employee, read an editorial on past Board member Betty Anne Schwerd noting that she was a beacon of light and was the only one that stood up for her and Bob Force. Mrs. Ajello apologized to the County Attorney stating that it was not her that was supposed to make the announcement at the delinquent tax auction but the Treasurer, also noting that sole discretion turns into discrimination, and asked that the County convene an Ethics Board and restore her home and land to her.

Stacie Haynes, Westford, NY, Executive Director of the Susquehanna Animal Shelter stated that they received a donation of \$2,500 and matched an additional \$2,500 to purchase 2 pet oxygen masks for every fire department in the County as well as 2 extra masks that will be located at the Emergency Services department.

Russ Ahrens, concerned tax payer and County employee stated that Otsego County is not equally taking properties and there is discrimination. Mr. Ahrens stated that on County Highway 26 the speed limit is too high and the safety committee should do something about it to save lives.

Under Special Presentations, Tolga Morawski from the Mohawk Valley Landbank, distributed for filing with the Clerk of the Board, a report on the Land Bank Community Revitalization Initiative from the Attorney General. Mr. Morawski stated that they applied for \$2 million in funding and were awarded \$1.64 million noting that the land bank is working hard on setting policies, creating documents, setting up committees, and looking at priority projects for target areas.

The reports of the Standing Committees were given and ordered filed.

During the report on the Intergovernmental Affairs Committee, Representative Marietta requested that the following be put on the record:

The Otsego Now Strategic Plan relates the following: "The primary roles of a not-for-profit board involve policy formulation, organizational oversight, financial stewardship and advocacy on behalf of the organization. Based on this strategy, these are the Board Priorities for Otsego Now:

1. Improve relationship with County to improve effectiveness of Board member recruitment and development process to provide adequate diversity of member demographics, skills, etc.

Under its current legal structure, members of Otsego Now's board are appointed by the County's legislative body, the Board of Representatives. In order to ensure that Otsego Now's Board has access to the skills and experience needed to further its economic development mission, the Board must always have a close productive relationship with the County Board of Representatives. This will enable the County Board to understand the needs of Otsego Now and allow the two organizations to recruit and nominate members to Otsego Now's board that have the background and experience required of that organization. This will also require the Otsego Now Board to have a ready understanding of its needs with respect to board membership so that these can be communicated to the Board of Representatives. As part of preparing the Otsego Now Board to better understand its needs, a board recruitment matrix is included as a guide for considering the skills and other types of characteristics desired of board members." I again request the Board Skill Inventory from Otsego Now be provided to the Otsego County Board in the best interest of our partnership and as outlined in this plan.

In addition, the County of Otsego Industrial Development Agency bylaws mandate the following:

Article 2, Section II titled Responsibilities of Members; Training Requirement Subsections:

F) Members of the Agency shall file annual financial disclosure statements with the Otsego County Board of Ethics.

G) Individuals newly appointed to the Board of the Agency must participate in state approved training regarding their legal, fiduciary, financial and ethical responsibilities within one year of appointment to such Board. Existing Members shall participate in such continuing training as may be required to remain informed of best practices, regulatory and statutory changes relating to the effective oversight of the management and financial activities of public authorities and to adhere to the highest standards of responsible governance.

With a number of new board members joining Otsego Now's board, I just want to confirm board members are filing their disclosures and fulfilling their mandated training. Otsego Now is an essential partner for Otsego County, and we need to continue to improve on this partnership and ensure board members elected by Otsego County are getting the support they need. I am also looking for clarification on the Otsego County Board of Ethics and its status and the filing of financial disclosures with this entity.

Ellen Coccoma, County Attorney stated that each public authority files a report to the State and it is the responsibility of each specific Board.

Under the Administration Committee report, Representative Marietta requested the following be put on the record:

Board Meeting recordings issues to address (as raised at the February 2017 Administration Committee meeting):

- the time it takes to post the recordings
- editing
- how to handle being in and out of session
- what other municipalities are doing
- how recording may affect the quality of the discussions being had
- The committee discussed listening to a sample recording

I continue to make my request for approving the use of the board meeting recordings already being made and posting them online.

Again, I also am asking for clarification on the Otsego County Board of Ethics status.

RESOLVED, that the "Otsego County Strategic Prioritization Plan", authored by Laberge Group (November 22, 2016) and on file with the Clerk of the Board of Representatives is hereby approved.

LOCAL LAW NO. A of 2017 COUNTY OF OTSEGO, NEW YORK

A LOCAL LAW TO PROVIDE FOR THE INSTALLMENT PAYMENT OF ELIGIBLE DELIQUENT TAXES PURSUANT TO REAL PROPERTY TAX LAW SECTION 1184

BE IT ENACTED by the Otsego County Board of Representatives as follows:

SECTION 1. DEFINITIONS

As used in this local law:

A."Eligible delinquent taxes" means the delinquent real property taxes, including interest, penalties and other charges, which have accrued against a parcel as of the date on which an installment agreement is executed.

B. "Eligible owner" means an owner of real property who is eligible to or has entered into an installment agreement.

C. "Enforcing Officer" means the Otsego County Treasurer.

D. "Installment agreement" means a written agreement between an eligible owner and the Enforcing Officer providing for the payment of eligible delinquent taxes in installments pursuant to the provisions of Section 1184 of the Real Property Tax Law and this local law adopted thereunder.

SECTION 2. APPLICATION

This local law shall apply to all classes of properties within Otsego County.

Installment payment of eligible delinquent taxes shall be available to each eligible owner on a uniform basis pursuant to the provisions of Real Property Tax Law section 1184 and this local law. Installment payment of eligible delinquent taxes shall commence upon the signing of an installment agreement between the Enforcing Officer and the eligible owner, which agreement shall be kept on file in the office of the Enforcing Officer.

SECTION 3. INSTALLMENT AGREEMENT PROVISIONS

Such installment agreement shall provide:

A. A maximum term, which shall not exceed twelve months;

B. A payment schedule, which shall be monthly, bimonthly, quarterly or semi-annually;

C. A required initial down payment, which shall not exceed 25 per cent of eligible delinquent taxes, although an eligible owner may make a larger initial down payment if the eligible owner so chooses;

D. Such other terms and conditions consistent with the provisions of Real Property Tax Law section 1184 and this local law as the Enforcing Officer shall deem appropriate in the best interests of Otsego County.

SECTION 4. RESTRICTIONS

A property owner shall not be eligible to enter into an installment agreement where:

A. there is a delinquent tax lien on the same property for which the application is made or on another property owned by such person and such delinquent tax lien is not eligible to be made part of the agreement pursuant to this local law;

B. such person is the owner of another property within the county on which there is a delinquent tax lien, unless such delinquent tax lien is eligible to be and is made part of an installment agreement pursuant to this local law;

C. such person was the owner of a property on which there existed a delinquent tax lien and which lien was foreclosed within three years of the date on which an application is made to execute an installment agreement pursuant to this local law; or

D. such person defaulted on an agreement executed pursuant to this local law within three years of the date on which an application is made to execute an agreement pursuant to this local law.

SECTION 5. ELIGIBILITY DATE

A property owner shall be eligible to enter into an installment agreement no earlier than thirty days after the delivery of the return of unpaid taxes to the Enforcing Officer.

SECTION 6. AMOUNT DUE

The amount due under an installment agreement shall be the eligible delinquent taxes plus the interest that is to accrue on each installment payment up to and including the date on which each payment is to be made. The agreement shall provide that the amount due shall be paid as nearly as possible in equal amounts on each payment due date. Each installment payment shall be due on the last day of the month in which it is to be paid.

SECTION 7. INTEREST AND PENALTIES

Interest on the total amount of eligible delinquent taxes, less the amount of the down payment made by the eligible owner shall be that amount as determined pursuant to Section 924 (a) of the Real Property Tax Law or such other law as may be applicable. The rate of interest in effect on the date the agreement is signed shall remain constant during the period of the agreement. If an installment is not paid on or before the date it is due, interest shall be added at the applicable rate for each month or portion thereof until paid. In addition, if an installment is not paid by the end of the fifteenth calendar day after the payment due date, a late charge of five percent of the overdue payment shall be added.

SECTION 8. DEFAULT

A. The eligible owner shall be deemed to be in default of the installment agreement upon:

(i) Non-payment of any installment within thirty days from the payment due date;

(ii) Non-payment of any tax, special ad valorem levy or special assessment which is levied subsequent to the signing of the agreement by the tax district, and which is not paid prior to the receipt of the return of

unpaid taxes by the Enforcing Officer, or

(iii) Default of the owner on another installment agreement made and executed pursuant to this local law.

B. In the event of a default, the Enforcing Officer shall have the right to require the entire unpaid balance, with interest and late charges, to be paid in full. The Enforcing Officer shall also have the right to enforce the collection of the delinquent tax lien pursuant to the applicable sections of law, special tax, charter or local law.

C. Where an eligible owner is in default and the Enforcing Officer does not either require the eligible owner to pay in full the balance of the delinquent taxes or elect to institute foreclosure proceedings, the Enforcing Officer shall not be deemed to have waived the right to do so.

SECTION 9. NOTIFICATION OF POTENTIAL ELIGIBLE OWNERS

A. Within forty-five days after receiving the return of unpaid taxes from the collecting officer, or as soon thereafter as is practicable, the Enforcing Officer shall notify by first class mail all potential eligible owners of their possible eligibility to make installment payments on such tax delinquencies. The Enforcing Officer shall add one dollar to the amount of the tax lien for such mailing.

B. The failure to mail any such notice or the failure of the addressee to receive the same shall not in any way affect the validity of taxes or interest prescribed by law with respect thereto.

C. The Enforcing Officer shall not be required to notify the eligible owner when an installment is due.

SECTION 10. TAX LIEN

The provisions of this local law shall not affect the tax lien against the property except that the lien shall be reduced by the payments made under an installment agreement, and that the lien shall not be foreclosed during the period of installment payments provided that such installment payments are not in default.

SECTION 11. EFFECTIVE DATE

This local law shall take effect immediately upon the filing of this local law with the Secretary of State.

This local law is offered by the Administration Committee.

Seconded, Koutnik. Local Law laid over under the rules until Wednesday, May 3rd, 2017 at 9:45 a.m.
