Residential Trash and Recyclables Collection Frequently Asked Questions

Does the trash need to be in a container?

Trash should be placed at curbside in containers to prevent strewn trash that can result from broken and torn bags (i.e. from animal interference). At this time, regular household trash that is placed at the curb in bags will still continue to be collected.

Does the container need to be only 32 gallons?

While the City's ordinance does specify a 32-gallon trash container, we understand that residents may currently utilize various sizes to dispose of their trash. As such, trash containers that are less than 96-gallon receptacles are OK and collection will still occur. Collection will not occur for 96-gallon or larger containers.

How many containers for trash can one household have?

There is no limit on the number of containers.

What time should my trash and recyclables be placed at the curb?

Trash and recyclables should be placed at the curb by 7:00 a.m.

What happens if my current receptacle gets damaged?

Trash containers should be removed from curbside promptly (or as soon as feasibly possible) after collection to prevent inadvertent displacement into roadways and potential damage. If you suspect damage has occurred by the collector, please report to the Department of Public Services and Utilities, 413-499-9330.

Damaged recycling bins can be replaced at no cost at 100 North Street (Floor M (Mezzanine Level) – Department of Public Utilities) and at City Hall – Clerk's Office, 70 Allen Street. The damaged bin will be collected at curbside for disposal.

Where can I get a recycling bin? Are they free?

Recycling bins are provided by the City at no cost. They are available at 100 North Street (Floor M (Mezzanine Level) – Department of Public Utilities) and at City Hall – Clerk's Office, 70 Allen Street.

Can we only use the City-issued blue recycling bins for recycling?

Other bins are acceptable, but should be clearly identified to the collector. Up to a 32-gallon container can be used for glass/plastic/can recyclables; separated recyclables should not be placed in plastic bags.

What items are able to be recycled?

Cardboard boxes should be flattened to a maximum size of 2' x 2' (the size of the cardboard is necessary for the truck equipment) and placed in a recycling bin. Cardboard not placed in a recycling bin will not be collected.

What do I do if an item doesn't fit in a trash container?

Large items such as mattresses, wood furniture, vehicle tires, chairs, etc. are considered bulky waste and will need a Bulky Waste Sticker for disposal. Stickers can be purchased for \$15 at Carr Hardware, Price Chopper in Pittsfield and Lenox, Harry's Supermarket on Wahconah Street, Elm Street Hardware, Pittsfield City Hall – City Clerk's Office (1st floor), 100 North Street (Floor M (Mezzanine Level) – Department of Public Utilities).

Additionally, large items can be taken to Covanta (there is a disposal fee) located at 500 Hubbard Ave. Hours of operation are: 7:30-11:45 a.m. Saturdays and 7 a.m.-3:45 p.m. Monday through Friday.

What if I am disabled and can't get my trash and recycling to the curb?

Please know the City offers a program, the Backyard Collection Initiative, which provides a pick-up service to those unable to get their trash to the curb. A link to the application is available here:
