PURPOSE OF USE _____

THE RENTER AGREES:

1. Not to bring or consume alcoholic beverages on the premises.
2. Not to allow smoking on the premises.
3. To accept the premises in its present condition and return it in like condition.
4. To clean the premises and remove all trash to the large dumpster
5. To reimburse the Township of Richland for any damages to the premises, building and equipment.
6. To vacate the premises at the scheduled time.
7. To notify the Township offices at least 24 hours in advance of any cancellation. Failure to notify will result in full payment for the scheduled time. fees are to be paid 72 hours or hold is released.
8. Township use has priority over any other use. The Township reserves the right to cancel any reservation when a Township event takes precedent.
9. The Township reserves the right to have a representative present at any time.
10. The Township reserves the right to refuse use to anyone who previously abused the premises.
11. To provide the Township with a **Certificate of Liability- Insurance** for the date of use **naming Richland Township as certificate holder.**
12. Applicant must be at least 21 years of age.

Richland Township does not refund money for events that have been cancelled due to "Acts of God" or inclement weather; however, the Renter's event may be rescheduled pending availability and upon approval by Richland Township. Additional fees may apply.
