## A RESOLUTION TO PROVIDE FOR ALTERNATIVE STARTING DATES FOR THE MARCH 2024 BOARD OF REVIEW

WHEREAS, the Township Board of Review of Richland Township, Kalamazoo County, Michigan is required by MCL 211.30 to meet on the second Monday in March, 2024 unless such date is changed by ordinance or resolution in accordance with the authority granted in MCL 211.30 (2); and

WHEREAS, in accordance with MCL 211.30 (2) "the governing body of the city or township may authorize, by adoption of an ordinance or resolution, alternative starting dates in March when the board of review shall initially meet, which alternative starting dates shall be the Tuesday or Wednesday following the second Monday of March"; and

WHEREAS the Township Board of Richland Township deems it expedient and lawful to provide for an alternative starting date for the March 2024 Board of Review.

NOW THEREFORE, BE IT HEREBY RESOLVED that the Richland Township Board designates the Tuesday following the first Monday of March 2024 as the start date for the Richland Township Board of Review. (Organizational meeting is <u>Tuesday March 5, 2024</u>). The first meeting for hearing review requests shall be the Tuesday following the second Monday of March, 2024. (Review hearings commence on <u>Tuesday March 12, 2024</u>). The Township Board of Review shall in all other respects comply with the provisions of MCL 211.28- 211.33, as amended.
