Please read the following carefully and initial next to each line stating that you understand and agree to comply with **City of Saginaw Animal Control Ordinance No. 2023-26 Multi Pet Permit & Foster Permit. The cost for this application is \$50.00 plus the cost of registrations \$10 per animas. I understand that this fee was set by City Council and must be paid annually prior to receiving my permit. These fees will be due once all inspections have been completed and passed.**

_____ I the undersigned understand except as provided by this Section, no residence within the City shall harbor more than five (5) adult dogs, five (5) adult cats, or 5 adult dogs or cats in any combination (for example 4 dogs and 1 cat, or 4 cats and 1 dog). No residence within the City limits shall harbor more than one litter of puppies or kittens over the age of 4 months of age at any given time

_____ I the undersigned understand any person desiring to keep more than five (5) adult dogs and/or cats or more than one litter of puppies or kittens at a residence may apply with the animal control authority for a multi-pet permit allowing them to keep two (2) additional dogs or cats ("service animals" as defined in Sec. 6-32 will be counted in this number and are not exempt from registration). The applicant shall pay an application fee for permit once it has been processed and all inspections have passed.

_____ I the undersigned am the current owner of the property listed above, I understand that if I am a renter/tenant of the property, I must provide a notarized letter from the property owner stating permission for the pets on the premises. This permission must be written, notarized, and must be provided annually or upon request of the animal services manager or their designee.

_____ I also understand this permit may be revoked by the animal control authority for cause, including but not limited to, violations of the provisions of this Section or the inability of the permit holder to keep the animals in a healthy and sanitary environment.

_____ I understand that this permit must be renewed annually and each renewal will require an inspection and approval by the animal control authority or its designee.

_____ I understand that this permit is issued for specific owners of a specific property, and a application for a new permit will be required if the original permit holder moves to a new residence within the City limits and wishes to keep more than five (5) adult dogs/cats or more than one litter of puppies or kittens, or ownership of the property for

which the permit was originally issued changes and the owners/tenants desire to keep more than five (5) adult dogs/cats or more than one litter of puppies or kittens

_____ I understand that this permit requires all animals on the premises to be sterilized, proof of sterilization will be required at time of application (example Letter from vet or marked on rabies certificate)

_____ I understand that all animals at the residence will be microchipped and that chip will be registered with a national database and proof will be required at time of application

_____ I have received a copy of Ordinance No 2023-26 Multi-pet Permit & Foster Permit from the City of Saginaw Animal Services Department, and that if found in violation of this Ordinance more than twice in a twelve (12) month period this permit will be revoked and all animals over the allowed number of animals (5 dogs or 5 cats, or any combination totaling 5) will need to be removed for a period of 12 months

I, hereby certify that the above information is true and correct. I have read and initialed this document and understand that this permit allows me to keep the above listed animal within the City limits of Saginaw and that if found in violation of this ordinance more than (2) times within a twelve (12) month period, my permit will be revoked
