A Message from the Economic Development Department

"How to Make a Great Taco"

The winter holiday season is now behind us, and the summer months are just around the corner. I can't help but think about all the outdoor grilling possibilities that have opened up for me with the weather change. As a born and bred Texas Hill Country fella, tacos are one of my favorite foods. In fact, they might be at the top of my food pyramid. You really can't go wrong with tacos because they are so simple: gather a flour or corn tortilla, add some form of meat and/or veggies, and heaven awaits. ¡Muy delicioso! Economic Development may be a little less straightforward than making tacos, but it doesn't have to be difficult. All you really need are just a few key ingredients that can make all the difference in a community's success. After reading a great article by Dane Carlton on the Economic Development Show, I decided to share some of his words and explain how Saginaw, Texas has



been putting his wisdom into action.

Each community must, or at least should, have an economic development plan. An economic development plan is a strategy-driven plan that helps communities realize their strengths, weaknesses, opportunities and threats. It also provides vision, sets clear and attainable objectives, as well as policies and programs to achieve them. About seven years ago, the City of Saginaw changed their development philosophy to a renewed focus on proactive economic development. In 2016, a previous Saginaw City Council had the foresight to meet with an Economic Development Consultant to devise a detailed Economic Development Plan specifically for Saginaw, Texas. The purpose and goal of this concentration was to improve the Saginaw citizen's quality of life, drive new sales tax dollars to the community, and to keep Saginaw residents dining/shopping in the community, as well as bring new consumers to Saginaw from surrounding areas. This initial plan is what we currently honor and follow.

However, Economic Development Plans are a lot like Texas weather in that they are always changing. Demographics change. Interests' change. Economics change. How we keep our plan updated is that we "*listen*" to our citizens. Citizens are the most important agents of change in Economic Development in our community and that is why we choose to involve them. Here are some recent examples of how our citizens have helped shape Saginaw, Texas:

- *In 2018*, the City of Saginaw hosted a "Citizen's Summit". Our residents provided comments about their thoughts of the city and what changes they would like to see. They also said that they wanted more sit-down restaurants, fast-casual restaurants, retail and entertainment options.
- *In 2019*, the City of Saginaw published an Economic Development specific "Eat and Play Survey" online seeking feedback on our resident's consumer patterns, requested retailers, and additional comments. The results of this survey were crucial for staff with their recruitment of businesses to Saginaw.
- *February 2020 to present*, the Economic Development Staff receive emails, phone calls and have personal conversations on a daily basis with our residents who profess what type of commercial businesses (restaurant, retail, entertainment) they would like in Saginaw.

The City of Saginaw felt it was more inclusive and a better development practice to engage residents and ask exactly what it is that they want. The 2019 citizen's survey was imperative for City Staff because it gave the city a clear path on what our residents actually want (more sit-down restaurants, fast-casual restaurants, retail and entertainment options). We couldn't do this without their help and guidance.

Every community is unique with distinct strengths, weaknesses, opportunities and threats and Saginaw is no different. Economic Development does not lend itself to cookie-cutter solutions. College textbooks provide you with theory and opinions but not necessarily "real-world" solutions because every community is very different. Below are some real-world, essential ingredients that every community should consider:

#1 Business Retention & Expansion

- For most communities, about 80% of new jobs added will come from companies already in your community. Pay attention to your existing companies first. Work to make them efficient and healthy before turning your attention to attracting outside investment.
- Don't walk past an old friend to meet a new one. Too many communities focus too much on attracting the next new thing. For most communities, "recruit-recruit-recruit" should not be the primary focus of their economic development efforts. Take care of what you already have.
- Shop Local! Shop Saginaw!

#2 Education and Workforce

- Your education system and workforce are the key engines of your community. We are blessed to have an amazing public school system in the Eagle Mountain-Saginaw Independent School District as well as an upper-level education opportunity with Tarrant County College-Northwest Campus right here at our doorsteps.
- In a recent survey, corporate executives ranked the 25 most critical site selection factors. The three most important factors were labor availability, labor costs and quality of life, rated as important or very important by 95+% of respondents.
- City leaders, educators and the business community should always look for ways to partner and work together. It is critical for your community's success.

#3 Appearance

- What your community looks like matters for the people and companies you already have as well as the people and businesses you want to attract. Give people a reason to care instead of just asking or telling them to care. Tourists, prospective residents, and companies don't want to go to communities that, quite frankly, don't care about themselves.
- A few years ago, the City of Saginaw made an important decision to reinvest in existing businesses by creating a Building Improvement Grant Program. This grant program provides matching grants to reimburse commercial property owners or business operators for eligible enhancements/improvements made to their properties. Thus far, we have received 27 grant applications and have awarded over \$116,000 in grants. At the same time, those businesses have invested over a half a million dollars in improvements to their own businesses. This award-winning program has been a model that other communities across the state of Texas mirror and duplicate.

#4 Quality of Life

- It is a proven and well documented fact that families, companies and commercial businesses will relocate to your community based on its amenities (parks, recreation, entertainment, food/retail, education, etc.). Younger generations increasingly choose where they want to live first, move there, and then worry about getting a job. Your community needs something to offer regarding the high-priority quality of life factors. Quality of life is very important.

Okay, so I didn't talk much about tacos. Quite frankly, there are a million delicious recipes on the internet and YouTube by accomplished chefs and by people like you and me. If you like tacos, they are all good. In a way, Economic Development has a simple, yet easy to follow recipe too. The four key ingredients are Business Retention and Expansion, Education and Workforce, Appearance, and Quality of Life. The main and most important ingredient is quite simple: just listen. Don't talk...listen to your citizens and business community. It's also important to remember that every community is different and not "cookie-cutter". Just because one community does things a certain way doesn't mean that it will work in your community. One of the main differences between tacos and economic development is that while tacos can get quite messy, Economic Development and communities can be born again and become better than ever.

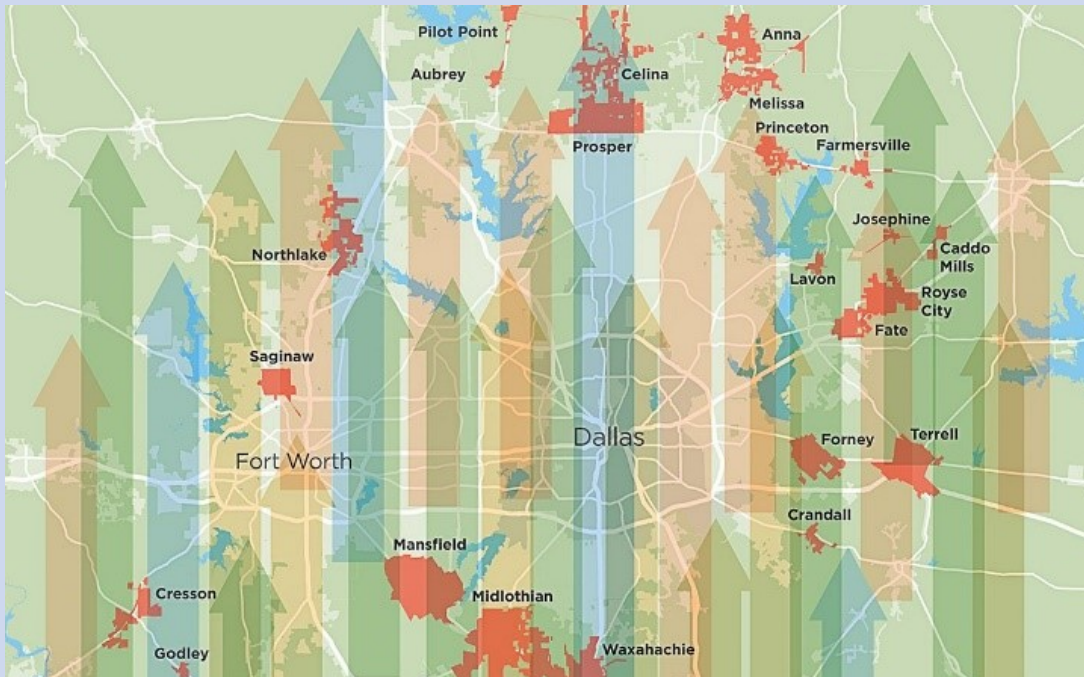

Miller Milling Plans Flour Mill Expansion in Saginaw!

Only four years after completing a major expansion at its Saginaw, Texas, flour mill, Miller Milling said it is planning another major expansion that will increase the plant’s daily capacity by 10,000 cwts (cwts = hundred

weight; 1 hundredweight equals 100 pounds). The Saginaw mill also underwent a capacity expansion of 10,000 cwts, to 24,000 cwts, that was completed in 2019.

When the upcoming expansion is complete, the Saginaw mill will be the largest in Texas, ahead of Ardent Mills' facility in Saginaw, which has daily production capacity of 27,500 cwts. **The increase will make the Saginaw flour mill the third largest in the United States at 34,000 cwts of daily flour production capacity**, behind North Dakota Mill in Grand Forks, North Dakota (54,500 cwts) and Ardent Mills' plant in Hastings, Minn. (35,260 cwts), according to Sosland Publishing Co.'s 2023 Grain & Milling Annual.



This has been a long process. The Saginaw Economic Development Staff has been talking with Miller Milling for about 8 or so months. We made it down to be a finalist along with a city in Alabama. I came down to either building a new facility from scratch or expanding. The City of Saginaw pleaded our case, visited with quite a number of their executive team in interviews, and provided more than enough commentary and information. Fortunately, they chose us. **THIS IS A BIG DEAL FOR SAGINAW, TEXAS!**

Saginaw Sales Tax Revenues

The State of Texas imposes a 6.25 percent state sales and use tax on all retail sales, leases and rentals of most goods, as well as taxable services.

Local taxing jurisdictions (cities, counties, special purpose districts and transit authorities) can also impose up to 2 percent sales and use tax for a maximum combined rate of 8.25 percent.

- .125 cent Street Maintenance Sales Tax
- .375 cent Crime Control and Prevention District
- 1.5 cents of our state-allowed 2 cent total goes to General Fund Operations

Sales Tax Revenues have continued to increase year after year in Saginaw. The City of Saginaw municipal year is based on October through the following September.



Below are Fiscal Year Sales Tax Revenues as reported by the Texas State Comptroller's Office:

FISCAL YEAR SALES TAX – “Revenues”:

- Fiscal Year 2022-23 Total Revenues = \$2,636,687.85 – through January 2023 (11.57% increase from the previous year = \$273,432.21 more than the same 4 months last year)
- Fiscal Year 2021-22 Total Revenues = \$7,762,572.97 (7.27% increase from previous year)
- Fiscal Year 2020-21 Total Revenues = \$7,236,582.55 (21.46% increase from previous year)
- **Fiscal Year 2019-20 Total Revenues = \$5,957,804.98 (6.72% increase from previous year)
- Fiscal Year 2018-19 Total Revenues = \$5,582,848.90 (6.73% increase from previous year)
- Fiscal Year 2017-18 Total Revenues = \$5,257,738.16 (3.19% increase from previous year)
- Fiscal Year 2016-17 Total Revenues = \$5,091,389.00 (6.91% increase from previous year)

- Fiscal Year 2022-23 Monthly Average: \$686,646.96 (through December: 3 months)
- Fiscal Year 2021-22 Monthly Average: \$646,881.07

Building Improvement Grant

We Are Re-Investing in Saginaw Businesses!

Who is this program for? This **2021 and 2022 Texas Economic Development Council Award Winning Program** is for any commercial business in the City of Saginaw that is looking to enhance their existing site visually, or in ways that increase the viability of the property for business use. This includes uses allowed in the zoning classifications: Community Commercial, Neighborhood Commercial, Office Professional, Light Industrial, Heavy Industrial, and within Planned Developments. This program provides matching grants to reimburse commercial property owners or business operators for eligible enhancements made to their properties.



There are 10 different categories of improvements that are eligible for consideration as part of this grant program that include: Façade Enhancements, Interior Building Renovations, Landscaping, Lighting, Parking Areas and Driveways, Pedestrian Amenities, Signage, Code Compliance, Demolition and Public Art Installation.
