#### PUBLIC HEARING BEFORE THE SMYTH COUNTY BOARD OF SUPERVISORS

The Smyth County Board of Supervisors will conduct a public hearing on Tuesday, January 14, 2014 at 6:00 p.m. or soon thereafter, as may be heard, in the Smyth County Office Building, 121 Bagley Circle, Marion, Virginia, to consider the following nuisance complaints pursuant to §15.2-900 et. seq. of the Virginia Code, (1950), as amended and by authority of Smyth County Code, Article 3, Section 20. Sec. 20-66 requires publication in cases where the property owner is unknown or the county has been unable to contact the owner. Those with an ownership interest in the properties below should appear at the hearing. If a property is declared a public nuisance, the property owner may be required to abate or raze the nuisance at his/her cost. If the County

takes action to remove the nuisance, the cost will be charged to the owner and is a lien against the property ranking on parity with real estate taxes. Failure to pay any nuisance abatement charges may result in the property being sold for delinquent real estate taxes and nuisance abatement liens pursuant to §58.1-3965.

At this public hearing, subject to the rules of procedure of the Board of Supervisors of Smyth County, Virginia, any person may appear and state his/her views thereon. Chairman Blevins opened citizen's time; the following citizens addressed the Board: Sara Combs – wanted to re-emphasize to the Board the importance of cellular telephone service in the Sugar Grove area and update on what she has done and inquired as to what the Board has done towards this effort. Mr. Carter explained the contacts which he has made over the last few weeks and that he is awaiting responses for the providers.

Earl McClure – Wants the Board to address the filth and such at the convenience stations, the citizens should not have to deal with that when dropping off their waste.

Chris Stone – Echoed the cellular service request for the Sugar Grove community.

Carl Keyes – Also wanted to support the cellular service request for the Sugar Grove community.

No one else wished to speak; Chairman Blevins closed citizen's time.

Chairman Blevins recognized newly elected Delegate Jeff Campbell. Delegate Campbell reviewed with the Board his pre-filed Bills: an Economic Development bill which leaves 1% of the sales tax with the Locality to be used specifically for Economic Development efforts. A second bill which will adjust the per diem rate at the regional jails so that County rates and State rates are more equal; and thirdly, a minor District line adjustment which would place approximately 80 people into the 5th District from the 6th District, this should correct a large voting problem which is occurring in this area. Delegate Campbell looks forward to working with the County leaders in the upcoming term of office.

Chairman Blevins recognized Jeff Richardson, Commissioner of Revenue. Mr. Richardson addressed the continued item related to the need to establish a Land Use Application Fee. He now proposes an application fee of between \$ 15 and \$ 25. A \$ 15 fee will generate the approximate budgeted amount of revenues for the program this year. Mrs. Clayton reminded the Board that this program is governed by Ordinance, and any changes to it will need to be adopted as a change in the ordinance. The previous approval for the 90 day extension was also a change in the ordinance. In order to accomplish this properly, an Emergency Ordinance will need to be considered, and be followed up by the permanent Ordinance changes and adoption.

County Administrator Michael Carter updated the Board on the Green Acres revenue sharing project. At inception, VDOT had generated a cost estimate of \$ 375,000 for the project; this estimate was used as a basis for the residents and the County to make a decision on the feasibility of the project and their intentions to move forward with it. Seth and Brandi Heath – Special Use Permit for Service Business in the Agricultural/Rural District: At approximately 7:03 p.m. Mr. Williams explained an application for a Service Business for parking snow removal trucks on properties owned by Seth and Brandi Heath surrounding 1087 Porter Valley Road and 1217 Fox Valley Road in Marion. He stated the properties are zoned Agricultural/Rural. He directed the members to Section 3-2.2 v) which allows the proposed use by the issuance of a Special Use Permit, Section 10-65 which defines a Service Business, Article 6 which contains the provisions for a Special Use Permit. He stated he advertised notice of this public hearing in the Smyth County News on December 7 and 14. In addition, he sent letters to all of the adjoining property owners for which an affidavit is on file. He received one letter which he read for the record from Alice and Isaac Freeman, attached hereto. He pointed out the letter received from Seth and Brandi Heath explaining their request for the service business which was included in the packets each member received prior to the meeting.

Seth and Brandi Heath were present to address any questions regarding their request. Mrs. Heath stated their business has grown and they have been awarded a snow removal contract by VDOT from exit 17 to exit 54. Describing her business, Mrs. Heath said the proposed sites would simply be used as parking lots. When the equipment isn't needed, it will be parked on the property. In the event it is needed, employees' vehicles will replace the equipment while it is being used. Other than minor maintenance, (i.e.

windshield wipers, tire inflation, etc.), Mrs. Heath stated all maintenance of their equipment would be done by offsite repair garages.

Regarding the brine and salt used, she stated it was stored at VDOT centers in Glade Spring and Atkins and would not be stored on either property. They clarified they are not currently removing snow on local roads, such as Fox Valley Road. They are strictly on I-81. Realizing there may be a concern about the speed their trucks travel, Mrs. Heath stated their trucks are not allowed to go over 25 mph on secondary roads and 45 mph on primary roads. They have 26 trucks and they clean their trucks at the Glade salt storage site. Their contract is good for three (3) years and VDOT can renew the contract on a yearly basis; otherwise, the job is open for bids.

Mr. Wassum and Mr. Williams discussed the differences in uses allowed by right in the A/R zoning district. Mr. Williams suggested any changes Mr. Wassum would like to see made needed to be presented to the Ordinance Committee for discussion. Mr. Wade Blevins concurred with Mr. Williams

Supervisor Ron Blevins stated he went to the property and noted only farm equipment was stored in the buildings located on the properties. Supervisor Todd Dishner commented on how well the property is maintained.

With no one signing up to speak, Chairman Wade Blevins opened the floor for public comments. Several members of the audience expressed a desire to address the Planning Commission and Board of Supervisors. Ms. Rhoten and Ms. Fox stated their concerns of the property going from an agricultural use to a commercial use.

Mr. Williams and Mr. Dishner both explained that the request does not affect any surrounding or adjoining properties. This was not a rezoning request, just a Special Use Permit request. Mr. Williams reminded the neighbors that Mr. and Mrs. Heath were required to get a Special Use Permit for a Rodeo several years ago and that request did not open the door for other businesses. He confirmed the Special Use Permit process is required for almost every business unless it is permitted by right in the Zoning Ordinance.

Kathleen Nicholson spoke in favor of the application and as a adjoining neighbor stated she could verify the equipment was being parked on the property. She added the increase in noise and traffic was insignificant.

**VDOT** Revenue Sharing

Last year, you applied for revenue sharing from the Virginia Department of Transportation (VDOT) to complete the planned round-about at the intersection of Hwy. 11 and Brown Subdivision Road. Subsequently, VDOT decided that they did not want to pursue the round-about, leave the intersection as is, and monitor it as the school year began.

Recently, VDOT approached Smyth County Schools about using the revenue sharing funds to improve the intersection with two turn lanes. From our conversations with VDOT, these turn lanes would improve traffic flow at the intersection but does not improve the traffic flow on Hwy.11 for traffic coming from the Marion area. We discussed the idea of turn lanes with county administration and felt this project should move forward for your consideration.

We have prioritized the turn lanes options in case the funds are limited to one project. Priority one would be to build a turn lane on Brown Subdivision Road as it intersects with Hwy. 11, and priority two would be to build a short turn lane as a vehicle crosses the interstate bridge coming from the Adwolfe area. These projects would be completed based on the approved priorities and if funding is available. The Smyth County share of funding would come from the funds approved for the construction of Oak Point Elementary School and the renovation of Marion Elementary School.

The Smyth County School Board is open to working with you to best meet the needs of the county and the school division on this project. Thank you.
