7.16 Smoking on County Property

Additional smoke breaks are prohibited and are subject to disciplinary procedures.

Revised Policy Effective January 1, 2017: (Adopted by the Board of Supervisors, November 8, 2016) **Tobacco Use on County Property** 7.16

All Smyth County facilities and grounds are tobacco-free. The use of traditional tobacco products (i.e. cigarettes, cigars, pipes, smokeless tobacco, etc.) and non-traditional electronic smoking devices are prohibited on all County facilities and grounds except in the privacy of the employee or visitor's personal vehicle, effective January 1, 2017.
