
Background

- The County may have the opportunity to refinance the 2012 Bond by participating in Virginia Resources Authority's Spring pooled bond issue.
- It is important to note that the County would not have to proceed with the refinancing unless certain pre-determined savings threshold target is met with the refinancing,
- If market conditions change such that the refinancing does not meet the savings threshold target, then the County would not proceed with the transaction and would not incur any transaction costs with respect to the refinancing.
- We have enclosed herein:
- A summary of the current interest rate environment;
- Preliminary refinancing results (assuming participation VRA's Spring pooled bond issue); and
- Next steps for implementing the refinancing through VRA.

Interest Rate Trends

Although interest rates remain near all-time lows, it is impossible to predict how long rates will remain this favorable. Interest rates are capable of rising quickly, as evidenced by the roughly 100 basis point jump that occurred in May to June of 2013 (highlighted below).



The "20-Bond Index" shown above consists of 20 tax-exempt bonds with an average rating of Aa2 / AA (Moody's / S&P) that mature in 20 Years and serves as a general indicator of prevailing interest rates for tax-exempt borrowers.



AN ORDINANCE AMENDING THE SMYTH COUNTY CODE, CHAPTER 2 – ADMINISTRATION, ARTICLE 1, SECTION 2-6, "REVIEW OF CRIMINAL HISTORY RECORD INFORMATION OF APPLICANTS FOR COUNTY EMPLOYMENT,".

WHEREAS, Pursuant to § 15.2-1505.1 of the Code of Virginia (1950), as amended, a locality may be ordinance and in accordance with §19.2-389, require applicants upon offer of employment with the locality to submit to fingerprinting and to provide personal descriptive information to be forwarded for criminal history record information; and,

WHEREAS, notice was properly published for a public hearing held at the regular meeting on January 12, 2016.

NOW, THEREFORE BE IT ORDAINED, by the Board of Supervisors of Smyth County:

1. That the Smyth County Code, Chapter 2, Administration, Article 1 In General, is hereby amended with the addition of Section 2-6 as set forth below:

CHAPTER 2 ADMINISTRATION ARTICLE I. IN GENERAL

Sec. 2-6. Review of criminal history record information of applicants for county employment

(a) The county administrator or his designee shall, in the interest of public welfare and safety, conduct investigations of all applicants to whom a conditional offer of employment is made to determine if the past criminal conduct of all applicants to whom a conditional offer of employment is made to determine if the past criminal conduct of an applicant with a conviction record would be compatible with the nature of the

- employment under consideration, in accordance with Virginia Code §15.2-1505.1, as amended.
- (b) The county administrator or his designee shall require such applicants to submit to fingerprinting and provide personal descriptive information to be forwarded along with the applicant's fingerprints through the Central Criminal Records Exchange and the Federal Bureau of Investigation for the purpose of obtaining criminal history record information.
- (c) Criminal history record information shall be confidential.
- (d) If an applicant is denied employment because of information appearing in his criminal history record, the county administrator or designee shall notify the applicant that information obtained from the Central Criminal Records Exchange contributed to such denial.

Secs. 2-7-2-26. Reserved.

- 2. That should any section or provision of this ordinance be decided to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity or constitutionality of any other section or provision of this ordinance or of the Smyth County Code:
 - 3. That this ordinance shall be effective on the date of adoption.

Please accept this letter as an appeal of the denial of an application for residential real estate tax exemption by the Commissioner of Revenue in connection with real property located at 252 View Drive, Marion, Virginia 24354 (the "Property"). As described in a letter to the Commissioner dated as of January 25, 2016, the Property meets the following requirements for exemption pursuant to Section 23-340 of the Code of the County of Smyth, Virginia: (1) The Property is located within the boundaries of Smyth County, Virginia; (2) The improvements located on the Property were constructed in approximately 1981 (please note that the original letter erroneously stated 1982); (3) The Property contains 72 residential units; (4) The Property will be rehabilitated at a cost of approximately \$55,000 per unit; and (5) It is anticipated that the rehabilitation of the Property will result in an increase of the assessed value of the Property.

The building permits for the property were issued on November 17, 2015 and November 19, 2015. The application for tax exemption was submitted on January 26, 2016. It is our understanding that the Commissioner has denied our application because the application was filed later than thirty (30) days after the building permits were issued. We also understand that our application was acceptable in all other respects. The late submission of the application was the result of an oversight on our part. We would respectfully request that you place this appeal on the February 9, 2016 agenda of the Board of Supervisors for their consideration. Although we made an error by submitting our application more than thirty (30) days after our building permits were issued, we believe that the Property meets all other criteria for a partial tax exemption and is a project that will benefit Smyth County.

We are also now aware that application should have been made by a form provided by the Commissioner of the Revenue Office. A completed form is enclosed herewith along with proof that taxes for the 2015 tax year have been paid. Our \$250 fee has already been submitted to the Commissioner.

We very much appreciate your consideration of granting a reversal of the Commissioner's denial of a residential rehabilitation partial exemption to the Property. Please do not hesitate to contact me should you have any questions or need anything further.

Hybrid plan employees must follow the requirements of the plan, and meet the qualifying periods for disability benefits. Benefits are based on a percentage of the employee's pre-disability earnings and amount of months of continuous service in the hybrid retirement plan. Additional information is available from the Human Resource Director.
