7/11/2017 5:52 PM Project Updates-Scott Simpson, Assistant County Administrator presented an update to the Board of Supervisors concerning two (2) Sewer projects.

Mr. Simpson stated two (2) small projects in Atkins and Browns Subdivision to provide public sewer to seven (7) new customers who have failing septic systems was completed in late June. The cost of the project was \$80,792.00, with Evergreen Soil and Water providing \$10,000.00 for the project and Mt. Rogers Planning District Commission providing \$40,396.00. Smyth County contributed \$30,396 and all funds were reimbursed in FY16-17, therefore the project will not carry over into the new fiscal year.

Mr. Simpson then updated the Board of Supervisors concerning the Adwolfe Sewer Project, which consists of two (2) contracts. One for the pump stations being completed by King General Contractors and one for the gravity sewer collection system being completed by Mendon Pipeline. In the last three (3) months, King General Contractors has installed one wet well, 8,639 feet of force main piping and is approximately 29% complete. Over the next month the second wet well is expected to be installed, along with site work and control items. Mendon Pipeline is actively working on the gravity sewer collection portion of the project and is approximately 37% complete. Contractors have installed 9,140 feet of sewer piping, out of the 24,459 feet expected to be installed and are currently working in the Fairfield and Rolling Hills Subdivisions.

Smyth County's projects were ranked 3, 4, 5, and 6 in the Bristol District. The projects awarded were: US 11 at Railroad Drive Intersection Improvements (\$2,783,000), US 11 at SR 107 Intersection Improvements (No Radius) (\$2,347,000), US 11 at SR 107 Intersection Improvements (with Radius) (\$3,042,000), and I-81 Exit 35 (State Route 107) Interchange Modifications (\$2,516,000). The US 11 at SR 107 Intersection Improvements projects are 2 versions of the same project and the final scope of work will depend on the preliminary engineering. Smyth County was one of the most successful localities in the Commonwealth in this past year's program.

The next round of SMART SCALE funding opens in March, 2018 and has a firm deadline of August 1, 2018, there will be approximately \$ 19 million of available funding. There is a workshop on August 14-15 to begin project development with the VDOT consultants. Staff will review highway safety data and

overlay economic information and sites to determine projects which have a higher scoring potential due to these weighted factors.

WHEREAS, in consideration of the renewal by Stokes of the lease to Smyth for this monitoring well on the land of Stokes for a period of five (5) years to conform the dates of the Stokes lease and the Smyth lease to the same timetable, with an option in Smyth to renew the same for an additional five (5) years for a total of ten (10) additional years; and,

WHEREAS, if after the five (5) year extension, Smyth renews this lease for another five (5) years, Smyth agrees to continue the lease of Stokes to a portion of the old landfill property land and to negotiate with Stokes for an additional term of five (5) years on successive one (1) year terms; and,

WHEREAS, Smyth had reserved a part of the property located in the old landfill in the extension of August 31, 2006, and the reason for this exclusion from the extended lease has ended, and the parties now desire for the Stokes to be permitted to lease the same land covered in the original lease of August 8, 1995 from Smyth to Stokes, based upon the undertakings herein.

NOW, THEREFORE, in consideration of the covenants herein, and in consideration of the right of Stokes to extend the original lease dated August 8, 1995, and the three extensions dated August 31, 2000, August 31, 2006, and August 31, 2012 as modified herein for the additional land, and the extension of the lease of Smyth of the property of Stokes dated August 31, 2017, the parties do hereby agree as follows:

- 1. Stokes shall be permitted to use the pasture, and to remove hay from a portion of the land of Smyth that is part of the old Smyth County landfill. Stokes shall have the right to use the area north of the road leading to the scales from Route 107, the area west of Route 107 and north of the entrance road to the landfill, the land east of the area of landfill closure, and near and north of the Plum Creek Road for a period of five (5) years terminating August 31, 2022, and subject to the possible extension described hereunder. Smyth reseeded a part of the leased area, and repaired the ground in this part of the area during the extension of August 31, 2000, and later surrendered the entire area to the Stokes for his use, and all of the original leased area is included in the present extension.
- 2. Stokes shall be responsible for all the fences needed to separate his use of the land from the old landfill and areas of buried trash. Stokes will provide all labor, including any necessary machinery and equipment, to maintain these fences, which will be sufficient to turn cattle or other livestock from the areas of buried trash and closure in the old landfill.
- 3. The extended term of this extension shall be for five (5) additional years for Stokes. Within ninety (90) days of the end of lease, Stokes shall give Smyth written notice of his intention to renew this lease for an additional five years until the final year in 2022.
- 4. Smyth shall have continuing access to the monitoring well on Stokes for an additional period of five (5) original years from August 31, 2017 to August 31, 2022 to match the term of the Stokes lease. Smyth shall have the option to extend this lease term by an additional five (5) years beginning on July 1, 2022. Smyth shall give Stokes written notice of its intention to renew this lease for an additional five (5) years at least ninety (90) days prior to the end of the present five (5) year extension. As a part of the lease, Smyth shall be permitted to use the roadway across Stokes off of Plum Creek Road for access to this leased property. If circumstances change, Smyth may cancel this lease on written notice to Stokes, and will cancel the lease of the monitoring well is no longer needed or required to be maintained on the land of Stokes.
- 5. Smyth reserves the use of all monitoring wells in the area leased by Stokes, and all rights of ingress and egress to these other monitoring wells or across any part of the land leased to Stokes, including the right to move any existing monitoring well to another location on the leased premises. Smyth further reserves the right, on sixty (60) days written notice to cancel the lease to Stokes if the land under the lease, or any part thereof, is required for any purpose of Smyth.
- 6. In the event Smyth is required to use a part of the premises leased to Stokes, Stokes will move the fences to accommodate this use by Smyth. Stokes shall keep the land cleared and use his best efforts to remove and eradicate briers, thorn or other noxious

plants, including mowing, bush hogging, spraying, and grazing of livestock on the leased premises. Except as modified herein, theoriginal leases and former extensions described above shall continue in full force and effect.

The meeting was called to order at 4:10 P.M.

Michael Carter, County Administrator presented a request from the Tourism Association to set the annual salary for the Director of the Association at \$40,000.00 for fiscal year 2017-2018. The salary for the Tourism Director is currently budgeted within the County's budget at an annual amount of \$33,000. Mr. Carter then explained the process in which the County serves as the fiscal agent for the Tourism Association and also handles the payroll process for the employee. The Committee informed the Tourism Association there would be no decrease in the contribution for FY17-18 from the County, allowing for the Association to re-work their budget to accommodate the salary increase. The Committee took no action on amending the budget to allow for the salary increase at this time.

Michael Carter, County Administrator presented a request from the Clerk of Circuit Court's Office to restore funding for part-time wages in the FY2017-2018 budget. Rye Valley District Supervisor Rick K. Blevins made a motion to deny the request submitted by the Clerk's Office. Park District Supervisor M. Todd Dishner seconded the motion and all agreed unanimously.

Mr. Carter then informed the Committee that notification had been received from the State Board of Elections on July 24th, 2017 regarding a 2% salary increase, effective August 1st, 2017, for the Voter Registrar position, along with the Chairman, Vice Chairman, and Secretary for their positions on the Electoral Board. After discussion, Park District Supervisor M. Todd Dishner made a motion to approve the 2% increase to the base salary, which excludes the mandated VRS contribution that went into effect in 2012, for the Voter Registrar position, and the \$42.00 increase for the Chairman and Vice Chairman, and \$84.00 for the Secretary of the Board of Elections. Rye Valley District Supervisor Rick K. Blevins seconded the motion and all agreed unanimously.

The meeting was called to order at 5:00 p.m. by Chairman Roscoe D. Call.

Nykki Wyatt spoke concerning the accuracy of the water meter located on her property at 522 Valley Road, Saltville Virginia. Her concern is that it read high one time in early 2016 and she has not received a satisfactory resolution. Ms. Wyatt stated her bill is usually under the minimum and that in November it read 9,000 gallons and the next month it was back down to below the minimum. Ms. Wyatt has researched meter companies and has concluded there is an error factor that is possible. After discussion, North Fork District Supervisor Phil Stevenson made a motion to recommend denying any refund or adjustment since the reading is well above any error range indicated by the manufacturer. Rye Valley District Supervisor Rick K. Blevins seconded the motion and all agreed unanimously.

Ms. Wyatt also brought to the attention of the committee that her water heater and area it is installed were damaged by air being trapped in and traveling through the water main and entering her house piping. Ms. Wyatt stated owns property on the end of the line at 124 Woodbury and unfortunately receives most of the air that could be in the main. Although understanding the Committee stated the County cannot be responsible for air, as efforts are made to bleed it off when the County is notified of the situation. In this case, the Town of Saltville repaired one of their lines and the air from that repair likely was not bled off adequately by them and it entered the County's portion of the system.

Alvin Jones, 310 Dry Run, Marion, Virginia spoke concerning a water theft issue he had with a rental property located at 142 Beulah Lane, Marion, Virginia. Mr. Jones received a letter from Smyth County informing him of the charges related to correcting the problem, he does not feel as if he is responsible for the charges and would like for the County to waive them. Discussion continued on this item. After discussion, North Fork District Supervisor Phil Stevenson made a motion to deny the request. Rye Valley District Supervisor Rick K. Blevins seconded the motion and all agreed unanimously.

The committee addressed the concept of allowing Fire Departments to draw water from fire hydrants and using it for activities which are not fire suppression related. Rye Valley District Supervisor Rick K. Blevins made a motion to allow staff to write a letter to all of the fire departments notifying each of them to stop drawing non-fire suppression related water from the hydrants except in specific instances and if the practice continued it could affect their funding from the County. North Fork District Supervisor Phil Stevenson seconded the motion and all agreed unanimously.

Scott Simpson, Assistant County Administrator brought 3 water main extension requests to the committee for consideration, Grubmore Road, Little Walker Way, and Daywood Lane, which total 18 to 20 homes who have all requested public water service. Mr. Simpson asked for approval to sample the 20 individual wells for water quality, stating the tests are less than \$20 each and there is a grant which he believes will pay for the testing. The test results, if positive for Total Coliform, will allow for eligibility in a grant program to extend public water to residences with failing wells. The grants are for up to \$12,500 per well and other funding would likely be needed; however, without the tests there is no funding from the VDH program. North Fork District Supervisor Phil Stevenson made a motion to recommend allowing the testing to determine grant eligibility. Rye Valley District Supervisor Rick K. Blevins seconded the motion and all agreed unanimously.

Mr. Simpson the presented an update on the Adwolfe Sewer project. The Gravity Sewer portion (Contract 2) is progressing well, about 35% complete, and is ahead of schedule. There are no anticipated change orders at this time on that contract. Mr. Simpson presented a few lines which are additive alternates to the project. There is currently about \$250,000 of funding allocated as contingency. The committee at this time is still unsure of the amount of any change orders for the project and is not ready to commit these available funds at this stage of the project with one exception; the Grubmore Road line adjustment which takes the sewer main out of the road and places it in the adjacent field now that the easement is secured. North Fork District Supervisor Phil Stevenson made a motion to accept the Grubmore road line adjustment which is an approximate credit of \$ 30,000. Rye Valley District Supervisor Rick K. Blevins seconded the motion and all agreed unanimously.

The Pump Station portion of the project (Contract 1) is progressing slowly and there are a few items which will likely be change orders and additional cost to the project. The existing pump station top slab replacement, provision of new guiderails for the pumps, and the correction of a design error for the depth of the new Exit 39 wet well. There was much discussion related to the ability to determine the time and material costs for the excavation and the efficiency with which the contractor is performing. Additional discussion centered around the dewatering process and the discharge of the pumps onto private property. Staff was directed to check with the property owners and contractor to assess the potential concerns of the situation.

With nothing further to discuss, the meeting was adjourned at 6:32 P.M.
