work. The pump station portion of the contract is almost complete with the site work and fencing which is anticipated to be completed by the end of the month. Mr. Simpson stated that AEP has the Highway 11 electrical service scheduled for installation the last week of January. The Exit 39 pump station electrical service is still in easement acquisition, as there is one landowner who has not returned their easement despite repeated attempts to contact them. AEP and the County staff are following up on this on a consistent basis.

The gravity sewer portion of the project is lacking about 350 feet of pipe installation in order to be complete. Michael Carter, County Administrator presented an update to the Committee concerning the Building and Zoning Department's job duties and related items. Mr. Carter informed the Committee that an internal decision was made to no longer participate in the Assign-A-Highway program earlier in the month of January. A letter was written to that effect and provided to Mr. Mark Moss with the Virginia Department of Corrections, the Honorable Judge Simmons with the Smyth County Circuit Court, Clegg Williams, Zoning Administrator and Michael Carter, County Administrator. Recently, it was brought to staff's attention this program was implemented by the Board of Supervisors in 2007, along with a monetary incentive given to those employees that were concluded to become a part of the program. As a result, of this notification, the internal discontinuation of the program was questioned and led to the questioning of the ability to internally end this program without Board approval. To provide clarification, a Personnel Committee was set up for February 5th, 2018 to allow the Committee to discuss the issue at hand and provide a formal recommendation to the Board of Supervisors regarding the continuation or discontinuation of the program.

After discussion, North Fork District Supervisor Phil Stevenson made a motion to recommend to discontinue the Assign-A-Highway Program and additionally remove the monetary incentive given to those employees identified within the program in accordance with the Board of Supervisor minutes dated June 28, 2007. Saltville District Supervisor Roscoe D. Call seconded the motion and all agreed unanimously.

With nothing further to discuss, the meeting was adjourned at 5:38 P.M.

Chairman, Chilhowie District Supervisor R. Curtis Rhea called the meeting to order at 4:03 pm.

Michael Carter, County Administrator informed the committee the Leases for Solid Waste Haul and Disposal Services were in their 5th year, and set to expire in October of 2018. The County currently has a contract with W&L for hauling of trash and the City of Bristol for disposal of trash. The current agreement identifies that either party can notify the intent to discontinue services within 120 days of the lease expiration. Mr. Carter informed the Committee of the cost currently paid for the services and the costs associated with prior years. Discussion continued on this item. North Fork District Supervisor Phil Stevenson made a motion to recommend not continuing with the current contract for Haul and Disposal services, and to place them out for new bids. Atkins District Supervisor Charles Atkins seconded the motion and all agreed unanimously.

Wally Blevins, Solid Waste Foreman updated the Committee concerning the repairs to the Transfer Station due to a fire last fall. Mr. Blevins stated the repairs were coming along nicely, and contractors were working diligently to complete.

With nothing else to discuss, Chairman, Chilhowie District Supervisor R. Curtis Rhea adjourned the meeting at 4:28 p.m.

A meeting of the Smyth County Water and Sewer Committee was held at the County Office Building on Monday, February 5, 2018 at 4:30 p.m.

At 4:26 p.m. Chairman, Saltville District Supervisor Roscoe D. Call called the meeting to order.

Mr. Scott Simpson, Assistant County Administrator informed the committee of a visitor to the County offices a couple of weeks ago. Mr. Rusty Cox who owns the Highway 107 tank access road came by and was insistent the County needs to do more to maintain the roadway, trim trees, mow grass, and overall maintenance on the road in question. Mr. Cox also indicated that he was going to ask the County to participate in the paving of the roadway at the next Board of Supervisors meeting. The committee reviewed the agreement for the tank access and determined the County is performing the necessary improvements to the roadway as identified by the agreement. The committee took no action on the matter.

Mr. Simpson then presented information on 22 homes located along Spring Valley Road and asked to perform well testing for a Grant Application on those residences. The testing itself could be covered within the adopted budget for FY2017-2018 and is anticipated to be less than \$500. Northfork District Supervisor Phil Stevenson motioned to recommend the wells be tested. Chilhowie District Supervisor R. Curtis Rhea seconded the motion and all agreed unanimously.

The Committee then discussed the possibility of developing an interconnect with Wythe County to possibly supply residents of the Atkins portion of Smyth County with another source of potable water. Both Mr. Simpson and Michael Carter, County Administrator indicated they had discussion with representatives from Wythe County regarding this possibility. Mr. Carter identified that Wythe County will be having a Water Committee meeting later this month and discussion on this issue will be had internally with Wythe County officials. He also suggested that a meeting of the two localities committees would be considered moving forward to ensure proper communication between both parties occur and recommended developing a plan of action to engage in to assist in determining the feasibility of the project. The Committee provided instruction to continue with the discussions and would remain flexible moving forward to allow for the joint meeting to occur to discuss the issue in more detail.

Northfork District Supervisor Phil Stevenson then inquired about a spring located on the Spring Valley Road section of the County which reportedly flows at over 200 gpm. After discussion, Northfork District Supervisor Phil Stevenson made a motion to allow staff to pursue discussions with the landowner regarding additional information about the proposed site, determining the feasibility of the site and to begin discussions regarding a possible option agreement on the site in order to perform the appropriate

testing of the spring source. Chilhowie District R. Curtis Rhea seconded the motion and all agreed unanimously.

Mr. Simpson then informed the committee it was time for the annual renewal of the Term Services Agreements for engineering firms to provide services to the County for smaller projects along the way. The current listing includes Draper Aden, ECS Limited, Hurt and Profit, The Lane Group and CHA Engineering. After discussion, Northfork District Supervisor Phil Stevenson made a motion to renew the agreements with Draper Aden, ECS Limited, Hurt and Profit and The Lane Group and to not renew the agreement for CHA Engineering. Chilhowie District Supervisor seconded the motion and all agreed unanimously.

A brief update was given on the Adwolfe sewer project. The project is completed except for the startups which are being scheduled for the coming weeks. In addition, there are no lingering issues we are aware of at this time.

At this time, Mr. Simpson presented a spreadsheet of the Audited Financial reports for the Water Sewer Department, the information indicates the department is continuing to move in a positive direction and is making strides to become self-supporting in the years ahead.

Mr. Carter then presented information of the Mandatory Connection Ordinance for both water and sewer customers. A request was made to local legislators to include Smyth County in House Bill 22 to allow for the proper language included in the Code of Virginia to allow for such mandatory connections. As of February 2, 2018, the Bill had made it through the House and was being moved over to the Senate for consideration as well. At this point it has been assigned to the Senate Committee on Local Government. Mr. Carter will continue to monitor the status of the Bill and report the progress in the days ahead. Staff will continue to gather information regarding the impact this opportunity will present to Smyth County and report back to the Committee accordingly.

Lastly, the Committee discussed options to ease the process for citizens paying a Water/Sewer bill. After discussion, Chilhowie District Supervisor R. Curtis Rhea made a motion to allow staff to prepare a request for proposals for services that would allow citizens the ability to use debit/credit cards or ACH (Automated Clearing House) debits for payment of Water/Sewer bills. North Fork District Supervisor Phil Stevenson seconded the motion and all agreed unanimously.

With nothing else to discuss, Chairman, Saltville District Supervisor Roscoe D. Call adjourned the meeting at 5:11 P.M.
