Resolution to Support an Increase in State Funding for Small and Rural School Divisions

WHEREAS, Virginia's unemployment rate is the lowest it has been in recent history, at 2.8%; and Smyth County's unemployment rate is 3.4%; and

WHEREAS, Virginia has been recognized as the top state in America to do business; and

WHEREAS, Virginia has been designated as the 10th wealthiest state in America; and

WHEREAS, Virginia finished with a significant budget surplus last year of \$230 million; and

WHEREAS, over half of Virginia's schools and 12 of 14 Smyth County Schools were built over 50 years ago; and

WHEREAS, when inflation is accounted for, state per-pupil funding is down 8% from pre-Great Recession levels, despite a significant improvement in Virginia's economy; and

WHEREAS, Virginia ranks 32nd in per pupil funding nationally; and

WHEREAS, per pupil spending varies widely across Virginia, from \$11,919 in Smyth County to \$20,000 in some suburban districts and the statewide average in per pupil spending trails the national average by about \$1,800 per student; and

WHEREAS, Virginia's teachers are paid more than \$9,000 less than the national average which ranks us 35th; and

WHEREAS, since the Great Recession, localities have increased their share of funding public education by 2.9 percentage points, while the state has decreased their share by 3.3 percentage points; and

WHEREAS, in Virginia's rural schools, where localities have seen the least post-Recession growth, those numbers are even worse. Rural localities have increased their share of education funding by 3.9 percentage points and the state has decreased their funding to rural schools by 4.4 percentage points; and

WHEREAS, the national average for the additional funding for high poverty students has been estimated between 20% and 29% and Virginia caps this funding stream at 16%; and

WHEREAS, the research is clear that teaching students whose families live in poverty is more expensive than providing education to students of affluent families; and

WHEREAS, when all funding sources are considered, Virginia spends less, on average, on per pupil education in high poverty districts than the rest of the country; and

WHEREAS, Small and Rural Stakeholders believe that PK-12 public education is critical to the vitality of their region and to the Commonwealth as a whole; and

WHEREAS, Rural School Divisions have seen a decline in K-12 enrollment of almost 24,000 students since 2009 which represents an 8% decline and Smyth County has experienced a 787 student decline during the same time period; and

WHEREAS, 16% of students in the Rural School Divisions live below the Federal Poverty Level; and

WHEREAS, 48% of students in Rural School Divisions and 76.90% of Smyth County students are eligible for Free or Reduced Priced Lunch; and

WHEREAS, these Rural Localities have the ability to raise only \$19,941,000 and Smyth County to raise only \$140,100 by increasing property taxes by one penny (.01); and

WHEREAS, over 80 school divisions across the Commonwealth could be defined as Rural and/or Small; and

WHEREAS, local poverty and tax revenues prevent Rural Localities from funding schools at the same level as affluent Localities.

NOW, THEREFORE, BE IT RESOLVED that the Smyth County Board of Supervisors asks the Commonwealth of Virginia to adopt a budget that increases teacher pay to ensure we are able to keep and hire the best talent, increases the At-Risk Add On either through the VDOE's proposed Equity Fund or in its current form, provides state funding for school construction and renovation, and reinstates the Enrollment Loss

funding stream.





Smyth County Enterprise Zone: CHILHOWIE, MARION, AND ATKINS Local EZ Incentives

REVISED JANUARY 1, 2013

Local Financial Assistance

• Economic Stimulus Grant - Applicable to Manufacturers Only

A three-year local grant provided to companies that make new machinery and equipment investments and create new jobs. The grant would be provided through the Smyth County Industrial Development Authority and would be equivalent to the following percentage of the machinery and tools tax due and paid on new equipment and machinery of a minimum investment of \$500,000 in one year.

No. of new jobs created	Year One	Year Two	Year Three
100 or more	100%	50%	25%
50-99 new jobs	80%	40%	20%
5-49 new jobs	60%	30%	15%

A cap amount of \$50,000 per year currently applies to this incentive.

• Building Permit Fee Rebate

New industrial and commercial buildings of at least \$500,000 in value and any renovations or expansion of existing industrial and commercial structures of at least \$100,000 in value are eligible for a rebate of fifty (50) percent of the building permit fee paid. The current county charge for building permits is \$0.16 per square foot for new commercial and industrial buildings and for any renovations or expansion. The rebate is capped at \$10,000 for any one permit issued.

• Water and Sewer Cost Reductions

The increased cost of water and sewer service for town and county customers will be rebated fifty percent (50%) for one year based on the creation of at least 5 or more full-time, permanent jobs. (The increase will be measured from the average of one 12-month period compared to the next consecutive 12-month period).

In addition, any initial water and sewer hook-up fees (town or County) are rebated at 100% for any business or industry locating in the zone creating at least 5 or more full-time, permanent jobs within the first year.

Tax Incentives

Real Estate Rehabilitation Tax Exemption

A nine-year decreasing exemption on the increase in assessed property value resulting from substantial rehabilitation of certain commercial or industrial real estate (15 years old or older), starting with 100% credit in the first five years, and decreasing 20% each year to a bottom of 20% in the ninth year. The property value must increase by sixty (60) percent or more to be eligible for this incentive.

• BPOL Tax Credit. (Only applies within the Towns of Chilhowie and Marion).

A decreasing tax credit over a 5-year period following the creation of new full-time, permanent jobs based on the following:
