10/8/2019 5:24 PM Kendra Hayden, CSA Coordinator, reviewed FY18-19 total expenditures, total children served and reviewed the most utilized categories in which funds were spent for the CSA program in Smyth County. Mrs. Hayden explained that treatment Foster Care is the highest spending category at 37% usage, residential education just below that at 31% usage, and the most highly used category of Community Based services at 16%. Mrs. Hayden continued, stating Community Based Services incorporates an array of services such as foster care prevention services, assessments and evaluations, counseling, parent education, and foster care maintenance. Mrs. Hayden explained the epidemic of substance abuse issues; incarcerations and childhood trauma are leading causes of the 51% of out of home placements within Smyth County's children served through the CSA program. Finally, Mrs. Hayden encouraged members of the Board and Community alike to be kind to individuals who have had past issues with substances or who are continuing to work to get their children back in their homes; this will allow them to feel supported and a part of something better for themselves and their families.

Karen Johnson, Foster Care Supervisor and Helen Holman, CPS Supervisor also presented information to the Board of Supervisors regarding the programs offered to those children within the communities of Smyth County that have been removed from home for various reasons and the resources available to them such as counseling, foster care, schooling etc. There is a growing need for more Foster families in Smyth County for children of all ages and Ms. Holman and Ms. Johnson both encouraged the citizens to contact the Department of Social Services for more information.

We have reviewed the county's request for CDBG Planning Grant assistance for the proposed Smyth County Telecommunication Planning Grant Project. Due to the county's prior involvement in state funded regional telecommunication planning efforts in 2008 with the Towns of Chilhowie and Saltville, as well the most recently ARC POWER Funded Regional Telecommunication Planning Effort with Planning Districts 1(Cumberland Plateau), 2 (LENOWISCO PDC) and 3 (Mount Rogers PDC). We are prepared to offer Planning Grant Assistance in the amount of \$15,000 and have reserved \$2,000 in Planning Grant Funding to reimburse the county for completion of the following activities:

1. Completion of an initial public meeting

The county must schedule a public meeting to give citizens and stakeholders an overview of the proposed project. Citizens must be informed about the county's intentions to identify the need for high-speed telecommunications, and to survey residents, businesses, and other potential beneficiaries to confirm need and demand. Citizens must also be informed of potential future activities under the study, including additional public and management team meetings, feasibility studies, and need and demand surveys for the county. The county must disclose that future Planning Grant and Community Improvement Grant Funding depends on completion of these initial activities. At this meeting, energized community leaders called "sparkplugs" must be identified and included as members of the management team.

2. Completion of an initial management team meeting

The county must identify key stakeholders and secure their commitment in serving on a project management team. The management team must include, at a minimum, the County Manager or designee, a member of the Mount Rogers Planning District Commission, a representative from the Retail Merchant's Association, a representative from the local community college and universities within the region, representatives from community businesses, a representative from the local school system, a representative from a local health care provider, local telephone and

Internet service providers, and at least two community representatives. At this initial meeting, management team members must help the County develop a plan for completing these initial Planning Grant Activities.

3. Engagement of the Center for Innovative Technology

The county should consult the Center for Innovative Technology to assist with the completion of the community needs assessment survey. Documentation of the consultation should be including with the response to completion of all Initial Activities.

The county must conduct a community-wide survey to assess existing broadband telecommunication assets and services and identify needs. Efforts must be made to target and receive responses from a good representation of residents, businesses and industries in the county. The survey also should include income information for residents, a sample question has been attached. The income data to populate the survey can be found at https://www.huduser.gov/portal/datasets/il/il2019/select Geography.odn .

4. Completion of a second management team meeting

The county must schedule a meeting of the management team wherein members can review the results of the survey. Potential project activities and plan of action should be discussed at this meeting.

Upon completion of these five initial items, the county must submit a copy of the survey results, draft RFP, the meeting minutes and attendance sheets to the Virginia Department of Housing and Community Development (DHCD). The responses must be submitted online using the agency's Centralized Application and Management System (CAMS). If you have questions about how to access or use CAMS, please contact us.

If the local government completes the activities outlined above (# 1-4) by January 7, 2020, the county will have access to the \$2,000 reserved. The actual funding amount, not to exceed a total of \$15,000, will be dependent upon costs to complete the identified and agreed upon activities. If the county fails to complete the identified activities, the balance of the Planning Grant Funding may not be awarded.

The Department of Motor Vehicles sells the Animal Friendly license plate, which is authorized by Virginia Code, §46.2-749.2:7, as part of its special license plate program. This plate is issued to supporters of dog and cat sterilization programs at a cost of \$25.00 per year in addition to the prescribed fee for vehicle registration. After the first 1,000 sets of plates are sold, \$15.00 of each fee is made available to the locality in which the vehicle is registered, to be used to support sterilization programs for dogs and cats. This money is set aside in a special fund titled the Dog and Cat Sterilization Fund for distribution to localities, regardless of the amount of funds involved. For Fiscal Year 2019, DMV's records indicate that your locality is due \$465.00 from this Fund.

Virginia Code §46.2-749.2:7 requires each locality to certify that this money will be used to support sterilization of dogs and cats. If your locality does not have a program for this purpose, the statute provides the locality options. You may make the funds available to any private, nonprofit sterilization program for dogs and cats in your locality or decline receipt of funds. Any funds that are declined shall be distributed to other affected localities on a pro rata basis.

Attached to this letter is a form to make your choice pertaining to the amount stated above. Complete the form and return it no later than December 20, 2019, to:
